1 TAX CYCLE AND BILL NUMBER:
This is the current bill cycle and unique bill number. Refer to this number when you have a question about this specific bill.

2 PROPERTY TAX ID NUMBER:
This is a distinct number assigned to each property. Use this number for general inquiries and online property searches or updates.

3 PROPERTY LOCATION / DESCRIPTION:
Verify the property location. Notify the Assessment Division at (302) 855-7824 as soon as possible with any errors.

4 PROPERTY OWNER(S) / MAILING ADDRESS:
Verify the ownership and mailing address. If you have sold the property, forward tax bill to the new owner(s) or return with the new owner's name(s) and date sold, call or contact us online to update.

5 CREDITS APPLIED:
This shows credits such as the State 65 credit that are deducted from your tax bill.

6 CODE AND SUMMARY OF CHARGES (C,S,N):
Codes are used to summarize and define the types of charges and services being billed on your current tax bill.

7 TOTAL DUE:
This is the total due as of the date this bill was printed. The due date shown is for the current tax period only; any past due amounts will be assessed monthly finance charges until paid.

Assessment / 100 x Rate - Credit = Current Charge
