In 2011 the Sussex County Engineering Department had requested permission from County Council to hold a public hearing on the annexation of your area into the sewer district. Permission was granted and we proceeded to the public hearing, minimal attendance at the hearing led council to believe there was not sufficient interest and they deferred action. The department has recently been approached by a few residents inquiring about central sewer service again. Since several properties have changed ownership since the last attempt we have developed this polling letter to judge the current interest prior to approaching County Council. Our records indicate you as a property owner in the area, and we would like to hear from you. Your wish to be included in the proposed boundary does not guarantee sewer service. If there is sufficient interest, there will be a public hearing prior to the County Council vote on including the area into the Sussex County Unified Sanitary Sewer District boundary.
