OLD BUSINESS

- 1. C/U #1715 -- application of **GOOD EARTH MARKET, LLC** to consider the Conditional Use of land in an AR-1 Agricultural Residential District for an office, professional space, café restaurant, and meeting space to be located on a certain parcel of land lying and being in Baltimore Hundred, Sussex County, containing 9.2509 acres, more or less, lying south of Route 26, approximately 1,500 feet west of Route 17.
- 2. C/U #1719 -- application of **DANIEL D. RUPPERT, JR.** to consider the Conditional Use of land in an AR-1 Agricultural Residential District for professional office space to be located on a certain parcel of land lying and being in Indian River Hundred, Sussex County, containing 0.62 acres, more or less, lying southwest of Route 24, 315 feet south of Road 289.
- 3. Subdivision #2006-54 -- application of **COOL SPRING REALTY ASSOCIATES, LLC** to consider the Subdivision of land in an AR-1 Agricultural Residential District and a GR General Residential District in Lewes and Rehoboth Hundred, Sussex County, by dividing 26.13 acres into 18 lots, and a variance from the maximum allowed cul-de-sac length of 1,000 feet, located west of Road 290, 800 feet north of Road 262.
