OLD BUSINESS

- 1. Subdivision #2005-94 -- application of **SEACOAST INVESTMENTS, L.L.C.** to consider the Subdivision of land in an AR-1 Agricultural Residential District in Dagsboro Hundred, Sussex County, by dividing 81.84 acres into 163 lots, (Cluster Development), located east of U.S. Route 113, south of Road 325, and west of Road 326.
- 2. Subdivision #2008-10 -- application of **JACK STANTON** to consider the Subdivision of land in an AR-1 Agricultural Residential District in Nanticoke Hundred, Sussex County, by dividing 72.46 acres into 43 lots, located north of Road 473 (Joseph's Road) approximately 650 feet east of Route 20.
