OLD BUSINESS

1. C/U #1827 -- application of **DRY DOCK, INC.** to consider the Conditional Use of land in an AR-1 Agricultural Residential District for a non-profit facility (meeting place) to be located on a certain parcel of land lying and being in Indian River Hundred, Sussex County, containing 2.436 acres, more or less, lying southwest of Road 277 (Angola Road), 450 feet southeast of Route 24.

- 1. C/U #1829 -- application of **M. L. JOSEPH SAND & GRAVEL, INC.** to consider the Conditional Use of land in an AR-1 Agricultural Residential District to expand excavation of borrow pit to be located on a certain parcel of land lying and being in Dagsboro Hundred, Sussex County, containing 40.85 acres, more or less, lying north of Road 322 (Bunting Road) approximately 2,400 feet west of Governor Stockley Road (Road 432).
