- 1. Subdivision #2008-16 -- application of **ALPACO V, L.L.C.** to consider the Subdivision of land in a GR General Residential District in Indian River Hundred, Sussex County, by dividing 57.00 acres into 135 lots, located 1,050 feet west of intersection of Route 24 and Road 299.
- 2. Subdivision #2008-25 -- application of **UNDERHILL PROPERTIES, LLC** to consider the Subdivision of land in an AR-1 Agricultural Residential District in Indian River Hundred, Sussex County, by dividing 8.78 acres into 14 lots, (Environmentally Sensitive Development District Overlay Zone) expansion to 138 lot Environmentally Sensitive Development District Overlay Zone (#2005-52), located 500 feet east of Road 279 and 700 feet north of Road 279A.
