OLD BUSINESS

- 1. Subdivision #2006-56 -- application of **ZONA SAEZ** to consider the Subdivision of land in an AR-1 Agricultural Residential District in Indian River Hundred, Sussex County, by dividing 1.98 acres into 2 lots, and a waiver from the street design requirements, located south of Road 287, 1,250 feet east of Road 288.
- 2. Subdivision #2007-4 -- application of **LACROSSE HOMES OF DELAWARE** to consider the Subdivision of land in an AR-1 Agricultural Residential District in Cedar Creek Hundred, Sussex County, by dividing 90.11 acres into 82 lots, located at the southwest corner of the intersection of Road 620 and Road 617.
- 3. HOWELL, JR.** to consider the Subdivision of land in an AR-1 Agricultural Residential District in Northwest Fork Hundred, Sussex County, by dividing 4.913 acres into 2 lots, and a waiver from the street design requirements, located northwest of Road 575A, 1,550 feet southwest of Road 573.
