C/U #1555 -- application of **PAUL ROBINO AND ROBINO-SANIBEL VILLAGE, L.L.C.** to consider the Conditional Use of land in an AR-1 Agricultural Residential District for multi-family dwelling structures (122 units) to be located on a certain parcel of land lying and being in Baltimore Hundred, Sussex County, containing 15.29 acres, more or less, lying southeast of Route 54 (Lighthouse Road) and 100 feet northeast of Route 394.
- 2. C/U #1557 -- application of **CLINTON PROPERTIES, LLC** to consider the Conditional Use of land in a GR General Residential District for multi-family dwelling structures (95 units) to be located on a certain parcel of land lying and being in Baltimore Hundred, Sussex County, containing 22.24 acres, more or less, lying on the south side of Sandy Cove Road (Road 358), east of White Creek and 0.7 mile west of Cedar Neck Road (Road 357).

- 5. Subdivision #2003-56 -- application of **DOUGLAS D. AND JUDITH K. BREEDING** to consider the Subdivision of land in an AR-1 Agricultural Residential District and a GR General Residential District in Cedar Creek Hundred, Sussex County, by dividing 5.70 acres into 6 lots, located at the northeast, northwest and southwest corner of the intersection of Roads 224 and 213.
