The submission shall be confidential until the bid has been awarded and a contract has been executed. Thereafter, all submissions shall be open to public inspection.

Federal and State scale wage rates are <u>NOT</u> applicable on this Project.

Liquid Asphalt Cement Cost Adjustment and Diesel Fuel Index are <u>NOT</u> applicable to this Project.
