Certificate of Achievement for Excellence in Financial Reporting

Mr. Stickels announced that Sussex County, for a third consecutive year, has won the Certificate of Achievement for Excellence in Financial Reporting for its Comprehensive Annual Financial Report for Fiscal Year 2004. The award is among the highest forms of recognition for governmental accounting and financial reporting. The Government Finance Officers Association of the United States awarded the Certificate of Achievement to the County in 2005. Mr. Stickels noted that only approximately two percent of counties receive this prestigious award. The following County employees were recognized for their efforts in compiling the report: Susan Webb, Jeff James, Mary Matthews, Chris Parker, Eddie Sparpaglione, Bill Townsend, Patti Faucett, David Baker, and Robert Stickels.

trator's Report Mr. Stickels read the following information in his Administrator's Report:

#### 1. Beneficial Acceptance

The Engineering Department gave Beneficial Acceptance on January 11, 2006, to Bayview Landing – Phase III, Agreement No. 367. This project is located on the north side of Route 54, east of Swann Keys, in the Fenwick Island Sanitary Sewer District, consisting of 54 single-family lots. Included with this report is a fact sheet on the project.

Wellhead Protection and Groundwater Resources Contract

Mr. Lank, Director of Planning and Zoning, advised the Council that in November 2005, the County was reminded of 7 Delaware Code §6081 - §6084 requiring counties and municipalities with populations of 2,000 persons or more, with the assistance of DNREC, to adopt as part of the update and implementation of their 2007 Comprehensive Land Use Plans, the overlay maps delineating, as critical areas, source water assessment, wellhead protection and excellent ground-water recharge potential areas. Furthermore, the counties and municipalities are to adopt, by December 31, 2007, regulations governing the use of land within those critical areas designed to protect those critical areas from activities and substances that may harm water quality and subtract from overall water quantity.

Mr. Lank reported that the County requested and received a Scope of Services proposal from four different consultants: Davis, Bowen & Friedel, Inc., Duffield Associates, George Miles & Buhr, LLC, and Whitman, Requardt and Associates, LLP. Each firm was asked to provide the following information: scope of services, fee estimate, schedule, etc.

Mr. Lank reported that the consultants were advised that a committee would be established by the County to provide review and/or direction of the ordinance development process. The Committee may include ten people appointed by the Council plus some County staff participation and resource agency participation. Mr. Lank noted that, typically, when committees have been established in the past, each Councilman has been asked to appoint two people from their district to serve on the Committee. (Mr. Stickels asked that each Councilman submit two names by February 7th.)

Mr. Stickels stated that Duffield Associates has been selected and is being recommended based on their experience. He noted that the Scope of Services proposal is not a contract that is based on bids. Duffield Associates proposes to provide services on an actual time spent basis in accordance with an hourly rate schedule, with a contract proposal in an amount not to exceed \$24,650.00; exceeding this amount would require the Council's approval. (Mr. Stickels noted that the cost is based on four committee meetings and two public hearings.)

The Council expressed concerns about the necessity of protecting resources and permitting development and the designation of excellent recharge areas; that the County consists of a broad constituency and that the Committee would represent that constituency; that acreage would be taken out of development for the groundwater recharge areas; that farmers have a great concern about this; that Duffield Associates must remain aware that they would be working for the County and not the State.

Contract (continued)

Jeffrey Bross of Duffield Associates concurred that the regulations are going to have to be tailored specifically to Sussex County and the interests therein; that Sussex County has an abundance of groundwater and the degrees of protection that need to be afforded in Sussex County may be considerably different than some of the models that people are suggesting; that it is possible to accommodate resource protection and development using certain techniques of science and engineering; and that they understand that their goal is to make sure the Council and the citizens of Sussex County approve of the outcome.

The Council agreed to appoint two citizens from each Councilmanic District to the committee.

Mr. Phillips requested that the Council defer action on awarding the contract for one week.

- 6. There will be no more than two employees in addition to the Applicant working on the premises at any one time.
- 7. There shall only be one (1) unlighted sign on the property, advertising the business, not to exceed 32 square feet in size on either side.
- 8. Any security lights shall only be installed on the buildings and shall be screened so that they do not shine on neighboring properties.
- 9. The site plan shall be subject to review and approval by the Planning and Zoning Commission.
- 10. The existing fence on the property must remain or be improved in its current location.

## Delaware Division of Fish and Wildlife Habitat Conservation Plan

Holly Niederriter and Karen Bennett of the Delaware Division of Fish and Wildlife and the Natural Heritage and Endangered Species Program were present to give a presentation on a Habitat Conservation Plan for Delmarva Fox Squirrel and Other Species. Also present were Paul Fromer with Recon Environmental, Inc. and Karen Terwilliger and Harmony Hall of Terwilliger Consulting.

Ms. Niederriter spoke about the Delaware Division of Fish and Wildlife's development of a Habitat Conservation Plan (HCP), an endangered species conservation project designed specifically for Sussex County. She stated that there are two primary goals of the Plan: (1) to enhance conservation for endangered species in Sussex County, particularly the Delmarva Fox Squirrel and the Bald Eagle and (2) to alleviate conflicts between landowners and endangered species. The HCP would provide the foundation to achieve conservation benefits for forest-dependent species, including the Delmarva fox squirrel, in balance with other important community goals and to alleviate impacts on private landowners.

Ms. Niederriter advised that it is the intent of the Delaware Division of Fish and Wildlife to prepare a plan in cooperation with the County and that the Division is asking for the County's participation in Public Advisory Meetings and reviewing documents.

Mr. Stickels advised that Rick Kautz would be the contact person for the County.
