Grant Option Proposal Mr. Baker presented a grant option proposal which would partially restore some of the grant reductions that occurred with the passage of the Budget in June. The County's estimated revenues over expenses for the six months ending December 31, 2009 was approximately \$556,000; this was an estimate and is subject to change with swings in the economy and it is especially susceptible to changes in the amount of realty transfer tax and

other construction related revenue. Mr. Baker stated that one suggestion is for the County to partially restore the local law enforcement grants to the municipalities in an amount of \$5,000 each. This would bring each municipality up to \$20,000 for the year versus the Fiscal 2009 amount of \$25,000 each. The total cost of this proposal is \$105,000.

Grant Option Proposal (continued)

Mr. Phillips noted that this proposal is a result of a suggestion made by Mr. Cole during a discussion on the Fiscal Year 2010 Budget, at which time budget reductions were made. At that time, Mr. Cole suggested that the Council revisit the County's financial situation at a later date and consider restoring grant funding that was cut.

Mrs. Deaver suggested that consideration also be given to restoring a portion of the funding to the Sussex Conservation District.

Mr. Phillips responded that in August 2009, \$50,000 was restored to the Sussex Conservation District.

Mr. Phillips stated that Administration believes that restoring funding should be approached incrementally.

Administrator's Report

Mr. Baker read the following information in his Administrator's Report:

1. Sheriff Contract

We are pleased to announce that the Sussex County Sheriff's Department has been awarded the contract to handle delivery of court documents for Family Court and the Division of Child Support. This contract went into effect on February 1, 2010. The contract for this work was previously held by a private Pennsylvania based company. The estimated net income from providing this service for the County is approximately \$80,000 per year.

2. Snowstorm – January 30-31 Weekend

We would like to thank County staff from Facilities Management and other departments who worked during the past weekend as a result of the snowstorm. We would especially like to thank Doug Stoakley, Johnny Moore, Ken Dunn, Barry Hitchens, Bob Witzke, David Elliott, George Hunsicker, Terry Noon, Kyle Belle, Charlie McKinney, Pete Hazzard, Bobby Rogers, Bobby Schoonover, Bryan Murray, Brian Morley, and Joe King. County staff did an excellent job in cleaning snow on sidewalks, County parking lots, and the Airport runways over the weekend. This enabled County business to go on as usual on Monday, February 1.

3. Prescription Drug Card Report

As per the attached report, 6,762 prescriptions have been filled utilizing the Sussex County prescription drug card. This has resulted in an average price savings of \$15.11 per prescription, totaling \$255,048. This card is available in County offices, as well as via our website and many other locations. It is available for anyone to use.

4. Dog and Kennel Licenses Processed Since December 23, 2009

The County has collected \$11,980 to date, since December 23, 2009, for 772 dog licenses. Attached is a copy of an application form. Licenses may also be purchased on-line. March 1, 2010, is the due date for the purchase of licenses.

5. <u>Utility Billing Amnesty Program Status</u>

As per the attached notice, the amnesty program for 50 percent of interest charges for County sewer and water customers has been mailed to Dewey Beach, Bethany Beach, South Bethany, Fenwick Island, Blades, Henlopen Acres, Dagsboro-Frankford, Cedar Neck, Ocean View, Holts Landing, Ellendale, Bay View Estates, Millville, and South Ocean View customers. The program is ending for the Long Neck, Oak Orchard, and West Rehoboth districts. At this time over \$126,000 has been collected from 555 accounts that took advantage of the program. The program has saved our sewer and water customers a total of \$3,943 in interest charges to date.

6. Manufactured Housing Committee Meeting

The first meeting of the Manufactured Housing Committee appointed by the Sussex County Council will be held on Thursday, February 4, 2010, at 10:00 a.m. in Council Chambers. A copy of the agenda is attached.

7. <u>Substantial Completion</u>

The Engineering Department has granted Substantial Completion to the following projects:

Hawkseye Regional Force Main (Phase 2B), Agreement No. 777-

1, was granted Substantial Completion on January 28, 2010. The developer is L. T. Associates, L.L.C., and the project is located in Lewes in the West Rehoboth Expansion of the Dewey Beach Sanitary Sewer District, consisting of a regional force main.

Administrator's Report (continued) • Seagrass Plantation – Phase II-R1, Agreement No. 710, was granted Substantial Completion on January 29, 2010. The developer is Greenfield Partners, LLC, and the project is located on County Road 348, Irons Lane, in the Holts Landing Sanitary Sewer District, consisting of 55 single-family lots.

Public Hearing/ CDBG A Public Hearing was held on the development of a Community Development Block Grant Application, which is to be submitted to the Delaware State Housing Authority prior to February 25, 2010. The

Program

Community Development Block Grant (CDBG) is a federal grant from the Department of HUD to the Delaware State Housing Authority (DSHA). Kent and Sussex Counties compete for the funding by making application to the DSHA.

Public Hearing/ CDBG Program (continued) Mr. Lecates, Director of Sussex County Community Development & Housing, and Brad Whaley, Assistant Director, advised that Sussex County's application will consist of projects in the County and in the municipalities. He reported that staff has met with all the municipalities who have asked for the County's assistance to make application. Mr. Lecates explained that the primary objective of the Community Development Program is the development of viable urban communities, including decent housing, a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income. It is also a primary objective to alleviate physical and economic distress through the stimulation of private investment and community revitalization in areas of population out-migration or a stagnating or Eligible applicants are units of general local declining tax base. governments in Sussex and Kent counties, the Kent County Levy Court and the Sussex County Council. Mr. Lecates reported that there is approximately \$2 million available for Sussex County, Kent County, and the municipalities. Seventy percent (70%) will be for housing rehab, demolition and code enforcement and thirty percent (30%) will be for infrastructure projects, with a priority towards housing rehabilitation. There is a fifty percent (50%) match for administration required; administration of the grants is provided by the County's Community Development & Housing Department. Mr. Lecates reviewed the program eligibility requirements which are based on family size and income. He noted that the average grant per homeowner is \$15,000,00 (CDBG) and \$3,000.00 (HPG).

The Planning and Zoning Commission held a Public Hearing on this application on January 14, 2010 at which time they recommended approval with conditions.

Lawrence Lank, Director of Planning and Zoning, read a summary of the Commission's Public Hearing.

Curtis McDonald was present on behalf of his application with Mark Davidson of Design Consultants Group, LLC. Mr. Davidson stated that they are proposing a produce stand and full service meat market; that the existing building has been utilized historically for a store, flea market, and cycle shop; that other commercial uses in the area include a pre-school and nursery and a tire center; that they are proposing to remove all of the structures on the property and to build a 4,000 square foot building for the produce stand, the meat market and a storage area between the two (2) units; that Mr. McDonald has been a meat cutter for approximately 26 vears; that they are proposing a family operated business with other employees; that approximately six to eight jobs will be created; that they have been working with DelDOT on the entrance design; that a new entrance is proposed and will include a multi-modal path which will be contracted when required by DelDOT; that all the concrete paving and curbing near the highway will be removed and a new entrance constructed; that an on-site septic system is proposed since no central sewer exists in the area; and that this site is located south of and across U.S. Route 113 from the Wilson Auction site.

Public comments were heard.

Dan McClain who lives adjacent to the subject property, spoke in support of the application.

- 1. The hours of operation shall be from 7:00 a.m. to 7:00 p.m., seven days per week.
- 2. All loading areas, storage areas, and trash container areas shall be screened with a six foot high privacy fence and landscaping.
- 3. All entrances, intersections, roadway improvements, and multimodal facilities required by DelDOT shall be completed by the Applicant as required by DelDOT and within the time periods required.
- 4. Potable drinking water shall be provided.
- 5. Stormwater management and erosion and sediment control facilities shall be constructed in accordance with all applicable State and County requirements and shall be operated utilizing Best Management Practices to provide positive groundwater recharge.
- 6. The site shall have one non-illuminated on-premises sign of which the sign shall not exceed 32 square feet on any side or facing, identifying the uses permitted on the premises.
- 7. Parking lot and security lighting will be provided and will have downward illumination and shielding so that no illumination will encroach over any property line.
- 8. A landscaping plan will be provided as a part of the Final Site Plan.
- 9. The location of outside displays of goods for sale shall be shown on the Final Site Plan. Outside displays shall not be located in the front vard setback.
- 10. The uses shall be limited to a produce stand and meat market/butcher shop.
- 11. The Final Site Plan shall be subject to the review and approval of the Planning and Zoning Commission.

He stated that he is the owner of the property and that his home is located on the property; that he needs storage and warehousing for the storage and delivery of appliances; that he proposes to build a barn style structure, that he does not anticipate any negative impact on the community; that there will be no sales from the site, only storage; that he would receive deliveries of appliances once per week by an 18-wheeler tractor-trailer; that appliances would be taken off site for delivery by their small company trucks; that no signage is necessary; that the entrance would be from Road 258; that the building would not be visible from the road; that the biggest concerns expressed at the Public Hearing before the Planning and Zoning Commission was (1) traffic, (2) the lack of a sufficient turning radius for large trucks and (3) the large trucks would damage the shoulder right-of-way.
