Administrator's Report

Mr. Stickels read the following information in his County Administrator's Report:

1. **DelDOT Public Workshop**

DelDOT and the Town of Georgetown will solicit public comments regarding the Georgetown Bicycle and Pedestrian Plan. A DelDOT information booth will be set up near the ball fields at the Georgetown Little League on Opening Day, Saturday, April 27, 2002. The public is invited to visit the booth between 9:00 a.m. and 12:00 p.m.

The proposed improvements consist of sidewalks, crosswalks, and bicycle lanes in and around the Town of Georgetown. I would encourage Georgetown area residents to review this plan on Saturday, April 27.

2. **25th Annual Sussex County Prayer Breakfast**

A reminder that the 25th Annual Sussex County Prayer Breakfast will be held on Tuesday, May 7, 2002. Breakfast will start at 7:30 a.m. and will be held at the CHEER Community Center located on the corner of East Market Street and Sand Hill Road, Georgetown, Delaware.

This year's speaker will be Dr. Leonard N. Smith, Senior Minister, Mount Zion Baptist Church, Arlington, Virginia. Dr. Smith is the Chaplain of the Arlington County Fire Department, who was the first responding agency to the Pentagon on 9/11. Dr. Smith played an active role in both the incident and the recovery of this terrible tragedy.

3. **Earth Day Activity**

Representatives from the Federal government, Rural Development Agency, State of Delaware, and Sussex County Council will be participating in a ceremony on Friday, April 26, 2002, as part of the nationwide Earth Day activities. The Council will receive a check from the Rural Development Agency in the amount of \$2,475,000 for

the Miller Creek Sanitary Sewer District. Project costs are projected to be \$10.7 million.

The project will consist of a gravity collection system. Pipelines ranging from eight inches to 15 inches in diameter will be placed within existing right of ways where possible. Individual connections will be provided for each home at the street right of way. The wastewater will be collected at the new regional pumping station at Bear Trap Dunes and pumped to the County's existing South Coastal Wastewater Facility.

Construction of central sewer for this area will eliminate 483 on-site systems. It is believed that many of these systems are contributing nitrates to the groundwater and inland bays. It is projected that the average home with a 75-foot lot will have an annual cost of \$820.50.

The ceremony will take place at 2:30 p.m. in Plantation Park at Miller Creek and Double Bridges Road, west of South Bethany and south of Ocean View. For additional information, contact Russell Archut, Assistant County Engineer, at 855-7719.

4. Fire Service Grants

Tonight at the Sussex County Volunteer Firemen's Association meeting, \$378,448.00 in checks to various fire companies will be released. This is the County Council's third contribution towards the \$1.8 million that is provided annually.

Mr. Baker advised that the Indian River Volunteer Fire Company has requested and been approved for a \$7,154.00 grant from the State of Delaware Community Transportation Fund Program for a paving project at their Long Neck Facility. The Indian River Fire Company has asked the Sussex County Council to sponsor this project, a requirement of the State grant program. The County will handle the receipt and disbursement of the State funds. Another requirement for administering these funds is for the County to enter into an agreement with the Delaware Department of Transportation in order to receive the funds on behalf of the Indian River Volunteer Fire Company. Mr. Baker advised that the grant covers all the costs involved.

Update on E911 Addressing Project	Matt Laick, Acting Supervisor, Addressing Department, updated Council on the E911 Addressing Project. This deadline was set for the Addressing Department to provide Verizon with all the accurate data for that area. At the same time, the Addressing Department is working on the Bridgeville, Seaford, (part of) Georgetown, and Milton areas.

Public Hearing/ Sussex County Land Founda- tion/ Proposed Ordinance	A Public Hearing was held on the Proposed Ordinance entitled "AN ORDINANCE AUTHORIZING SUSSEX COUNTY TO ASSIST THE SUSSEX COUNTY LAND FOUNDATION IN PROTECTING, IMPROVING, ENHANCING AND PRESERVING THE NATURAL RESOURCES AND OPEN SPACE IN SUSSEX COUNTY". This Ordinance authorizes the County to participate with the Sussex County Land Foundation in the acquisition of land or the purchase of development rights in order to promote the public purpose of protecting,

improving, enhancing and preserving the natural resources and open space in the County.

Mr. Bayard read into the record the following two letters which were received regarding the Proposed Ordinance:

GOVERNOR RUTH ANN MINNER, DOVER, DELAWARE.

RE: Commending the County for recognizing the importance of preserving valuable open spaces and agricultural lands and expressing that in developing such a program at the local level, it is important that the County's effort be consistent with the States Agland Preservation and Open Space programs.

MABLE GRANKE, REHOBOTH BEACH, DELAWARE.

RE: Stating that the Proposed Ordinance should include:

- **A definition of stewardship of the land.**
- **A description of the process by which land will be acquired.**
- **What entity or entities will be used to obtain information or advice as to which lands are at risk, worthy of conservation, and potentially available?**
- **What standards for conservation/preservation are being formulated?**
- **Is the concept of green corridors as part of DNREC's conservation program part of the process for land acquisition?**

Mr. Stickels reviewed the Proposed Ordinance.

Section 1. Pledge of Support for the Foundation. The County shall be authorized to pledge to the Foundation One Million Dollars (\$1,000,000) from its fiscal year 2002-2003 budget in order to assist in protecting, improving, enhancing and preserving the natural resources and open space in the County. The County shall be authorized to pledge to the Foundation for such purposes an amount equal to ten percent of its net increase in the General Fund balance, or other authorized amount, in each subsequent fiscal year.

Section 2. County Representatives on the Board of Directors of the Foundation. As a condition for the receipt of the aforesaid funds, the Foundation's governing documents shall provide that at least two of the directors of the Foundation shall be appointed by the President of County Council, one Council person from each political party, to serve at the pleasure of the President of County Council.

Section 3. Use of County Funds. County funds contributed to the Foundation shall only be used for land acquisition, the purchasing of development rights, or stewardship of the land purchased with County funds and shall not be used for administration of the Foundation. The Foundation agrees to maintain adequate general liability, directors and officers' liability, and property insurance coverage. County funds contributed to the Foundation may only be expended for specific purposes

that are approved by four (4) affirmative votes of the County Council in an open Council meeting. Property that is acquired by the Foundation with County funds shall be restricted to preserving natural resources and/or open space use by deed restriction, or by other controls approved by the County Administrator, with the advice of counsel. All contributions to the Foundation shall be made pursuant to the terms of a Grant Agreement to be approved by the County Administrator, with the advice of counsel, which shall provide, among other things, for the County to have access to the Foundation's books and records at all reasonable times and for the County to receive annual financial statements of the Foundation. The Foundation shall permit an authorized representative of the County to inspect and audit all appropriate data and records of the Foundation.

Section 4. Effective Date. This Ordinance shall become effective immediately upon its adoption. (It will still be subject to the approval of the County's Fiscal 2003 Budget.)

Mr. Cole referred to Section 3 and recommended that "County funds contributed to the Foundation may only be expended for specific purposes that are approved by four affirmative votes of the County Council in an open Council meeting."

Public comments were heard.

Mr. Dan Kramer asked: (1) how is this program different than other organizations who want County funding, (2) why is the County backing this particular program, and (3) where is the Certificate of Incorporation which is to be included as Exhibit A in the Proposed Ordinance? Mr. Kramer stated that the Proposed Ordinance should not be voted on until the 501-C3 designation has been received.

Mr. Stickels stated that when the Foundation wants a property to be purchased with County funds, the matter will be placed on the Agenda, which will be duly advertised and posted.

Mr. Stickels and Mr. Hudson, Chairman of the Foundation, noted that the Foundation is a Sussex County organization; it is Sussex County funding; the funding will be used on Sussex County property; and Sussex Countians will be making the decisions, including two members of the Sussex County Council.

Mr. Hudson reported that the Foundation will use a different set of criteria for each property it considers. The criteria will be gathered from sources such as the Department of Natural Resources and Environmental Control, other agricultural preservation groups, and the National Alliance which the Foundation is a member of.

It was noted that, upon approval of this Proposed Ordinance, the Council President shall appoint two Council persons, one from each political party, to serve as County representatives on the Board of Trustees of the Foundation.

Mr. Hudson acknowledged that the Foundation is still in the formation process. He stated that the Foundation is officially incorporated and they are working on the 501-C3 designation and the reason that do not yet have that designation is that the IRS has certain criteria and timetables that the Foundation has to pass before receiving the designation. Mr. Hudson and Mr. Rawl stated that even though the Foundation has not received its 501-C3 designation, it can still accept contributions through a sister-organization, the Mid-Shore Foundation, and can engage in fund-raising activities until it does receive its 501-C3 approval.

It was the consensus of Council that Mr. Archut revise the Proposed Resolution removing Mr. Hanby's property from the Proposed Expansion Area. The revised Resolution will be placed on the April 30th agenda for consideration.

Mr. Archut advised that a request has been received for petitions to create a sanitary sewer district in the Johnson's Corner area.

A previous request (in the 1980's) was made for sanitary sewer service in this area; a public hearing was held on the boundaries and the need for the project. At that time, it was decided that the project was not a high priority project and no further action was taken.

Mr. Archut advised that this area is in the South Coastal Area Planning Study and that there are several subdivisions in the area. Mr. Archut advised that the proposed boundaries are the same boundaries that were previously proposed. Mr. Archut requested Council's authorization to distribute petitions.

Mr. Cole questioned if anything has changed in the area since the proposed boundaries were established; whether there are any failing septic systems in the area; approximately how many people live in the area; and whether there are other properties in the area which should be included in the petition process.

Mr. Archut was instructed to review the proposed boundaries; to consider including other properties in the petition; and to report back to Council in two weeks.

Building Code Workshop	Mr. Bill Massey, Lewes Building Official and President of the Lower Delaware Maryland Building Officials Association gave a presentation on the International Building Code. Mr. Massey reported that on April 3 and 4, 2002, the Lower Delaware Building Official Association sponsored classes on comparing present Sussex County Codes to the International Building & Residential Code. Currently, the Sussex County Council utilizes the Council of American Building Officials 1992 edition for residential requirements and the 1994 edition of the Southern Standard Building Code for commercial requirements. Two classes were held: one class was structured for contractors, engineers and architects and one class was structured for city and County officials.
	Concern was expressed that everyone did not know about the seminars. Mr. Massey stated that there will be opportunities to do seminars again and they plan to do so.
	Mr. Massey advised that the Southern Building Code Congress International (SBCCI) is moving forward with the International Building Code; that all three Building Code Books were merged in its development;

and that SBCCI continues to amend it. He noted that the previous issues of the three Codes are no longer being amended or reproduced.

Mr. Massey explained some of the different changes/comparisons. He handed out a brief summary prepared by the SBCCI in which they pinpointed the most drastic changes.

Mr. Massey pointed out that the changes incorporated in the International Building Code are not that different from what the County and municipalities are already enforcing and will not be detrimental to builders and homeowners.

Mr. Massey emphasized changes that are safety related, i.e. high wind construction, glazing protection, floodplain construction, etc.

Mr. Dukes questioned whether the Code can be adapted to Sussex County. Mr. Massey stated that this code can be adopted, with exceptions.

Public comments were heard. Support was expressed for a unified code to be used throughout the State of Delaware; to incorporate the most current building code requirements used throughout the Country; to improve the life safety requirements for occupants in buildings; and to make buildings safer with respect to fire and wind requirements.

Concern was expressed regarding starting a construction job under one code and finishing it under a different code; concern about builders' liability protection; and concern about the Code going into effect too abruptly.

Mr. Massey noted that adoption of the International Code would apply to new construction and remodeling projects and that once a house is started, it will be finished under the same code it was started under.


Mr. Massey stated that contractors and property owners will be educated as to what the changes are going to be.
