First State Inspection Agency/ Contract Amendment

approval for a contract amendment with First State Inspection Agency (FSIA). Mr. Godwin explained that Councilman Phillips had contacted him on April 12, 2006 concerning a complaint received from Mr. and Mrs. Mayr regarding the County's building inspection procedures. Mr. Godwin gave a brief summary of the incident, as well as distributing copies of a memo sent by him to First State Inspection Agency and the Sussex County Building Code Department. The basis of the complaint stems from the fact that upon an inspection at the Mayr home by a FSIA building inspector, the inspector offered additional personal opinions about the builder's workmanship. Later, when Mr. and Mrs. Mayr took the builder to court, the inspector testified and billed the homeowners for the time in court. It is the County's position that when an inspection is made, FSIA inspectors should not offer personal opinion. Mr. Godwin has been in contact with First State Inspection Agency and they are in agreement to an amendment of their contract with the County, as well as making reimbursement to Mr. and Mrs. Mayr in the amount of \$140. Mr. Godwin read into the record the recommended contract amendment.

FSIA or its employees shall not offer or provide services to any third party that may result in a fee being charged to the third party while performing County inspections under the terms of this agreement."

Bicycle Safety Program/ Request for Funding State Representative Peter Schwartzkopf was in attendance and addressed Council regarding his letter requesting the County's financial assistance for the continuation of a Bicycle Safety Program. Mr. Schwartzkopf noted the danger caused by the influx of foreign student workers who rely heavily on bicycles as their mode of transportation. The Bicycle Safety Program educates the cyclists on the rules of the road and bicycle safety, as well as providing safety equipment, such as reflective vests and helmets. The Program is a partnership between law enforcement, medical professionals, Sussex Cyclists, Inc. and local

businesses. Sussex Cyclists have volunteered to hold periodic checkpoints starting in late June and throughout July along Route One. Mr. Schwartzkopf had originally agreed to provide \$5,000 in funding for this Bicycle Safety Program from his Community Transportation Funds, but was informed by DelDOT that this was not an allowable expense of those funds. Mr. Mike Tyler, of Sussex Cyclists, Inc., presented additional information regarding the influx of summer student workers, as well as tourists, and their impact on the roadways of Sussex, especially Route 1. He noted that, last summer, as many as 100 cyclists an hour were recorded as traveling on Route 1. It was mentioned that DelDOT has allocated \$4,000 for light sets, and that the \$5,000 requested today would be used toward a total of \$11,000 that is needed to purchase 3,000 helmets, not only for seasonal foreign workers, but for local cyclists and residents as well. Of the \$11,000 needed, presently, there is an approximate \$6,500 shortfall. All Sussex residents are welcome to attend the Bicycle Safety Day/Fair that will be held on June 19.

Mr. Masten, Director of Economic Development, reported that requests had been received from John Reichert to construct an approximately 5,000 square foot airplane hangar on leased property, Site #6, at the Sussex County Airport, as well as from A.P. Croll, III, on Site #7. Mr. Masten distributed handouts detailing the specifics of the two leases. Both would be 30-year leases with two 10-year options, CPI yearly increase after the first year, \$650 monthly land lease, proposed improvements would be reviewed by County Engineering staff, and construction would begin within 180 days.

Sussex County Airport Sublease/ Delmarva Aviation Mr. Masten noted that Mr. John Kenney, of Georgetown Aircraft Services, is requesting approval to sublease their current lease with the County to Delmarva Aviation. The sublease tenant would be Garrett L. Dernoga, owner of Delmarva Aviation. Both Mr. Kenney and Mr. Dernoga were in attendance. Mr. Dernoga explained that he is a local flight instructor with 6 years of experience. He noted that he has identified the need for additional flight instruction in Sussex County. In addition to their primary focus in providing flight instruction services, Delmarva Aviation will also provide aircraft rentals, advanced training, recurrency training, and sightseeing & aerial photography services. The proposed services would begin immediately upon County Council's approval.

White's Creek Manor (Project No. 05-06)/ Mr. Izzo reported to Council on Sussex County Project No. 05-06, "White's Creek Manor and County Road 350 Sewer" of the Millville Expansion of the Bethany Beach Sanitary Sewer District. Mr. Izzo noted that of the 6 bids that were received, three were less than the Engineer's estimate of \$3,572,465. A

bid protest was received from Metra Industries of Little Falls, New Jersey, the second low bidder. The basis of the protest was due to the fact that two of the subcontractors referenced in the low bid received from Underground Utilities were not licensed in the State of Delaware as of the bid opening. Research indicated that one subcontractor was actually licensed properly, and the amount of the work to be performed by the second subcontractor amounted to less than \$5,000. A finding by the Assistant County Attorney determined that the error was not significant and that the award to the low bidder, Underground Utilities, was appropriate.

Ms. Deptula, Assistant Director of Public Works, presented and reviewed with

Proposed Suburban Community Improvement Project Council a fact sheet regarding the Holly Oak Proposed Suburban Community Improvement (SCI) Project. She noted that the project was formally accepted into the SCI Program on Tuesday, January 17, 2006. Since that date, a final cost estimate has been prepared for the requested improvements, which includes a final project cost of \$235,279.36 for a 3-inch hot mix pavement overlay and minor drainage repair work. This cost estimate was mailed out to property owners on April 10, along with an invitation to attend a public comment session held on Sunday, April 30th (the date of an already scheduled property owner's meeting). A letter was then received from the Association requesting the County to proceed with an election based on the cost estimate presented by the County of \$235,279.36, or \$427 per year, based on the average parcel size. Ms. Deptula is requesting Council's approval to authorize an election to be held.

West Reh. Expansion/ DBSSD (Pinetown Sewer Redesign/ Mod. No. 3)

Mr. Stewart, Project Engineer, appeared before Council to discuss a modification to the County's contract with George, Miles & Buhr, LLC, the County's engineering consultant, for the Redesign of the Pinetown Sewer Extension of the West Rehoboth Expansion of the Dewey Beach Sanitary Sewer District. The original contract for the design of the West Rehoboth Expansion was signed on February 18, 1997. Modification No. 2 was for the design of the Pinetown Sewer Extension (Project No. 96-03). Mr. Stewart noted that construction bids received for that project exceeded the Engineer's cost estimate and the project's budget. Based on the Engineering Department's recommendation, the Council rejected both bids in October 2003, and determined that the project be value engineered and rebid. Mr. Stewart reported that it was now favorable to redesign the project as an all-gravity system. George, Miles & Buhr, the previous consultant, was requested to submit a proposal for the redesign, which has been done. At the present time, the Engineering Department recommends that the County go forward with this redesign by George, Miles & Buhr under Contract Modification No. 3 for the total estimated fee of \$38,313.

EOC/Change Order No. 1 Mr. Stewart, Project Engineer, reported to Council on Change Order No. 1 - Sussex County Emergency Operations Center, which is for a change in the amount of paving in the parking lots at the Center. When the design of the parking lots was reviewed, the pavement thickness was found excessive for the expected traffic loads. Therefore, the Engineering Department recommended that the total pavement thickness be reduced in all parking areas, except the entrances and exits. The asphalt courses were decreased from 4 inches to 3 inches, and the crushed stone course from 9 inches to 6 inches. The Contractor, Richard Y. Johnson & Son, offered a total credit of \$28,241 for this reduction in paving work, which will decrease the total contract sum by that amount.

Proposed Ordinance/ "Clean Hands Policy"/ Discussion Only

Mr. Godwin presented and briefly discussed with Council a proposed Ordinance entitled, "AN ORDINANCE TO AMEND CHAPTER 103, TAXATION, TO ADD ARTICLE V TO REQUIRE PROPERTY OWNERS TO BE CURRENT IN ALL MONETARY OBLIGATIONS OWED TO THE COUNTY AS A CONDITION TO MAKING APPLICATION FOR AND APPROVAL, **SERVICES COUNTY COUNTY** RECEIVING **OBTAINING A COUNTY LICENSE OR PERMIT".** The Synopsis states that "This amendment creates a "clean hands policy" that will require a property owner's monetary obligations to the County to be paid current prior to the County accepting an application from the property owner for any license, permit, approval or additional service to the delinquent property or its owner. Without this amendment, the property owner who is delinquent in their obligations can file an application for zoning approval, a variance, a building permit or building code review without paying the delinquent tax obligations owed to the County." This proposed Ordinance is for Council's review and possible introduction at a later time.

Proposed Ordinance/ Discussion (Define Scattered Parcel) Mr. Griffin reviewed with Council a proposed Ordinance entitled, "AN ORDINANCE TO AMEND THE CODE OF SUSSEX COUNTY BY AMENDING ARTICLE XVII \$110-110 DEFINING A "SCATTERED PARCEL". It was noted that Councilman Phillips had requested that this Ordinance be drafted. Due to concern expressed by Councilman Cole, it was requested by Council for Mr. Izzo and his staff to investigate the impact of this proposed Ordinance. The synopsis of the proposed Ordinance states, "This amendment enlarges the land area that constitutes a "scattered parcel" in light of the fact that the North Bethany area is almost entirely developed and that there is more than ample sewer capacity for the North Bethany extension of the Bethany Beach Sanitary Sewer District."

Introduction of Ordinance

Mr. Phillips introduced a Proposed Ordinance entitled, "AN ORDINANCE TO AMEND THE CODE OF SUSSEX COUNTY BY AMENDING ARTICLE XVII §110-110 DEFINING A 'SCATTERED PARCEL". The Proposed Ordinance will be advertised for a Public Hearing.

Update/ Sign Ordinance Mr. Godwin reported to Council regarding the Sign Ordinance and the enforcement thereof. Although a final analysis has not been completed, Mr. Godwin briefly reviewed highlights regarding the particular issues mentioned by Council at last week's meeting, such as changeable signs, lighted signs, and temporary real estate signs. Council was presented with copies of County Code, in particular §115-157 thru 160. Mr. Godwin also noted three items containing vague wording and suggested revisions to offer additional clarification. Mr. Godwin noted that it appears that enforcement of the County's Sign Ordinance is complaint-driven, but suggested a more proactive approach. Upon his final analysis of the County's Sign Ordinance, Mr. Godwin will report back to Council.

Resident's Concern

Mr. Kramer, of Greenwood, noted that several his continued complaints regarding an alleged illegal sign have not been addressed.

Mr. Abbott, Assistant Director of Planning and Zoning, read a summary of the Commission's Public Hearing and their reasons for denial. The summary was admitted as part of the County Council's record.

The County Council found that Jennifer Morgan, the applicant's wife, was in attendance, along with their attorney, David Rutt. Mr. Rutt explained that Mr. Morgan was absent due to complications arising from a recent medical procedure. Exhibit booklets were presented to Council by the applicant, which included a copy of their application, site plan, photographs of the site and

surrounding area, letters of support, and various additional information. Mr. Rutt presented a review of the application, as well as the 17 conditions submitted by the applicant that would address concerns expressed during the Planning & Zoning hearing. Mr. Rutt stated that he felt the application was an appropriate use for an AR-1 District, as well as benefiting the agricultural community. Council suggested privacy fencing as an additional condition so as to prevent future complaints that may arise as to the storage and parking of trucks and trailers. Mrs. Morgan stated agreement to the inclusion of privacy fencing, or a buffer, as an additional condition, and presented a brief statement of explanation and support of the proposed application.
