Report**

Mr. Baker read the following information in his Administrator's Report:

1. Delaware Department of Transportation Workshops – US 113 North/South Study

As per the attached notice, the Delaware Department of Transportation will be holding workshops regarding the US 113 North/South Study on May 24 and May 25, 2010. The May 24 workshop will be held at the Millsboro Fire Company, 109 East State Street in Millsboro, from 4:00 to 7:00 p.m. On May 25, a second workshop will be held at the Phillip C. Showell Elementary School in Selbyville from 4:00 to 7:00 p.m.

2. Delaware State Police Report

Attached is a copy of the Delaware State Police report for March 2010. As noted, 3,832 complaints were handled. There were 3,821 traffic charges, 331 felony criminal arrests, and 817 misdemeanor criminal arrests during March in Sussex County.

3. Clean Hands Collection Report

Per the Sussex County Council Assessment Division, approximately \$826,799 has been collected in delinquent property taxes and sewer and water billings as a result of the Clean Hands Ordinance. This ordinance went into effect October 16, 2007.

4. Sussex County – “Coastal Charms”

Attached is a copy of an article that appeared in The Wall Street Journal on May 15 and 16, 2010, about Sussex County. As noted in the article, more and more people are attracted to Sussex County, its coast, its people, and its lifestyle. The advantages of Sussex County are highlighted in this article.

Presentation of Proposed Annual Operating Budget for Fiscal Year 2011

Mr. Baker presented and reviewed the Proposed Annual Operating Budget for Fiscal Year 2011 and the accompanying Budget Letter (both of which are available for download and/or viewing on the County’s website at www.sussexcountynj.gov. Assisting Mr. Baker with the Budget presentation were the other members of the Budget Committee: Susan Webb, Finance Director; Gina Jennings, Director of Accounting, and Kathy Roth, Budget Director and Cost Manager.

Mr. Baker stated that the primary challenge and goal in developing this budget has been to maintain and supplement existing County services in the midst of a major economic downturn.

Mr. Baker reported that the County continues to budget with the following goals:

- balanced budget with zero use of appropriated reserves
- maintain an operating reserve of approximately 25 percent
- continue funding for pensions and pension benefits
- operate without tax supported debt
- maintain ‘AA ‘ strong bond rating
- maintain funding for local libraries
- upgrade and maintain existing wastewater services
- continue to eliminate existing septic systems in new and expanded sewer districts
- provide subsidies to allow for the capping of front footage costs at 100 feet in sewer and water districts
- continue tax credit and sewer assistance programs

Mr. Baker reported that the Fiscal 2011 Budget includes the following initiatives:

- Economic Development - take full advantage of available programs to provide more jobs in Sussex County
- unify sewer district accounting funds to provide administrative cost savings
- implement a plan to provide uniform service charges by reducing number of sewer and water funds from 23 to four, and make

- corresponding rate changes
- revise and improve security in County buildings
- obtain best possible financing for sewer and water projects to improve affordability
- begin implementation of new financial systems software packages
- revise and upgrade the Personnel Code
- perform sewer operations upgrades
- continue updating zoning ordinances per Land Use Plan
- provide emergency preparedness software which will improve communications with different agencies during emergency events
- no property tax increase

Mr. Baker reported that the County's proposed General Fund Budget for Fiscal 2011 increased \$613,791, which represents 1.33 percent more than the Fiscal 2010 Budget. Total revenues and expenditures are estimated at \$46,842,647. As in Fiscal 2010, realty transfer tax again is the second largest non-sewer and water revenue source in the General Fund. This estimate for Fiscal 2011 assumes that realty transfers will remain at the current level that was seen in Fiscal 2010.

Mr. Baker reported that the Fiscal 2010 Budget projected General Fund revenues decreased 16 percent. The General Fund revenues projected for Fiscal 2011 are only one percent higher than Fiscal 2010. The County's second largest revenue, realty transfer tax, equals the Fiscal 2010 Budget amount of \$12,700,000, which is 29 percent below the 2009 budget and 65 percent below the 2005 actual. Property tax revenues are up 1.45 percent, which represents a slower increase than in many preceding years. Housing related revenues are estimated to be four-tenths of one percent greater during Fiscal 2011 versus 2010, and six percent less than the actual for 2009. Mr. Baker noted that conservative budgeting now and in the past has enabled the County to continue without raising property taxes.

Mr. Baker reported that the proposed \$139 million budget includes \$46,842,647 in the General Fund; \$8,060,000 in the Capital Improvement Fund; \$3,464,024 in the Community Development Fund; \$31,283,297 in Water and Sewer Districts; and \$50,195,889 in Water and Sewer Capital Projects.

Mr. Baker reviewed the following budget highlights:

- No property tax increase
- Reduced staffing levels
- Unified sewer accounting fund
- Plan for a uniform sewer service charge
- Funding for 40 troopers above State Police allocation
- Sussex County Volunteer Firemen's Association (\$3 Million)
- Dog Control (\$755,846)
- 26 percent decrease in pension costs

- **Five year Capital Plan (\$215,180,341)**
- **Fiscal 2011 Economic Development - Capital Plan**
- **1.3% General Fund Budget Increase**
- **No use of appropriated reserves in the General Fund Budget**

(continued) **Mr. Baker advised that the Proposed Budget is based on the assumption that no changes would be made in State Paramedic funding or Realty Transfer Tax and based on the Register of Wills and Recorder of Deeds Offices remaining a function of the County.**

Mr. Baker reported that a Public Hearing will be held on the Proposed Budget on June 22, 2010.

for a Moratorium on Casino Applications The Planning and Zoning Commission held a Public Hearing on the Proposed Ordinance on May 13, 2010 at which time they recommended denial since the moratorium would cause panic regulations; that an ordinance should be drafted for consideration in the normal process of ordinances; that the ordinance contains language which provides that the Ordinance can be extended, modified or terminated at any time by a majority vote of all members of the County Council without any involvement by the Planning and Zoning Commission; and that moratoriums set precedence causing bad governance.

Mr. Phillips questioned if the moratorium is currently in place. Mr. Moore stated that, according to a Court of Chancery ruling, the County does not currently have a moratorium in place; that there was a majority vote by Sussex County Council to place one; and that is why a Public Hearing was scheduled.

Public comments were heard. Eric Bodenweiser spoke in support of the Proposed Ordinance stating the importance of the issue to the citizens and he asked the Council to keep in mind, while drafting the regulations, how detrimental the gambling industry could be to the citizens of Sussex County, if it is allowed.

Lit Dryden spoke, not in support or opposition, and he raised several concerns: private property rights, a level playing field (fairness); and the six month time period.

Mr. Cole stated that the Proposed Ordinance should be revisited and tightened up and he questioned if the Proposed Ordinance should pertain only to new applications; should it include casinos and/or racinos; and is it too all-encompassing.

The Public Hearing was closed.
