Announcement/ Loss of Sussex County Paramedic Stephanie Callaway Mr. Baker and Glenn Luedtke, Director of EMS, sadly announced the death of County paramedic Stephanie Callaway. A single vehicle crash occurred on Route 24 at approximately 2:40 a.m. on Tuesday, June 17th, when an ambulance from the Mid-Sussex Rescue Squad was en route to Beebe Medical Center in Lewes with a patient. The patient also passed away when the ambulance conducting the hospital transport struck a row of trees in an attempt to avoid a deer in the roadway.

Administrator's Report Mr. Baker read the following information in his Administrator's Report:

## 1. Land Use Plan Update

An amended copy of the Land Use Plan Update has been submitted to the Planning and Zoning Commission as per their request. At their June 18, 2008, meeting, the Planning and Zoning Commission will be discussing the proposed Land Use Plan Update. The Commission will be making a recommendation to the County Council. Copies of the revised Land Use Plan Update are available on the Sussex County website at <a href="https://www.sussexcountyde.gov">www.sussexcountyde.gov</a>.

# 2. <u>Delaware Department of Transportation Public Workshop – Statewide Transportation Plan Update</u>

The Delaware Department of Transportation will be hosting a workshop on July 15, 2008, from 4:00 to 7:00 p.m. at the DelDOT Administration Building, 800 Bay Road, Dover, Delaware. This will be an open workshop to receive comments and questions regarding the Statewide Transportation Plan.

### 3. Beneficial Acceptance

The Engineering Department has granted Beneficial Acceptance to the following projects:

- Bay Forest Club Phase 1.2, Agreement No. 478-2, was granted Beneficial Acceptance on June 11, 2008. The developer is Bay Forest, L.L.C., and the project is located on the east side of Whites Neck Road, north of Old Mill Road, in the Millville Expansion of the Bethany Beach Sanitary Sewer District, consisting of 35 single-family lots.
- The Landings at Pepper Creek (sewer revision) (a/k/a The Marina at Pepper's Creek), Phase 1A, Agreement No. 516-1, was granted Beneficial Acceptance on June 12, 2008. The developer

is S. K. Pepper Creek, L.L.C., and the project is located on the south side of Road 336, east of County Road 335A, in the Dagsboro/Frankford Sanitary Sewer District, consisting of 16 single-family lots.

Administrator's Report (continued) • Hopkins-Pettyjohn Subdivision – On-site (gravity and roads only) (a/k/a Red Mill Pond North), Agreement No. 446-2, was granted Beneficial Acceptance on June 12, 2008. The developer is ADC Builders and the project is located northeast of the intersection of Route 9 and Route 261 in the West Rehoboth Expansion of the Dewey Beach Sanitary Sewer District, consisting of 59 single-family homes and one clubhouse with a pool.

Included with this report is a fact sheet on each of the projects.

# 4. <u>Inland Bays Pollution Control Strategy Public Hearing</u>

The Delaware Department of Natural Resources and Environmental Control will hold a public hearing on June 23 at 6:00 p.m. at the Georgetown CHEER Center regarding the proposed Inland Bays Pollution Control Strategy. Attached is information regarding the hearing.

## 5. Legislative Update – House Bill No. 453

Attached is a copy of House Bill No. 453 regarding agritourism activities. On farms of ten or more acres, certain uses that now require public hearings by County Council and/or the Planning and Zoning Commission would be allowed by the State of Delaware. These allowed activities would include wineries, historical activities, cultural activities, harvest-your-own activities, outdoor recreation activities, rodeo and livestock activities, fishing, swimming, boating, camping, shooting, water skiing or tubing, paintball, freestyle or mountain and off-road bicycling, and riding or operating motorized recreational vehicles. Some of these activities currently require approval by the Planning and Zoning Commission and/or County Council after public input is received.

Legislation/ House Bill No. 453 Mr. Baker stated that the County has some concerns regarding House Bill No. 453, especially the elimination of the public notification process. Mr. Baker reported that there is an amendment to the Bill proposed by DelDOT so that DelDOT would continue to regulate vehicle ingress, egress and signage for farm markets and roadside stands, as they currently do. Mr. Baker advised that the Farm Bureau supports this legislation.

Mr. Baker stated that the Council could take a position to (1) oppose the legislation, (2) exempt the County, or (3) exempt the County from certain uses that are currently included.

The Council considered whether or not to oppose the legislation: Mr. Cole, Oppose; Mr. Phillips, Support; Mr. Dukes, Oppose; Mr. Rogers, Oppose; Mr. Jones, Oppose. It was the consensus of the Council to oppose House Bill No. 453, as written.

Ed Jestice, President of the Delaware Farm Bureau and Chairman of the Agritourism Group, was asked to address the Council and present the Sussex Farm Bureau's position. Mr. Jestice educated the Council on the agricultural activities that are already allowed (legislation adopted in 2004 and updated in 2006). He noted that House Bill No. 453 would only broaden a few of the existing aspects. Mr. Jestice stated that he respects the County's position and that he would take the Council's message and concerns to Dover. He agreed that there are concerns with some parts of the legislation, including on-farm rodeos and motorized vehicles, and that adjustments to the legislation will be made; in addition, building height and setbacks and off-street parking will be addressed.

Mr. Dukes referenced DelDOT's Public Workshop on state-wide transportation and he asked that Hal Godwin or Chip Guy find out cost information, e.g. DelDOT's costs and the rider's costs. Mr. Dukes commented that the State has said that they are losing money on this program.

A Public Hearing was held on the Proposed Ordinance entitled "AN ORDINANCE ESTABLISHING THE ANNUAL OPERATING BUDGET FOR FISCAL YEAR 2009".

David Baker, Susan Webb, and Kathy Roth (Budget and Cost Manager) presented the Proposed Fiscal 2009 Budget.

Mr. Baker stated that the Proposed Budget totals \$142 million, approximately \$113,000 less than Fiscal Year 2008; that the General Fund (operating funding) is down \$3.1 million from the previous year to \$54.8 million; and that the sewer and water districts budget for operations and debt service is down 7 percent (\$2.4 million). As part of the General Fund,

there is a \$9.9 million Rainy Day fund (approximately 17 percent of the Budget); this funding is used for emergencies and unexpected needs.

Public Hearing/ Fiscal Year 2009 Budget (continued) Mr. Baker stated that Realty Transfer Tax revenues are approximately onehalf of what they were in 2005 and 2006, which is due solely to the change in the economy. For this reason, the County is trying to make do with less and without making changes to important County services.

Mr. Baker stated that the challenge and goal in developing this Budget has been to maintain and supplement existing County services while facing major decreases in revenue; that conservative budgeting in the past has enabled the County to continue without raising property taxes; that the County's strong financial base enables further use of appropriated reserves during Fiscal Year 2009 to supplement the Budget; and that General Fund Budgeted Appropriated Reserves of \$2,550,515 are reduced by \$1,839,866 for Fiscal Year 2009. Mr. Baker reported that, as in prior years, a major concern of the Budget Committee continues to be various proposals by the State to reduce the County's share of Realty Transfer Tax funds. Mr. Baker reviewed potential cuts that may be necessary if the Realty Transfer Tax allocation is reduced by the State.

Mr. Baker, Mrs. Webb, and Mrs. Roth presented a power point presentation that provided an overview of the Proposed Fiscal Year 2009 Budget.

Mr. Baker presented the following budget highlights:

- No property tax increase.
- 21% decrease in anticipated Realty Transfer Tax and housing industry related revenues.
- Land Use Plan Update ordinances.
- No Sewer Service Charge or Assessment increases.
- Economic Development Industrial Park & Airport Improvements (\$10.1 Million)
- Records Storage Program
- Funding for 40 additional State Police
- Sussex County Volunteer Firemen's Association (\$3.5 Million)
- Moderately Priced Housing Program Administration
- Dog Control \$300,000 Grant
- Millville and Miller Creek Sewer
- Five-Year Capital Program (\$277,103,970)
- Fiscal 2009 Capital Plan, including Library Expansion Projects in Milton and South Coastal, Airport Industrial Park Improvements, Treatment Plant Expansion Design, Millville Sewer, Utility Rate Study, Water and Sewer Communication Improvements
- 5.4 percent General Fund Budget Decrease

Public comments were heard.

Dan Kramer of Greenwood commented on the State wanting more money from the County and he questioned and spoke in opposition to the funding allocation for the Sheriff's Department for a Deputy Sheriff to assist in providing added security to the County Administration Building and for additional training and education of all Deputies.

John Brady of Lewes and the Sussex County Recorder of Deeds thanked the Council for its budget allocation. He stated that, as always, he does not plan to spend the entire allocation and that he will be prudent with the taxpayers' money.

Bill Tobin of Harbeson, President of the Sussex County Volunteer Firemen's Association, spoke on behalf of the fire companies and the EMS service, thanking the Council for the funding allocated in the Fiscal 2009 Budget.

Lisa Smith of the Sussex County Habitat for Humanity thanked the Council for its past support and requested that \$20,000 be included in the Fiscal 2009 Budget to assist families who remain in substandard housing and to maintain their goal of constructing eight more homes next year.

Dr. Robert Roberts of Rehoboth Beach spoke regarding the West Rehoboth area. He stated that on June 10, 2008, the Lewes – Rehoboth Association of Churches (LRAC) recommended that the following committees be combined into one coalition committee: West Side New Beginnings (WSNB), Citizens Committee for West Rehoboth (CCWR), West Rehoboth Community Land Trust (WRCLT), and the Coalition for Tolerance and Justice (CT&J). The purpose of this is to establish an organized program for the improvement of the West Rehoboth community. Dr. Roberts requested funding in the amount of \$62,000 for West Rehoboth for the following: funding for rehabilitation of five homes (\$50,000), aid in addressing the dangerous situation existing with trash pick-up and its escalating costs (\$9,000), and improved street lighting (\$3,000). A letter from the LRAC, WSNB, WRCLT, CCWR and CT&J was made a part of the record of this Public Hearing..

Mr. Cole stated that the City of Rehoboth would have the equipment needed for a community clean-up project and he asked Dr. Roberts to (1) obtain a letter from the City confirming their participation, (2) find out what the clean-up costs would be, and (3) submit this information along with a letter to the Council requesting funding.

Brenda Melbourne spoke regarding the West Rehoboth area and requested immediate assistance with costs associated with trash removal and street lighting.

Esther Shelton of the League of Women Voters of Sussex County thanked the Council for its budget allocation for the brochure entitled "They Represent You". She also commented on Land Use, Open Space and Row Offices. Ms. Shelton submitted a letter, which was made a part of the record of this Public Hearing.

Public Hearing/ Fiscal Year 2009 Budget (continued) Ken Bock, Deputy Director of CHEER, stated that this year CHEER will provide over 200,000 meals to 6,000 citizens of Sussex County and the Home Services Division will serve 3,700 individuals providing over 115,000 hours of service to individuals in their own homes to help them maintain their independence and quality of life. Mr. Bock asked that the Council consider the following in the Fiscal 2009 Budget: increased costs associated with CHEER's Nutrition Program including increases in the cost of food and fuel and a proposal by the State to decrease their grant-in-aid program. It was noted that a grant request was previously submitted.

George Parish, Sussex County Clerk of the Peace, thanked the Council for approving the Department's Fee Schedule, which does not permit the taxpayers of Sussex County to subsidize out-of state residents' marriage licenses.

Bernice Edwards, Executive Director of First State Community Action Agency, asked for the Council's financial support for renovations to their office building in Georgetown. It was noted that a grant request was previously submitted.

David Wilson, Sussex County Register of Wills, spoke in support of the Proposed Budget.

There were no additional public comments.

Mr. Baker submitted to the Council a list of grant requests for the Fiscal 2009 Budget totaling approximately \$900,000. Mr. Baker stated that approximately \$200,000 of those grants have been included in the Proposed Budget: Delaware Hospice (\$5,000), La Esperanza (\$1,000), Milford Housing Development Corporation (\$25,000), University of Delaware (\$138,098), CHEER Community Center – Home Services Division (\$10,000), and Delaware District III Softball World Series (\$15,000).

Mr. Baker read a letter into the record from the Bethany-Fenwick Area Chamber of Commerce thanking the Council for including the County Economic Development Office and Director in the Fiscal 2009 Budget.

The Public Hearing was closed.

Public Hearing/ Assessment Rolls for Water A Public Hearing was held on the Assessment Rolls for all Sussex County Sewer and Water Districts. Mrs. Webb explained that the Assessment Rolls reflect the County's billing records for EDUs and billable front footage for each sewer and water district account. These records have been made available for public inspection in the Utility Billing Office for review and and Sewer Districts they are subject to individual appeals via the Assessment Review Board.

There were no public comments and the Public Hearing was closed.

A Public Hearing was held on the Proposed Ordinance entitled "AN **ORDINANCE ESTABLISHING ANNUAL SERVICE** CHARGES, **ANNUAL** ASSESSMENT RATES FOR COLLECTION AND TRANSMISSION AND/OR TREATMENT. AND **CONNECTION** CHARGES FOR ALL SUSSEX COUNTY WATER AND SANITARY SEWER DISTRICTS".

Susan Webb and Kathy Roth distributed and reviewed several charts and handouts, including a summary of costs to be recovered through annual utility charges; a summary of annual service charges and assessment charges; a summary of system connection charges; a summary of average sewer and water bills by district; and water and sewer district relief programs. Mrs. Webb noted the growth in the sewer districts; in 1998, there were 30,000 EDUS and in 2009, there are almost 60,000 EDUs, representing an average annual growth of 17 percent.

Mrs. Roth reported that \$38.7 million in capital projects is proposed, including Angola and Millville. The Five Year Capital Plan is \$277 million; 77 percent is for water and sewer projects and 23 percent is for general fund projects; bonds will fund \$175 million of this amount.

Mr. Baker reported that no changes are recommended to the assessment rates and service charge rates for the sewer districts. He noted that front foot assessment rates are designed to recover the costs of bond debt service and capital costs and that service charge rates are primarily used for operations and maintenance; however, they are also used for some bond debt service costs for treatment facilities. All of the charges are maintained for each respective district. Mr. Baker explained that connection charges are one-time up-front fees charged for new users. He noted that there are some recommended changes to these charges; an increase of 3.4 percent is being recommended for most of these fees due to the increase in construction costs. He further noted that connection charges are designed to cover the cost of growth.

### Public comments were heard.

Mickey Kerneklian of Ocean View stated that he was present representing Banks Harbor Retreat, which is a part of the North Millville Sewer Expansion. Mr. Kerneklian discussed the proposed charges and its impact on this (primarily) senior citizen community. He expressed concern about the impact fee. He stated that the impact fee for a home built before June 2003 would be \$2,300.00; however, additional costs in the approximate amount of \$1,500.00 would also have to be paid to a plumber; the total payout by the homeowner would be approximately \$4,000.00. If a home

was built after June 2003, the impact fee would be \$5,222.00 plus additional costs to a plumber; the total payout in this case would be approximately \$7,000.00. Mr. Kerneklian stated that the part that concerns him the most is the annual rate of \$230.00 and the front foot costs (\$9.85); and that 100 front feet would cost \$1,200 to \$1,300 per year. He stated that these rates will adversely affect the residents. Mr. Kerneklian compared these rates to other sewer districts. Mr. Kerneklian expressed his hope that the rates will be lower when the actual costs are established.

Edwin Schimler, Jr. stated that he believes that the existing ordinance establishing the tax assessment formula for County water and sewer districts needs to be reformed or amended in some way to ensure that the cost (tax assessment) is more evenly disbursed among the citizens utilizing the system. He stated that the current ordinance has been in existence for about 30 years and that it should be updated to consider the situations of various people. Mr. Schimler stated that at the Fiscal 2008 Budget Hearing, he was told by the President of the Council that the 100 foot cap limitation could not be made permanent and that changes to the assessment formula were in process. Mr. Shimler stated that he would like to know the status of those changes as he does not see any changes reflected in the Fiscal 2009 **Budget.** 

Mr. Baker stated that the County has hired a consultant to perform a Utility Rates Study and that the Study is near completion. Mr. Baker stated that he would arrange a meeting with Mr. Schimler and County staff.

There were no public comments and the Public Hearing was closed.

The Planning and Zoning Commission held a Public Hearing on these applications on March 5, 2008; on March 19, 2008, the Commission recommended that the applications be denied.

The County Council held a Public Hearing on these applications on March 18, 2008 at which time they deferred action.
