Delaware Transit Corporation's Reimbursable Transportation Budget Mr. Baker presented the Fiscal Year 2009 Delaware Transit Corporation's Reimbursable Transportation Budget; each year, the County Council is required by the State of Delaware to approve the budget allocations for Sussex County Senior Services transportation.

For Fiscal Year 2009, a budget appropriation in the amount of \$796,862.00 was approved by the General Assembly, the same amount as the last six years, as follows:

Mr. Baker read the following information in his Administrator's Report:

1. <u>Sussex County EMS Invited to International Competition</u>

Administrator's Report (continued) The Paramedic Competition Team from Sussex County EMS has been invited to participate in the Second International EMS Competition in Israel. The event is part of an international EMS symposium sponsored by Magen David Adom Israel, which is the national EMS system of that country. Competitors will include teams from the Czech Republic, Poland, Canada, Turkey, Ireland, Great Britain, Netherlands, Norway, France and Germany, in addition to those from Israel. As of this moment, Sussex County will be the only team representing the United States.

Three members of the SCEMS Paramedic Competition Team will compete in the event, which will be held September 7th through the 9th. A fourth member, Operations Manager, Robbie Murray, will also attend and will serve as an alternate, if necessary. Mr. Murray is also delivering a lecture at the conference.

All expenses, with the exception of air fare, are being covered by Magen David Adom Israel.

2. Roland L. Derrickson –Former Planning & Zoning Director

We regret to announce the passing of Roland L. Derrickson, of Dagsboro, Delaware, who died on August 9, 2008. Mr. Derrickson worked for Sussex County Council during the period of 1969 to 1984, and served as the first Director of Planning & Zoning from 1971 to 1984. He was active in the community with a variety of different agencies. He also served as Deputy Secretary of Delaware Department of Agriculture and Acting Secretary of Agriculture. We wish to express our condolences to Mr. Derrickson's family.

Report on Agency Comments/ C/U No. 1741 Lawrence Lank, Director of Planning and Zoning, reported on the Proposed Ordinance denominated Conditional Use No. 1741, filed on behalf of David G. Horsey & Sons, Inc.

On June 3, 2008, the Council held a Public Hearing on the application of David G. Horsey & Sons, Inc. for a borrow pit on the northerly site of Route 20. At that time, the Council heard comments in opposition to the application. Due to some concerns of the Council and concerns expressed by the residents in the area of the proposed borrow pit, the Council deferred action and left the record open for comments from the Department of Natural Resources and Environmental Control (DNREC) and the Department of Agriculture. The record was left open for 60 days for written comments from DNREC regarding water quality and quantity and other issues associated with the proposed activity and written comments from the Department of Agriculture on the possible impact of waterfowl impacting the water quality and nearby poultry operations. Thereafter, the record was to be left open for 30 days for any written comments in response to DNREC's and the Department of Agriculture's comments. On June 3, 2008, Mr. Lank was instructed by the Council to notify the Applicant and the spokesperson for the opposition, Stephanie Smith, once submissions were received from the two agencies. Mr. Lank noted that the letters to both agencies requested that responses be provided by August 1, 2008.

Mr. Lank reported that a response was received from Kevin F. Coyle, AICP, Principal Planner for DNREC, dated July 29, 2008 and thereafter, was distributed to the Council. Mr. Lank also reported that no response was received from the Department of Agriculture.

Mr. Jones announced that the public may view the DNREC Report in the Office of Planning and Zoning. Mr. Lank advised that the introduction of this Report into the record starts the 30-day response period.

Additional Business/ Daniel Kramer (comments) Under Additional Business, Daniel Kramer questioned if the County gives funding to the local SPCA. Mr. Kramer stated that they should not get any funding because they don't provide any services. Mr. Kramer also stated that, if the County is funding the State's Dog Control Program with Kent County SPCA, then the County should have control of the program.

Mr. Baker responded that a grant was given to the local SPCA in memory of a County employee. Mrs. Webb stated that they also receive Human Service Grant funding.

Additional Business/ Stephanie Smith (comments) Under Additional Business, Stephanie Smith commented on Conditional Use No. 1741 filed on behalf of David G. Horsey & Sons, Inc. She referenced that the record was left open for written comments from the Department of Agriculture and DNREC and she questioned the fact that no response has been received from the Department of Agriculture. Mr. Jones responded that the County can only ask for comments from outside agencies and that those agencies cannot be forced to respond.

Additional Business/ Ken Bock (comments)

(continued)

Under Additional Business, Ken Bock, Deputy Director of CHEER, commented on the Reimbursable Transportation Program funding which was previously acted on by the Council on this date. He emphasized that this is the sixth straight year that there has been no increase in transportation funding for the agencies in Sussex County. He referenced the increased cost of fuel and the fact that they continue to provide more and more transportation to an ever increasing senior citizen population. Mr. Bock stated that they provide transportation at one-third the cost per trip compared to the State-operated Para Transit System. He noted that the State has granted itself increases for fuel costs, insurance, utilities, etc. Mr. Bock asked that (1) the Council provide additional funds to CHEER and to the other agencies providing this transportation service and (2) that the State reconsider the funding in the next Fiscal Year so that the agencies do not continue to face flat-line budgets in future years.

Mr. Bock also asked for the Council's support of the Sussex County Mobility Consortium, a program in its second year of operation. This program coordinates existing resources from profit and non-profit organizations and volunteers to provide transportation services. The program currently provides transportation for over 1,000 people per month. Mr. Bock noted that the State did not continue its funding for this program and he asked the Council to provide funding to help support the continued operation of the Mobility Consortium.

Additional Business/ Corrina McAllister (comments) Under Additional Business, Corrina McAllister referenced Conditional Use No. 1741 filed on behalf of David G. Horsey & Sons, Inc. and a letter from Stephanie Smith, dated July 3, 2008, that was mailed to the Council asking for a response concerning House Concurrent Resolution No. 73 entitled "A REVIEW **BORROW** PIT TASK **FORCE** TO RULES **AND** REGUALTIONS IN THE STATE OF DELAWARE", which was passed by the House on July 1, 2008. Ms. McAllister questioned what effect the Council believes this will have and whether or not Council would be willing to wait on making a decision on Conditional Use No. 1741 until action is taken on HCR No. 73. Ms. McAllister stated that no response has been received from the Council. Mr. Griffin responded that the Council may choose not to comment until the Public Hearing record has been closed.

He stated that when a family chooses cremation, most of the member funeral homes must utilize the services of crematory locations in Lewes, Frankford, or Delmar in Sussex County; that the Zoning Ordinance provides that a Conditional Use is required for a crematory associated with a cemetery and requires certain setbacks from property lines; that the proposed building is 240-feet from the southerly property line and 370-feet from the chapel on site; that the closest building to the site is a chicken house approximately 3/4 mile away and that the closest dwelling is approximately 1 mile away; that the site is surrounded by other lands of the Melvin Joseph Estate; that the cremation rate in Delaware has grown by over 20%; that a need exists to serve the residents of the County with cremation services; that the use will not create any demand on County services; that pet cremation services would also be offered which would be separate from the human crematory; that the only additional traffic will be hearses; that the building will be in character with the buildings already existing in the cemetery; and that they have obtained the necessary DNREC permits for the crematorium.

John A. Cranston, a Funeral Director in Seaford; Dave Salmon, a Funeral Director in Dover, and George Short, a Funeral Director in Milton, were present in support of the application.

There were no public comments and the Public Hearing was closed.

Bishop Major Foster of Ellendale was present on behalf of the application. He stated that the application is for a Health Development and Crisis Center; that they have an existing shelter that house women for substance abuse, etc.; that the new site would be for young women who are pregnant; that pre-natal care would be provided; that they propose to provide a home for the young mothers and their babies for approximately 12 months after which time they propose to help them find a place to stay and raise their family; and that there is a need for this service in Sussex County as no similar facility currently exists.

Public comments were heard.

Elizabeth Williams, a resident of Georgetown, and David Kennedy of Oasis Homes and Development spoke in support of the application.

Mr. Baker presented a land acquisition proposal. He reported that the proposal is part of the County's plan to seek additional space for County offices. Mr. Baker reported that County offices are cramped and that the County recently leased space at the Tunnell & Raysor Building in Georgetown for the Clerk of the Peace Office and offices for some Engineering staff. Mr. Baker reported that Studio JAED completed a Space Needs Analysis in May 2007 and they recommended the construction of a 50,000 to 100,000 square foot building. Mr. Baker advised that the first step is to acquire property and he reported that a 29.6 acre parcel is available on the outskirts of Georgetown at the E. Trap Pond Road and Route 113 intersection.

Mr. Baker stated that the benefits of the site are: easy access to the site for the public and employees, sufficient parking, room for future expansions, and that most services could be available at this one location. It is proposed that the County would maintain a presence on The Circle in Georgetown, e.g. Clerk of the Peace and Register of Wills offices.

Mr. Cole expressed concern about the current economic environment and the fact that some of the County's income sources are down. He stated that he feels the County should tighten its belt and address this land acquisition proposal another time. He stated that three members of the Council have announced that they will not be seeking another term and therefore, will be leaving in January. He stated that he does not support shackling a new Council with this land purchase since a new Council may choose not to construct a new building and then, the County would be left with vacant land. He noted that this is a very large purchase and the County may have other financial needs in the future. Mr. Cole emphasized that he does not support the acquisition at this time.

In response to questions raised by Mr. Cole, Mr. Baker advised that the County has set aside \$14 million in the Capital Improvement Fund for this project.

Mr. Phillips referenced the County's \$2.7 million deficit in 2007 and its current \$3.8 million deficit; that when the County has a deficit, it has to utilize its reserves; that we are currently in a recession; that he is not convinced this is something the County needs; and that additional office space was recently leased to help relive the County's space needs.

Mr. Dukes stated that the County's Administrative Office Building was opened in 1996 and that the County has already outgrown the building; that parking is a problem; that departments are spread throughout Georgetown; that the County needs to start planning now; that the County needs to get control of some land now; that the original price of the property was \$4.2 million and that the price is now down to \$2.4 million; that the location is prime; and that the purchase of this property would be an investment for the future of Sussex County.

Mr. Rogers stated that the Council and staff have been discussing land acquisition for a new Administrative Office Building for over a year; that there has been a substantial drop in the price of the property; and that it is time to make the purchase for the future of Sussex County.
