Council discussed Conditional Use No. 1457 entitled, "AN ORDINANCE TO GRANT A CONDITIONAL USE OF LAND IN AN AR-1 AGRICULTURAL RESIDENTIAL DISTRICT FOR PUBLIC GOVERNMENTAL BUILDING AND USE (REPLACEMENT OF DEPARTMENT OF MOTOR VEHICLES BUILDING) TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN GEORGETOWN HUNDRED, SUSSEX COUNTY, CONTAINING 31.53 ACRES, MORE OR LESS (Conditional Use No. 1457) filed on behalf of State of Delaware, Department of Motor Vehicles.

The Planning and Zoning Commission held a Public Hearing on this application on June 27, 2002, at which time it was their recommendation that the application be forwarded to the Sussex County Council with the recommendation that the application be approved with the stipulation that the site plan be subject to review and approval by the Planning and Zoning Commission.

The Sussex County Council held a Public Hearing on July 16, 2002, at which time the Public Hearing was closed and action deferred for a period of two weeks to allow for the exchange of correspondence between Sussex County and the Department of Motor Vehicles to see if there would be any interest by the State in investigating the feasibility of locating a facility on the east side of Sussex County to serve that area. The record of the Planning & Zoning Commission was incorporated into the record of the Council's Public Hearing.

Mr. Stickels distributed copies of a letter dated September 4, 2002 from Michael Shahan, Director of the Division of Motor Vehicles (DMV). Mr. Shahan's letter was in response to an August 2, 2002 letter from Mr. Stickels on behalf of the Council. Mr. Stickels reviewed highlights of the letter. The construction of a DMV facility, located on the eastern side of the County, was a stated need expressed by the County in September 1998 during DelDOT's public hearings for capital improvement recommendations. Mr. Shahan's letter stated the Division's agreement with many of Council's concerns, namely the need for a DMV facility on the eastern side of the County, as well as for additional staffing and expansion of services, but, they are, nonetheless, hindered by budgetary constraints.

Airport Terminal Building/Supplemental Agreement/ French + Ryan

Mr. Sapp, Project Engineer, presented Council with a cost summary for French + Ryan, the architects for the Sussex County Airport Terminal Building. In particular, Mr. Sapp made note of a May 9, 2002 letter from Alvin French, Vice President of French + Ryan, and also a copy of "Amendment to the Professional Services Agreement", Amendments No. 2 and No. 3. Amendment 2 reflects the kitchen changes requested by the Owner (\$4,615) and by Jimmy's Grill (\$16,615). Amendment No. 3 reflects the additional Construction Administration hours spent by French + Ryan (not to exceed \$15,000).

Council expressed concern regarding the additional architect fees and discussed the legal/arbitration options available to the County. Mr. Stickels mentioned that the County made several attempts to negotiate with French + Ryan for the additional costs incurred for construction administration, however, these attempts were unsuccessful. Mr. Bayard advised Council that attempts at arbitration, in his opinion, would "not" be economically wise.

Delaware Agricultural Lands Preservation Program

Mr. Stickels introduced Ms. Wendy Baker, President/CEO of the Sussex County Land Trust. Ms. Baker informed Council that during a regular meeting of the Sussex County Land Trust on August 27, 2002, the Board of Trustees voted unanimously to seek County Council's approval to participate in the Delaware Agricultural Lands Preservation Program up to \$500,000, of the \$1,000,000 of County funds pledged (by Ordinance No. 1537), predicated by matching private funds. Ms. Baker explained that while the board is aware that farmland preservation is not their only role, they think this program is an excellent way to leverage money for open space preservation. The Board of Trustees also likes the system in place by the Agricultural Foundation of landowner-discounting below the appraised value, thus being able to preserve more open space.

Ms. Baker introduced Michael Parkowski, of Parkowski & Guerke, legal counsel for the Delaware Agricultural Lands Preservation Foundation. Mr. Parkowski was in attendance to explain the program and answer questions. Council was presented with a handout written by Mr. Parkowski, detailing the "Agricultural Lands Preservation Easement Purchases, Foundation-County Match Program". The enabling legislation for Delaware's Ag Land Preservation Program came into existence in 1991, but wasn't funded until 1995. For those landowners/farmers who

want to enroll their property into the program, an application is submitted and then reviewed under the "LESA" (Land Evaluation Site Assessment) scoring system, which is a nationally recognized system for determining the value of agricultural lands. To date, approximately 135,000 acres in Delaware have been enrolled in the program, out of a statewide farmland total of nearly 500,000 acres. Once the property has been in the program for 10 years, that property then becomes eligible to sell their development rights/Preservation Easement. Since 1995, \$67.6 million has been expended for purchase of Preservation Easements for over 65,000 acres, which is less than \$1,100/acre. Currently, there are 169 landowners, throughout the State, who have applied to sell their development rights, of which 79 are located in Sussex County. The method to select the properties, the LESA system, ensures the participants that decisions are not politically motivated and maintains the integrity of the process. The program is currently in its 8th round of purchases, with the previous 7 rounds providing an average discounting in the range of 42 percent. Out of the \$67.6 million that has been used to purchase development rights, \$65 million has been provided by the State of Delaware. This year, for the first time, Delaware's appropriation of \$5,000,000 comes with some additional provisions. One of those provisions is that the counties are entitled to contribute matching monies, up to \$1,000,000 each. This, in turn, would guarantee that the purchase of the Preservation Easements, with those matching monies, would take place in the counties that are participating. Any funds not matched would be utilized by the Foundation for statewide purchase of Preservation Easements. The Foundation would prepare a list of offers received in each county and present the list to each County who chooses to participate in the Matching Program. Under the Bond Bill language, there must be a mutual agreement between the County and the Foundation regarding Preservation Easements purchased in the County with the matching funds. The Foundation proposes that for Foundation-County matched funding, a County may have a Preservation Easement placed on a property in their County which is not among the highest discounted properties; provided, however, those property owners who have provided higher discounts, but were not selected, are notified of the County's decision.

Mr. Phillips commended the Foundation due to the complexity of the issues involved in the program. Mr. Phillips also stated his concern regarding a change in the selection criteria that occurred several years ago, which resulted in certain geographic locations being specifically targeted.

Mr. Cole mentioned that he thought people would like targeting a certain road, Rt. 9 or 404 for example, and protecting those areas. Mr. Cole stated his concern that open space and farmland preservation are not the same, and that the public is not benefited by farmland preservation. Mr. Cole also expressed concern as to the loss of equity to the present landowner, or future generations, in terms of acquiring loans, etc. Mr. Cole stated that farmland could also be preserved thru zoning.

Preston Schell, Vice Chairman of the Sussex County Land Trust, spoke to Council regarding matching private funds and the fact that he felt that private funds could most likely be raised to match the County's participation up to \$500,000. Dennis

(Con't.) Forney, member of the Sussex County Land Trust, expressed his belief that the Program presented to Council was a wonderful opportunity, and expressed his hope that the County would, in deed, vote to participate.

Mr. Parkowski stated that the Foundation would like to know of the County's intent to participate in the Delaware Ag Lands Preservation Program's Foundation-County Match Program by November 1, 2002. Ms. Baker stated that it was the Land Trust's hope that the County would state their intent to participate, or providing matching funds, up to \$500,000.

Mr. Stickels stated that this item will be placed back on the agenda in two weeks, or October 8, 2002. Mr. Stickels requested that the Land Trust Committee hold a full meeting prior to October 8, coming back to Council with some indication as to matching funds possibly available thru the private sector.



Business Mr. Daniel Kramer expressed his concern in using tax dollars to pay farmers to preserve their farmland.

Falun
Dafa Dr. Lei spoke to Council regarding Falun Dafa and thanked Council for its passage of a Proclamation in 2000 proclaiming the week of December 4-10, 2000 as "Falun Dafa Week". In a pamphlet provided by Dr. Lei, Falun Dafa is "a traditional Chinese self-cultivation practice that improves mental and physical wellness through a series of easy to learn exercises, meditation and development of one's 'Heart/Mind Nature'. The practice is based on the universal principles of Truthfulness-Compassion-Forbearance." Dr. Lei stated that it was his hope that Council would authorize the passage of a second Proclamation honoring October 7-11, 2002 as the Second Delaware Falun Dafa Week.
