Emergency Joseph Thomas, Director of Emergency Operations, provided an update

Operations Center Update

regarding dispatching from the Emergency Operations Center. During the period from October 19 until October 27, six Kent County dispatchers have been taking Kent County 911 calls at the Sussex County Emergency Operations Center. They are receiving calls at the Sussex County Emergency Operations Center on a temporary basis while their software and hardware are upgraded. Mr. Thomas reported that Kent County's software update will bring them up to the same level as Sussex County's.

Emergency Operations Center (continued)

This software update allows back-up for the centers in all three counties and in the event of a catastrophic event, one center could transfer its operations to another center. Mr. Thomas noted that Sussex County's first back-up is the Seaford 911 Center due to its close proximity.

Manufactured Housing Tax Plan Update

Mr. Baker reported that County staff met with representatives of the school districts in Sussex County to discuss ideas to improve tax collection efforts for specific classes of manufactured homes. Katrina Mears, Collections Manager, presented the proposal that was previously presented to the school districts. The goal of the meeting with the school districts was to define the current situation; present a standard proposal for resolution; discuss a specific scope of authority for the County; obtain the school districts' agreement; and implement the process.

Ms. Mears reported that manufactured homes in parks and 'on the lands of others' represent the biggest challenge in collecting past due property taxes; that sales of mobile homes are not as stringently managed as land sales; and that many of these homes have accumulated back taxes over a number of years.

Ms. Mears presented the proposal for resolution: grant the County the authority to act on the resolution of uncollectable property tax for manufactured homes in parks and manufactured homes on the lands of others within a specific and documented scope.; resolution options would be handled on a case-by-case basis according to the procedure. Ms. Mears reviewed the proposed scope of authority: allow the County government the authority to make decisions regarding the resolution of outstanding taxes when one or more of the following situations occur:

- 1. Manufactured home is abandoned in park or on the lands of others.
- 2. Manufactured home can be re-sold to a new owner with partial waiver of penalty due or complete waiver of penalty due.
- 3. Manufactured home is in such a state of disrepair (and meets item 1 condition) that demolition is the only option.

Ms. Mears reviewed proposed future efforts:

Park owners are concerned with removing old, uninhabitable homes,

demolishing them or remarketing them in an effort to attract new tenants.

- The County is working with park managers to review homes that may meet these conditions and to brainstorm ideas on how to prevent future problems. Some parks now require a copy of the title before a lease can be granted.
- The County is exploring the possibility of possible State legislation that would require park owners to obtain a copy of paid property tax at each lease renewal.

Manufactured Housing Tax Plan Update (continued)

• County staff is diligently reviewing tax records and past due properties to ensure unpaid taxes do not reach this stage in the future.

Ms. Mears reported that the school districts were asked to sign a Letter of Agreement indicating a district's approval for the County to move forward. To date, two school districts have responded. It was noted that many of the districts have not responded yet due to the fact that their boards have not yet met to consider and vote on the proposal.

Mr. Moore made a suggestion for potential legislation – to explore the possibility of working with the Division of Motor Vehicles so that any time a title is transferred on a mobile home, that they require evidence that the County taxes are paid.

Mr. Baker read the following information in his Administrator's Report:

1. Airport Advisory Committee

The Sussex County Airport Advisory Committee will be meeting on Wednesday, October 27, 2010, at 7:00 p.m. at the Sussex County Emergency Operations Center in Georgetown. Attached is a copy of the agenda for the upcoming meeting.

2. Sussex County Prescription Drug Discount Card Program

Attached is a report for the Sussex County Prescription Drug Discount Card Program including activity through September 2010. As per this report, users of the discount card received discounts totaling \$19,974 during September; 337 prescribed drugs were issued through this program during the month. The card is available at the County Administrative Office Building and various other locations for anyone to use.

3. Sussex County Election Year Scholarship Contest

Sussex County reminds students and parents of the Election Year Scholarship Contest. The contest is open to any student, kindergarten through 12th grade, who is from the County and

attending school. Each participant is asked to predict the outcome of elections here in Sussex County and across Delaware. The student with the most correct guesses will win a \$200 scholarship, while five runners-up will each win a \$100 scholarship.

Mrs. Webb presented proposed Loan Resolutions for the Inland Bays Regional Wastewater Treatment Facility (\$10,475,000) and the South Coastal Regional Wastewater Facilities Pump Station No. 30 and Force Main (\$6,400,000). Mrs. Webb explained that, on June 8, 2010, the Council approved a Resolution to allocate Recovery Zone Economic Development Bonds in the amount of \$16.6 million to be used on these County projects. One of the requirements was to close the bond issues by December 31, 2010 in order to receive the credit; when a debt service payment is made, the County will receive 45 percent back on the interest amount for these bonds as part of the Stimulus Package. The bonds will be funded by Rural Development. Mrs. Webb noted that ordinances to authorize the debt have already been approved for these projects; however, Rural Development also

Proposed Lease Renewal/ Paramedic Station 106 Bob Stuart, Director of EMS, presented a proposal to renew the Lease Agreement with Mid Sussex Rescue Squad, Inc. Sussex County Airport/ Rehabilitate Crosswind Runway 10-28 Project Michael Izzo, County Engineer, presented information on the close-out of Sussex County Airport 10-28 Project (Rehabilitate Crosswind Runway, 10-28, Phase IV). The General Contractor for this project was Dixie Construction; a Notice to Proceed was issued in August 2007. Tilcon, Inc. was the paving subcontractor. Mr. Izzo reported that one of the requirements of the project was that the contractor had to put down a test strip of pavement prior to commencing with the full pavement on the runway. Tilcon put down seven test strips and none of the test strips received approval; thereafter, the weather conditions changed and did not permit further paving in the Fall of 2008 and a Stop Work Order was issued. In May 2009, the contract was restarted. In the interim, Tilcon had gone into bankruptcy and the company was bought out by American

Infrastructure. The test strip process was performed again by American Infrastructure and by August 2009, all of the pavement had been put down and the runway was opened.

Mr. Izzo explained that Delta Airport Consultants, the Construction Administrator for the project, performed inspection services. Mr. Izzo proposed a final Contract Amendment in the amount of \$39,995.00 resulting from the time overrun of the extra work.
