## of State Planner Bryan Hall

Holland, Director of the Office of State Planning Coordination, who then introduced Bryan Hall. Mr. Hall recently took the position as Circuit-Rider Planner for Sussex County. Mrs. Holland advised that Mr. Hall would be working with the County and the municipalities in Sussex County to provide guidance, resources and coordination for their Comprehensive Land Use Plan Updates.

Mr. Godwin presented a Proposed Ordinance which would create a fee for the inspection and approval of foundation footers and tie downs for manufactured homes in order to insure that such housing units are installed on a secure foundation and properly tied down to the foundation in order to make them less likely to be damaged and/or destroyed by the effects of high winds and/or flood waters associated with hurricanes and other violent weather patterns which may occur in the coastal and inland areas of the County.

Mr. Godwin explained that the Proposed Ordinance would provide for three inspections: one for the footer foundation, one for the tie-down, and a third inspection, if needed. The charge for the three inspections is proposed to be \$125.00; if additional inspections are needed, a \$40.00 fee for each additional inspection is proposed.

Mr. Godwin explained that the Delaware General Assembly enacted legislation requiring all Counties in Delaware to begin conducting inspections of foundation footers and tie downs for manufactured homes effective January 1, 2007 (Senate Bill No. 203).

Mr. Rogers introduced the Proposed Ordinance entitled ORDINANCE TO GRANT A CONDITIONAL USE OF LAND IN AN AR-1 AGRICULTURAL RESIDENTIAL DISTRICT FOR LAND APPLICATION OF SLUDGE, **TREATED SLUDGE** OR ANY **THESE CONTAINING** MATERIAL **MATERIALS** BY **SPRAY** IRRIGATION TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN BROADKILL AND CEDAR HUNDREDS, SUSSEX COUNTY, CONTAINING 1,739.779 ACRES, MORE OR LESS" (Conditional Use No. 1725) filed on behalf of Harry Isaacs, Jr. The Proposed Ordinance will be advertised for Public Hearing.

Additional Business

Under Additional Business, Dan Kramer commented on the Council's donation to St. Jude Children's Research Hospital. He questioned who the check would be made payable to and if it is known how much of the donation would go to St. Jude and how much would go to the paid professional fundraiser.

Mr. Kramer told the Council that when Council votes to go into Executive

Session, they are officially in Executive Session and they should go directly into that Session, without talking to anyone.

Public Hearing (C/U No. 1667) (continued)

Richard Kautz, Land Use Planner, reported that the Planning and Zoning Commission held a Public Hearing on the application on October 12, 2006 at which time they deferred action; on October 26, 2006, the Commission recommended that the application be denied.

(See the minutes of the meeting of the Planning and Zoning Commission dated October 12 and 26, 2006 for additional information on the application, correspondence received, the Public Hearing before the Commission and their recommendation of denial.)

Mr. Kautz, Director of Planning and Zoning, read a summary of the Commission's Public Hearing. The summary was admitted as part of the Council's record.

The Council found that Douglas Hitchens was present on behalf of his application. He stated that he has done some research since the Public Hearing before the Commission and he referred to the other commercial establishments along Route 18 including Elmers Market, a nursery, an auto repair business, Short's Trucking, a produce stand, and a tractor-trailer maintenance building. He stated that he selected the site since he already owns the land and that he lives on the site; that he owns 30+ acres; that he would like to purchase the adjacent 2 acres; and that the landowner is in the process of selling the 2-acre parcel and that she has already contacted him to see if he is interested in purchasing it.

In response to questions raised by the Council, Mr. Hitchens stated that restricting the number of cars to 15 would be acceptable to him; that he would agree to a condition that all of the vehicles would be 1990 models or newer, and that he would agree to landscaping and buffer requirements.

Dan Kramer spoke in support of the application.

There were no additional public comments and the Public Hearing was closed.
