Town of Georgetown/ Payment in Lieu of Taxes

Mr. Stickels advised that each year the County's budget includes a payment in lieu of taxes to the Town of Georgetown to offset lost revenues for properties the County owns. A check in the amount of \$5,464.00 was presented to Town Manager David Baird for this year's payment. This amount reflects a three percent increase over last year's payment.

Administrator's Report

Mr. Stickels read the following information in his County Administrator's Report:

1. Veterans Day

Sussex County government offices will be closed Monday, November 12, 2001, to allow employees to observe Veterans Day. County offices will reopen at 8:30 a.m. on Tuesday, November 13, 2001. A County Council meeting will be scheduled on that date at 10:00 a.m.

2. Christmas Festivities/Parades

Included with this report for Council's convenience is a list of Christmas festivities and parades scheduled for Sussex County and some areas in Maryland. Please note that Caroling on The Circle will take place on Monday, December 3, starting at 6:30 p.m. Caroling on The Circle is the County's largest food-raising activity.

3. Sussex County Emergency Operations Dispatch Center

I am pleased to inform the Council that the Sussex County Emergency Operations Center Fire and Ambulance Callboard has received notification from the National Academy of Emergency Medical Dispatch that the Center is now recognized as a **Center of Excellence**. An accredited **Center of Excellence** is one that shares a common goal with the National/International Academy of Emergency Dispatch to improve patient care and maximize efficiency of Emergency Medical Service systems. The **Center of Excellence** accreditation is the highest recognition by the Academy for Emergency Medical Service Dispatch Centers that have demonstrated superior patient care standards and efficient resource utilization.

The Sussex County Emergency Operations Center has been using the Medical Priority Dispatch System since February of 1995. Each of the dispatchers is trained in the dispatch system, along with CPR and the use of an automated external defibrillator (AED). The Center was recognized as a Training Site with the National Academy of Emergency Dispatch in March 2000.

The Sussex County Council will recognize Callboard employees at a luncheon at the Emergency Operations Center on Tuesday, November 27, 2001.

4. Proposed Miller Creek Sanitary Sewer District

A referendum will be held on the proposed Miller Creek Sanitary Sewer District on Saturday, December 8, 2001, between 8:00 a.m. and 2:00 p.m. at the Lord Baltimore School, State of Delaware Route 26, Ocean View, Delaware. Included with this report is a copy of the "Notice of Referendum."

5. DelDOT Public Workshop

Sussex County to present the U.S. Route 13 Corridor Plan, which includes proposed improvements as part of the U.S. Route 13 Corridor Capacity Preservation Program. The workshop will be held on Tuesday, December 4, 2001, from 4:00 to 8:00 p.m. at the Seaford Middle School, 500 East Stein Highway, Seaford. The workshop will serve as a forum to learn how DelDOT proposes to preserve the ability of U.S. Route 13 to handle increasing traffic volumes and accommodate development well into the future. DelDOT planners and engineers will be available to answer questions related to specific transportation or development issues related to the program.

The Senior School Property Tax Credit Program is a State program administrated through the Sussex County Tax Division. Sussex County residents over the age of 65 may apply for a 50 percent tax reduction up to \$500.00 for their school taxes. The \$2,205,667.69 is a 13.75 percent increase in payment over the previous year.

I would like to compliment the County's staff for the extra effort they have given in administrating this program.

7. Proposed Millville/North Millville Expansion of the Bethany Beach Sanitary Sewer District

The Sussex County Engineering Department is conducting a meeting on Saturday, November 10, 2001, at 9:00 a.m. at the Millville Fire Hall, Route 26, Millville, Delaware. The purpose of the meeting is to receive input on a proposed expansion of the Bethany Beach Sanitary Sewer District to serve the Millville/North Millville area and to assess interest and discuss potential boundaries of the service area.

8. Ruth Timmons

It is with regret that I inform the Council that Ruth H. Timmons, a County pensioner, died on Thursday, November 1, 2001. Mrs. Timmons was employed by the County in the Data Processing Department from January 3, 1972, until she retired on December 31, 1986, with 15 years of service.

Proposal Regarding Providing Limited Property Tax Information on the Internet	Mr. Baker presented for Council's consideration a proposal to provide limited property tax and assessment information on the internet. The benefits of such a proposal would be a reduction in man-hours, phone inquiries, and traffic in the building. An additional benefit would be that the information would be available to the public 24-hours a day. Mr. Baker advised that a Committee was formed to investigate providing this service. The Committee estimates spending \$14,000 on the project, which includes the necessary software and the hiring of a computer security consultant to ensure that the County's sensitive data is protected from hackers. Mr. Baker acknowledged that the County's number one concern is the security of information. Mr. Baker advised that numerous disclaimers would also be added to the website so that the County cannot be held liable for any incorrect data. Sussex County would be the first county in Delaware to provide this service.

Mr. Stickels read the eight conditions proposed at the meeting held on October 23, 2001. Mr. Dukes expressed concern that additional fencing should be required to prevent children from walking off the site and to keep intruders out.

4. The site plan shall be subject to review and approval by the Planning and Zoning Commission.
5. The Cape Henlopen School District shall execute a Memorandum of Understanding for sanitary sewer service from the West Rehoboth Extension of the Dewey Beach Sanitary Sewer District.
6. All entrance and roadway improvements required by DelDOT shall be completed by the applicant.
7. The State of Delaware Historic Planning Office shall have reasonable access to the site to identify the location of the Fisher House as long as the review does not impede the progress of the construction of the school.
8. All necessary County, State and Federal permits shall be secured before construction is undertaken.

Findings  
of Fact

The Council found that a conditional use for a public school was appropriate legislative action based on the following findings of fact:

1. A conditional use is appropriate for this parcel of land. Conditional uses are generally of a public or semi public character and are essential and desirable for the general convenience and welfare of the residents of Sussex County.
2. A public middle school provides education to the children of the district being an essential and desirable service.
3. The need for the middle school was determined by a detailed review involving public participation and comment. Two new middle schools were designated as the top priorities of the school district; one school to be located in the northern part of the district and one in the south.
4. A determination was made that the proposed southern school be located west of Route 1 and between Routes 24 and 9. Such an area would provide a central location for the area and would insure that no child would be bussed over 7 miles.
5. Proposals were requested from landowners and realtors and the subject parcel was determined to be the most appropriate location.
6. A referendum was held by the school district to approve financing for the proposed improvements which passed by a vote of 69% in favor.
7. The conditional use is in substantial conformance with the Comprehensive Land Use Plan in that:
  - A. It is adjacent to the development district. While all land south of Route 24 between Route 1 and Oak Orchard is designated as a development district, the parcel in question is an exception. Whether this was an oversight on the Land Use Map or not is not relevant since the site is surrounded by land in the development district and provides a central site to serve these areas.
  - B. There are no negative environmental effects and the conditional use will provide significant benefits and employment.
  - C. The conditional use is in accordance with the development anticipated by the plan, which recognizes that development should be concentrated in those areas where central water and sewer are available and the

conditional use will provide educational infrastructure to serve the development.

D. The Applicant has shown that the proposed use is appropriate and in conformity with the Plan and the intent of the Land Use Map. The request promotes the health, safety, morals, convenience, order, prosperity and general welfare based on the evidence and testimony presented including the following.

1. Adequate fire and police protection are available nearby.
2. The project is located in an area which is appropriate for the conditional use in that it is centrally located to the growing residential areas.
3. That adequate central water and public sewer facilities are available and that there will be no adverse impact on nearby properties. The site will be served as part of the Sussex County Sewer System.
4. That adequate utility services, medical facilities and shopping areas are available nearby.
5. That the character of the existing area is mixed commercial/residential and that the site is suitable and appropriate for the proposed use, and does not appear to have any adverse impact on property values, nearby property uses or natural resources.
6. That nearby residential uses will be buffered by landscaping and storm water facilities.
7. That traffic will not be adversely affected in that the peak traffic volume is on weekends during the summer when the school is not in session.
8. That appropriate entrance and turn lanes will be constructed to provide for safe access to the school.
9. That the findings and conclusion stated herein are based on substantial evidence comprised of the reasons stated above, the testimony and evidence presented by the applicant and the findings of the Planning and Zoning Commission's recommendation of approval.

Holts Landing Sanitary Sewer District Update	Mr. Archut, Assistant County Engineer, updated the Council on the Holts Landing Sanitary Sewer District. On Thursday, November 1, 2001, a settlement was held and an Agreement reached whereby the County would take over the collection system from Utility Systems, Inc. (USI). The Agreement provides for the transfer and assignment of wastewater facilities to Sussex County for the Bay Colony subdivision, the Cripple Creek subdivision, Cripple Creek Country Club, and the Fairway Villas Condominium. Mr. Archut advised that a walk-through of the wastewater facilities was conducted by the County and the County is now operating the system. The Engineering Department has asked its consultants, Whitman Requardt and Associates, LLP, to prepare a proposal to develop plans and specifications for the upgrades and repairs that are necessary. The proposal will be presented to Council at a later date. Mr. Archut advised that a budget of \$1.3 million is available to perform the necessary upgrades. No action was required by Council.
Ocean View Expansion/ Change Orders	Mr. Izzo, County Engineer, presented two change orders to the Ocean View Expansion of the Bethany Beach Sanitary Sewer District Project. Mr. Izzo advised that construction was completed on approximately September 1, 2001; however, several paperwork items exist to closeout the project. Change Order No. 3, in the amount of \$3,220.00, is for isolation valves for homes in the Town of Ocean View. Change Order No. 4, in the amount of \$35,750.00, is for extending sewer lines for the connection of the Lord Baltimore School to the District.
