Mr. Baker introduced Col. Thomas MacLeish of the Delaware State Police. Mr. Baker announced that the County has budgeted \$1,413,000 in Fiscal Year 2007 for 32 additional State Police officers in Sussex County (which is in addition to the State's allotment).

Mr. Baker introduced Col. Thomas MacLeish of the Delaware State Police. Mr. Rogers presented to Col. MacLeish a check in the amount of \$460,000.00 which represents the first quarterly payment for Fiscal 2007, paying salaries and benefit costs from July 1 through September 30, 2006, as well as seven new police vehicles.

Col. MacLeish thanked the County Council for its partnership with the Delaware State Police and its commitment to the citizens of Sussex County.

Administrator's Report Mr. Baker read the following information in his Administrator's Report:

1. November 22 and 23, 2006 – Northeaster Storm

On November 22 and 23, a northeaster storm resulted in coastal flooding in some areas of the County, including Oak Orchard, Long Neck, South Bethany, Bethany Beach, and Dewey Beach. The storm did not result in major damage to property, although flooding of various roads, especially at high tides, resulted in an inconvenience for residents.

2. <u>Community Development and Housing Public Hearing and Meeting</u> Dates

Included with this report is a list of 15 public hearings and meetings that will be conducted by the County's Community Development and Housing Division. Council members may choose to attend the hearings that are held in their jurisdiction.

3. <u>Caroling on The Circle</u>

On Monday, December 4, 2006, the 23rd Annual Caroling on The Circle event will be held. Cookies and hot chocolate will be served afterward at the Georgetown Fire Hall. As in the past, canned goods and nonperishable food items are being collected to help the needy.

4. Annual Mildred King Christmas Luncheon

The annual Mildred King Christmas Luncheon will be held on Tuesday, December 5, 2006, from 11:30 a.m. to 1:30 p.m. at the Georgetown CHEER Community Center. This is an annual Christmas luncheon for County employees. County offices will be closed during that two-hour period.

5. **Catherine Jones**

We regret to announce that Catherine Jones, a County employee, Wastewater Operator III, passed away on November 1, 2006. She worked at the South Coastal Regional Wastewater Facility for the County from January 2, 2001, to November 1, 2006.

Proposed Resolution/ **Economic Develop**ment Stimulus Loan Program/ City of Seaford

Mrs. Webb presented a Proposed Resolution authorizing a loan of up to \$250,000 to the City of Seaford pursuant to the Sussex County Government **Economic Development Stimulus Loan Program.**

Mrs. Webb explained that the City of Seaford has applied to the County for a \$250,000 loan for the construction of a concession stand at their Sports Complex. Mrs. Webb advised that the City's application was in accordance with all the requirements of the Program. The County's Loan Committee found that this project would provide a public benefit; that the debt service would be payable from the revenues of the project or from other sources; that the loan would be backed by the full faith and credit and taxing powers of the City of Seaford; and, that it is an eligible project under the terms of the Program requirements.

Mrs. Webb noted that all municipalities are eligible to participate in this Loan Program provided their projects meet the eligibility requirements.

Placement Mr. Griffin explained that the Delaware General Assembly enacted

of Manufactured Homes legislation requiring all Counties in Delaware to begin conducting inspections of foundation footers and tie downs for manufactured homes effective January 1, 2007 (Senate Bill No. 203).

Mr. Baker reported that the County has nine employees that are currently in training to become certified to perform the inspections. Mr. Baker explained that the purpose of the Proposed Ordinance is to establish a fee to cover the costs of the inspections. He noted that the inspections of the foundation footers and tie downs for manufactured homes will help insure that the housing units are installed on a secure foundation and properly tied down to the foundation in order to make them less likely to be damaged and/or destroyed by the effects of high winds and/or flood waters associated with hurricanes and other violent weather patterns.

Mr. Baker explained that the Proposed Ordinance would provide for three inspections: one for the footer foundation, one for the tie-down, and a third inspection, if needed. The charge for the three inspections is proposed to be \$125.00; if additional inspections are needed, a \$40.00 fee for each additional inspection is proposed.

Eddy Parker, Director of Assessments, and Andy Wright of the Building Code Department were present to answer any questions raised during the Public Hearing.

Public comments were heard.

Dan Kramer raised several questions regarding the Proposed Ordinance: (1) how will an inspector know if the tie-down meets the depth requirements and (2) there is nothing that specifies how deep the footer has to be.

Mr. Parker responded that foundation plans have to be submitted in compliance with the manufacturer's standards.

There were no additional public comments and the Public Hearing was closed.

Michael Izzo, County Engineer, presented a proposal to acquire land for the

proposed extension of the main runway at the Sussex County Airport. He advised that the property is owned by Wenona L. Weaber (Tax Map and Parcel Number 1-35 20.00 51.03) and that it currently consists of a single family home on approximately 9 acres. He noted that the location of the property is just about center-alignment with the main runway. Mr. Izzo also noted that FAA requirements dictate that the County is to control all property under the Runway Protection Zone.
