- Independent Library funding formula update. County formula change: explanation and formula understood + accepted. Human data entry essential to capture program data and lessen funding piece based on circulation. Motion by Mary Schwanky; second by Diana Young.
- O Independent Library Group update. Refer to attached agenda. 1) Sussex Comprehensive Plan notes libraries in 2 areas. Asked County Administration about Liveable DE's library/school components. They were unclear. Focuses primarily on roads and access to Route 1, etc. now. 2) Independent Library Group, Lib Admin and System directors want an alternate ways to meet (e.g.: Zoom, Adobe Connect)
- Department of Libraries update. 1) budget presentation needs assessment will not be funded. 2) Milton's bulkhead may cost \$250,000 3) security guards have proven
- Department of Health + Social Services partnership. March Governor Carney's
   Social Service Month proclamation at Wilmington Library; successful launch DHSS
   wants to place a worker in every library. Some pushback -Dover City Councilman
   concerned that this pulls in more/provides a place for the homeless. Currently in
   Frankford, Selbyville and Seaford. Georgetown said no. Milton in line.
   Arrangements underway before discussion with County Librarian or library
   director. Formal meeting later in May to reiterate protocols and establish
   guidelines/mutual benefits for future partnerships.
- Upcoming Department of Labor partnership. See above. Note that during Broadband Technology Opportunity Program (BTOP) grant in the first 5 years of the Great Recession, DOL abandoned their One Stop Shop sites and sent job seekers to the public library. Meeting with Annie Norman on May 29, 2018 for facilitated discussion of partnership between DDL and the public libraries.
- Sussex County Children's Book Festival update. Awaiting final logo components.
   Kathy is to contact potential partners. Karen Johnson will then reach out to sponsors. All are adding author suggestions to a Google document.
