**RE:** Survey being conducted by the University of Delaware relative to transportation (accessible at <u>www.surveymonkey.com/r/coordinating specialized transportation</u>) and advising of an opportunity to join a working group to coordinate transportation services in Delaware.

#### Guest Speaker

Scott Phillips introduced Laurie Corsa, Veterans Service Officer, Delaware Commission of Veterans Affairs, who was invited to speak on *"Services Offered to Veterans in Sussex County."* Ms. Corsa provided an overview on how the Commission can help veterans access benefits through the Veterans Affairs office. Ms. Corsa explained that one of the programs established by the Department of Veterans Affairs to assist veterans in receiving medical services within their community is the Choice Program. Individuals who live outside of an 80-mile radius of a veterans facility can apply through the Choice Program to receive services closer to home. There is an application that must be filled out and approval is not guaranteed, but the Commission can help veterans with this process. Ms. Corsa also noted that the Delaware Veterans Memorial Cemetery located at 26669 Patriots Way in Millsboro, adjacent to the Stockley Center, is available to veterans and their spouses.

Several attendees expressed concerns, and some displeasure, regarding benefits available to veterans. Individual experiences with the Veterans Affairs office were shared as well.

Ruth Ann Beideman reported that the Advisory Committee has developed a survey to be completed by attendees at the close of each meeting. The survey is intended to provide (1) feedback regarding the meeting's subject matter, and (2) suggestions for future meeting topics. The survey was approved as proposed.
