  - **At July's meeting, we will talk about possible speakers for next year.**
- **Jamie Magee reiterated that our Conference will be held on May 11, 2023, from 9-2 at Crossroad Community Church.**
- **Jamie Magee reported that Max Baxter from Social Security has just announced offices are starting to re-open for in-person visits. She receives regular emails from his office, which are very informative.
