Call to Order

Sally Beaumont, Subcommittee Chair, called the meeting to order at 12:00 noon.

Approval of Agenda

Planning for Annual Conference

• Sally Beaumont stated that at the June meeting it was decided that giving Southern Delaware Tourism time at the end of the day for a short presentation did not offer them sufficient opportunity to effectively present all of the exciting information they could, nor did it give a fair amount of time for questions from participants.

- Judy Lodge, CHEER Community Center, distributed copies of the layout for this year's conference and explained how the setup would look. Discussion took place regarding the layout and the use of eight-foot or round tables. There will be 22 long tables inside of the conference room for vendors, with a maximum of eight long tables in the hallway.
