Call to Order

Ruth Ann Beideman, Subcommittee Chair, called the meeting to order at 11:30 a.m.

Approval of Agenda

Critique of 2016 LIVE Conference

• Katie Burritt was asked to report on the evaluations received from conference attendees. There were 85 evaluations submitted indicating moderate to high

satisfaction in most areas. People seemed to enjoy the keynote speaker and the panelists. Some individuals commented that they enjoyed having the developers present and that the vendors were helpful. Ms. Burritt will compile the survey answers and email the results to Committee members, which will be discussed in more detail at the January meeting.

- Future conferences
 - Healthcare may be a topic for discussion, as there could be changes with a new President.
 - Ruth Ann Beideman questioned if the Committee thought that it might be beneficial to move the annual conference to the spring. That would mean there would be a conference in the spring of 2018, but no conference in 2017.
 - Anthony DelFranco proposed changing the name of the conference since people do not know how to pronounce it and there is a Life Conference that it is often confused with. Mr. DelFranco suggested that "Sussex Living Conference" might work better.
 - The question was raised if the conference should be scheduled for a half day, maybe 8:30 a.m. to 12:30 p.m., instead of running until 2:15 p.m. This timing would eliminate lunch and could allow for an upgraded mid-morning snack or possibly a breakfast buffet. Concerns were expressed as to whether vendors would object to a half-day conference and if the Committee would need to charge less.
- Positive thoughts about the 2016 conference
 - Very professional the location and speakers were excellent.
- Negative thoughts about the 2016 conference
 - Food Lunch was not upgraded. Some sandwiches had very small portions, the turkey was bland, there were no Granola bars, they ran out of diet drinks, and onions from the veggie wraps were so strong that the taste seeped into the cookies.
 - Time The conference got off to a late start and a few speakers spoke too long. Fortunately, they were able to make up the time and still end at 2:15 p.m., but the schedule needs to be adhered to more closely in the future.
 - Registration There was a group from Ocean Pines that had not registered. Some people signed up through Eventbrite and had a receipt, but their names were not on the list. Vendors had four to six people attending without providing their names.
