Emergency Planning and Community Right-to-Know Act (EPCRA) Reporting Program

Local Emergency Planning Committee (LEPC) Report – May 2025

1. Reporting Year (RY) 2024 Reporting Summary

Delaware facilities submit their EPCRA Section 312 reports (also known as Annual Tier II reports) using the *Tier II Manager* TM (T2M) database. For Reporting Year (RY) 2024, over 97% facilities submitted 2629 Tier II reports by the March 1st, 2025, due date. As of May 1st, the total number of annual Tier II reports increased to 2683, representing 99% of expected submissions. This marks continued efforts to enhance compliance and timely reporting across facilities The program has received ~\$477,599 in annual fees from submitted reports.

Tables 1-3 summarize key reporting metrics such as submitted annual Tier II reports, active facilities in the database, and other EPCRA facility updates since the last LEPC meeting. Chart 1 shows a trend analysis of facilities submitting annual reports across all LEPC's. A list of facilities missing their annual report is summarized in Table 4. The tables below contain Tier II reporting data according to a facility's LEPC designation. Facilities usually determine their own LEPC, but these determinations should be verified by each LEPC. LEPC's can access and view the reports through the T2M system.




Chart 1 - EPCRA 312 (Tier II) Annual Facility Reporting Historical Trend

3. Status of Missing Facility Reports

On May 1^{st} , 2025, 32 active facilities listed in the Tier II ManagerTM database have been identified as delinquent.

- Verification is still required by the LEPCs for the 19 facilities listed below to determine their operational status and, if active, to obtain their current contact information.

DEMA UPDATES- Steven Phillips

SERC Report

- The last Planning and Training Committee meeting was on February 20. The next P&T Committee meeting will be on May 15, the following meeting will be on August 21.
- LEPC Plans will be requested for submission following the May 15 meeting. Those Plans will be proposed for approval at the August P&T meeting and September SERC meeting.
- The IT Committee met on April 16 and discussed the status of the EPCRA Public Portal, Translating EPCRA Flyers into Haitian Creole, and the SERC Website Refresh that was part of the DEMA website update.
- The last SERC meeting was on March 12. The next meeting will be on June 11.
- Secretary Bushweller was welcomed as the new SERC Chair, The FY26 SERC Budget was approved, allocations for the FY26-28 HMEP Grant were approved, discussion related to the storage of HazMat Decon/Response equipment in NCC, and DSFS provided a demonstration of their refurbished industrial firefighting equipment and props.

HMEP Report

- Currently in Year 3 of the HMEP three-year grant period. \$179,752.00 Total Grant Amount for Year 3. For Year 3 we have spent \$23,485.57.
- The application period for the FY26-28 HMEP Grant has not yet opened. The funding opportunity is going through additional reviews on the federal side before it is released.
- Projects and allocations have already been approved; submission window will be short.

DEMA Report

- The Logistics Section at DEMA worked with FEMA Region III to hold Logistics Capability Assistance Tool (LCAT) Workshops with internal and external partners. The purpose of an LCAT is to evaluate current disaster logistics readiness, identify areas for targeted improvement, help develop a roadmap to mitigate shortfalls and limiting factors, and further enhance strengths within our levels of disaster response capability.
- The first meeting to prepare for the September SERT Plan Seminar/TTX was held on April 30. That Concepts and Objectives Meeting reviewed the basics of the event with formal planning taking place at the June 4 Initial Planning Meeting. Planning team members include DEMA, NCC LEPC & OEM, DelDOT, DPH, DNREC, and DSFS.
- DEMA recently completed a total redesign of the State EOC. This replaces the command center style tiered seating arrangement with a leveled floor and pod

style seating setup. This will allow for greater flexibility by grouping ESCs together under similar mission sets and enhancing communication. An Open House for ESCs was held on May 5 and 6 to allow familiarization before the upcoming hurricane season and future exercises.
