**Mr. Stickels reported that the Fiscal Year 2006 Governor’s Recommended Budget includes the transfer of dog control responsibilities from the State to the individual counties.**

**Mr. David Small, Deputy Director of DNREC, reported that, if this proposal is enacted by the General Assembly, fifty percent of the total cost of dog control would be incurred at the county level, with the long-term goal of the counties assuming full control over the operation of the program in Fiscal Year 2007.**

**Mr. Small presented a historical summary of the Delaware Dog Control Program. Dog control started in Delaware in 1925, when it was operated as a function of the Game and Fish Commission and the enforcement was done by wardens. In 1970, the Commission was dissolved and its duties were assumed by DNREC/Division of Fish and Wildlife. Eventually, dog control was transferred to the Delaware S.P.C.A. by contract. This change was associated with a fundamental shift in services provided due to an increasing demand for dog control.**

**Mr. Small reported that until the mid-1970’s, dog licenses and fines paid for the cost of dog control. From 1975 through 1984, program income had to be supplemented through Grant-In-Aid from the General Assembly. In 1985, support for the dog program was switched to the General Fund.**

**Currently, the Program is funded primarily by two sources: (1) General Fund through the State Budget Bill and (2) through appropriated special funds, i.e. license sales, fines, and kennel licenses collected by various agencies.**

**Mr. Small reported that there are two independent S.P.C.A. organizations in the State. The Delaware S.P.C.A. operates in New Castle County with a satellite service in Sussex County, and the Kent S.P.C.A. services only Kent County. Both agencies operate under a contract with the Delaware DNREC. The contracts are bid through a Request for Funding Proposal every four years and renewed annually by mutual consent. The Delaware and Kent S.P.C.A. are chartered by the General Assembly of the State of Delaware as nonprofit corporations responsible for investigating animal cruelty.**

**Mr. Small reported that the number of service requests in Sussex County for the period July 1, 2003 through June 30, 2004 was 3,885; that approximately 1,000 stray dogs were brought in by animal control officers; and that the number of stray dogs brought in by the public were approximately 400.**

**Mr. Small reiterated that this is only a proposal at this point in time. It is envisioned that each County, in the coming fiscal year, would be given its pro-rated General Fund share for Fiscal Year 2006. In the Governor's proposal, it was recommended that 50 percent of the funding would come from each county. The State would continue to collect the fees/fines and would distribute the funding on a pro-rated share. Effective January 1, 2006, each county would be authorized to set dog license fees and collect revenues associated with the fees/fines to generate funds to operate the program. As of July 2006, there would be no further dog control funding appropriations from the State.**

**Mr. Stickels responded that the three counties have stated that, if this proposal is to be considered at all, the proposed schedule would need to be amended and the transition period would need to be extended beyond one year.**

**Mr. Small acknowledged that many issues will need to be considered: timing, transition, funding, changes in State Code, enforcement authorities,, County ordinances for implementation, level of S.P.C.A. funding, etc.**

**Mr. Small reported that the Delaware S.P.C.A. has sent a letter to the State voicing its concerns about the level of funding in order to carry out its current contractual responsibilities. He noted that the current amount of combined funding is \$533,541 for New Castle County; \$232,000 for Kent County; and \$274,850 for Sussex County. Mr. Small stated that he believes that the S.P.C.A. has reported a funding shortage of \$50,000.**

**The County Council discussed the proposal and commented that if dog**

license fees are increased, there will be an increase in the number of unlicensed dogs; that the program is a problem for the State and that they want to turn that problem over to the counties; that there is no support for the proposal; and that the County Council would consider providing funding for the State program.

John Caldwell, Director of the Delaware S.P.C.A., advised the Council that the Delaware S.P.C.A. officially notified the State in March 2005 that they do not intend to enter into a contract with the State in July 2006 for Fiscal Year 2007 and that they will turn the dog control program over to the State effective at that time. Further, the Delaware S.P.C.A. has stated that they will sign the Fiscal Year 2006 contract only if the program is adequately funded (\$931,433 has been requested for Fiscal 2006 for New Castle County and Sussex County). He noted that, of that amount, \$55,000 in funding was requested due to the non-renewal of the Board of Health contract, which provided funding for one staff position. Mr. Caldwell reported that only three employees are funded through the State's Dog Control Program and that the Delaware S.P.C.A. has subsidized the State of Delaware in the amount of \$331,000 in the past three years to run the program. Mr. Caldwell noted that it would take approximately ten employees and \$3 million - \$6 million annually to run the program adequately in Sussex County.

Mr. Caldwell stated that when their contract with the State expires, the S.P.C.A. will go back to their true mission of cruelty investigations, adoptions, humane education and neutering.

**Mr. Izzo, County Engineer, reviewed Change Order No. 3 to the contract with JJID, Inc. for the Corporate Hangars Taxi-lane Project. Mr. Izzo explained that a new taxi-lane is being installed to provide service to the main runway for five corporate hangars that will be constructed in the near future. The contract commenced in the Fall of 2004; however, the significant rain events in December resulted in wet site conditions which prohibited the contractor from getting the base down in the area where the taxi-lane was to be constructed. Mr. Izzo explained that there were two options to consider: to shut down the contract and wait for the soils to dry out before commencing the work or to come up with a different base material to be put down in wet weather. Mr. Izzo stated that it was determined that the best alternative would be to use a different base material (6 additional inches of stone) at a cost of \$14,400.00. Mr. Izzo noted that the change order consisted of four other cost items totaling \$5,830.94, including an additional fire hydrant, removal of an underground storage tank, demolition of existing concrete foundations, and removal and replacement of an existing storm pipe. Mr. Izzo further noted that the**

project is FAA funded.

- The use as a family center (private club) would be out of character with the community, which is primarily agricultural and residential, and would not be consistent with the surrounding properties.
- The property is zoned AR-1 Agricultural Residential, which references in its purpose that agricultural operations and activities be protected. The use would not be appropriate since it is proposed to be placed between an existing hog farm and an existing poultry farm. The use may cause a bio-security risk for poultry farm operations. The use may cause additional noise that could impact the poultry farm operation. Night-time vehicle lights could disturb the poultry farm operation.
- The proposed use may have a significant impact on traffic. The site is located on a narrow County road with several curves and no shoulders.
- The proposal, if approved, would have a negative impact on neighboring and adjacent properties, based on reasons stated by the opposition to the application.
- The proposed use does not promote the health, safety, convenience and general welfare of the neighborhood or community.

The County Council discussed a draft ordinance relating to a CR-1 Commercial Residential District. Part One of this amendment corrects an earlier error that had made certain amusements conditional uses. Also, the existing C-1 District is closed, thereby grandfathering existing zones. Part Two creates an entirely new zoning district modeled directly after the now closed C-1 district. However, the new district would allow residential uses as a Conditional use and at a density not exceeding 4 units per acre. The new district also includes several text changes addressing issues raised by the Council or staff. Part Three would limit any new B-1 Conditional Use for multifamily at no more than 4 units per acre. Part Four amends the “Bulk, area and height” requirements to recognize the reduced density in the B-1 and new CR-1 districts. Part Five adds Table III that establishes the new density requirements.

Following the discussion, it was the consensus of the Council that a workshop on land use ordinances be held in the near future to allow sufficient time for discussion.
