High School Class The County Council recognized the Life Skills Class of Laurel High School who were present to observe the County Council meeting.

Sussex County Habitat for Humanity/ Loan Agreement Richard Faull, President of Sussex County Habitat for Humanity, was in attendance and gave a brief background on the role of the organization. He reported that the organization built one house per year until last year, when they produced three houses. He also reported that so far this year, they have produced five houses. He stated that they have purchased three lots in Ellendale that they will be building on within the next year and that they have purchased 16 acres on German Road near Seaford where they will be building their first Habitat village. Mr. Faull stated that they requested funding from the County Council and that the County has worked out an arrangement with them whereby they will get a \$50,000 interest-free loan.

Mr. Stickels reported that in the FY 2005 Budget, the Council amended the Proposed Budget to include an extra \$300,000 for the County's Community Development Office. Of that amount, \$100,000 was allocated to assist with the building of homes; \$100,000 was allocated for emergency repair projects that were not on the Community Development Block Grant Waiting List; and an additional \$100,000 was allocated for the Strong Communities Initiative.

Mr. Stickels reviewed a Loan Agreement between the Sussex County Council and the Sussex County Habitat for Humanity, Inc. in the amount of \$50,000. The terms of the loan would be a 20-year payback with monthly payments of \$208.34. The money would then convert into a grant. Any principal payments made on the loan would be returned to the Borrower in the form of a grant, provided the funds are used by the Borrower for one or more future habitat housing projects in Sussex County.

Check Presentation The County Council presented a check in the amount of \$50,000 to Sussex County Habitat for Humanities, Inc.

CHEER Grant/ Check Presentation The County Council presented a check in the amount of \$25,000 to CHEER, Sussex County Senior Services, representing grant funding for the new senior center in Ocean View.

The County Council presented another check in the amount of \$10,000 to CHEER, Sussex County Senior Services, representing grant funding for the In-home Services Program.

Proposed Leases Mr. Stickels discussed two proposed Sussex County Industrial Park leases that will create additional employment in Sussex County.

Proposed Industrial Park Lease/ PATS Aircraft, LLC Dan Folghum of PATS Aircraft, LLC, Lieutenant Governor John Carney, Gary Smith of the Delaware Economic Development Office, Steve Masten of the Sussex County Economic Development Office, and Jack Riddle of Mellon Bank were present in support of the transaction. Mr. Stickels stated that this is an example of County, State, and Private Partnership working together.

Mr. Stickels stated that in September, the County Council approved the purchase of a building on Lot 24 in the Industrial Park that was owned by HolKrist, LLC for the purpose of marketing the building for employment opportunities for Sussex County.

Mr. Folghum stated that they plan to relocate their manufacturing facility from Maryland to the Sussex County Industrial Airpark. The corporate headquarters, accounting organization, IT organization, and a manufacturing team of PATS Aircraft, LLC will be relocating to the Sussex County Industrial Park. He stated that they already have a facility in the Sussex County Industrial Park and that their strategy is to make PATS Aircraft's home in Sussex County, Delaware.

Mr. Stickels stated that 40 new jobs will be added to their workforce; that approximately 23 of these jobs will be new hires; that there will be an annual payroll of \$2.2 million; and that PATS Aircraft annual payroll will be over \$10 million with the new employment.

Mr. Stickels stated that the facility is a 30,000 square foot building with two outbuildings. The Proposed Lease/Purchase Agreement is for a term of ten years with an interest rate of three percent on the unpaid balance.

Proposed Lease (continued The Lieutenant Governor stated that this project not only brings 40 jobs to the County but would possibly solidify the 160+ jobs that are already located in the County.

Proposed Lease Agreement/ Patrick Power Products Mr. Stickels presented a proposed Lease Agreement between Sussex County and Patrick Power Products, Inc. for Lot 25 at the Sussex County Industrial Airpark, which consists of $2.6617 \pm acres$. The term of the lease would be ten years, with the annual rent set at \$500.00 per acre for years 1-5 and \$750.00 per acre for years 6-10.

Mr. Stickels reported that Patrick Power Products, Inc. is currently developing a new generator and electrical power generator equipment for the United States Military and testing is currently funded by the U.S. Army through a \$2.5 million design contract which will expire in May of 2005 after which they will receive another contract in the amount of \$1.5 million dollars. This work is taking place in Maryland, close to Fort Meade. He further reported that they are in the process of negotiating contracts with the Navy, Marine Corp., Army, and the private sector in developing generators. They are proposing that the production and testing of the generators would be done at the Sussex County Industrial Airpark. Mr. Stickels advised that Patrick Power Products is in the process of developing a building to be constructed.

Mr. Stickels distributed a listing of nine emergency rehab projects, which total \$66,500. He noted that the work is recommended for homes that are in desperate need of repair work, i.e. roofs, doors, windows, handicap ramp. He stated that although the repair work may not bring the houses up to Code, it will protect the homeowners from the elements until they can get higher up on the priority list for CDBG funding. It was not necessary for the Council to take action.

Funding Request Mr. Stickels submitted a funding request from the Church of God and Saints of Christ.

2. <u>Beneficial Acceptance</u>

- CEA DAG Multi-Unit Dev., Agreement No. 333, was granted Beneficial Acceptance on October 14, 2004. The developer is Scott Evans, and the project is located one-quarter mile east of the intersection of Routes 26 and 113 in the Dagsboro/Frankford Sanitary Sewer District, consisting of 28 townhouses.
- Washington Place, Agreement No. 356, was granted Beneficial Acceptance on October 15, 2004. 4. Public Workshops

The Delaware Department of Transportation (DelDOT) is holding five Public Workshops to update, and seek comments from, the public on the continued progress of the US 113 North/South Study. Although similar information will be presented at each workshop, information specific to the Millsboro, Dagsboro, Frankford, and Selbyville area will be presented at both the "Millsboro-South Area Workshop" and "Selbyville Area Workshop," information specific to the Georgetown area will be presented at the "Georgetown Area Workshop," information specific to the Ellendale area will be presented at the "Ellendale Area Workshop," and information specific to the Milford area will be presented at the "Milford Area Workshop."

The purpose of this third round of workshops is to present the refined preliminary alternatives to the public for review and comment. Comments and suggestions provided at the workshops will be used in the study to further develop and evaluate preliminary improvement alternatives for US 113. Public input throughout the study is welcomed and encouraged. Public Hearing (C/U No. 1549) A Public Hearing was held on the Proposed Ordinance entitled "AN ORDINANCE TO GRANT A CONDITIONAL USE OF LAND IN AN AR-1 AGRICULTURAL RESIDENTIAL DISTRICT FOR A MEDICAL OFFICE TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN LEWES AND REHOBOTH HUNDRED, SUSSEX COUNTY, CONTAINING 14,998 SQUARE FEET, MORE OR LESS" (Conditional Use No. 1549) filed on behalf of Ramon A. Rosa and Lourdes Aponte De Rosa.

The Planning and Zoning Commission held a Public Hearing on this application on August 19, 2004 at which time they deferred action. On September 9, 2004 the Commission recommended that the application be approved with conditions.

(See the minutes of the Planning and Zoning Commission dated August 19 and September 9, 2004 for additional information on the application, correspondence received, and the Public Hearing before the Commission.)

The Council found that Dr. Aponte and Dr. Rosa were present on behalf of the application. They stated that propose a medical office; that the building will be approximately 2,700 square feet on one floor; that the facility will house one to two physicians; that the parking will be in the rear of the property; that the residential appearance of the structure will be retained in the front of the building.

There were no public comments and the Public Hearing was closed.

Proposed Land Acquisition/ Sussex County Airport Mr. Izzo, County Engineer, discussed the proposed purchase of land adjacent to the Sussex County Airport. He noted that this is part of the continuing process in which the County proceeds toward a 1,300 linear foot extension of the main runway at the Sussex County Airport. He noted that this property is affected by the realignment of Truck Route 9 and the runway protection zone and that the FAA requires that the County control this property. Mr. Izzo reported that the property is Parcel 51-02 owned by John Cupa and that it is a vacant property of 8.43 acres. The property has been appraised at \$105,000 by Tidewater Properties. Mr. Cupa has accepted the purchase price of \$105,000.

Milton Public Library Project/ Change Orders Mr. Izzo, County Engineer, and Brad Hawkes, Project Engineer, presented two changes orders to the Milton Public Library Project. He noted that the project is substantially complete; however, they are continuing to process the paperwork on the project and they are continuing to negotiate some things with the contractor. Mr. Hawkes reviewed the proposed change orders. Change Order No. 7 is for mechanical work including a larger water service line for the fire service and an electrical panel item. Change Order No. 8 is for additional brickwork, a ramp and step for the handicapped, handrails required by the Handicapped Accessibility Code, and work to correct drainage problems.

Roxana Fire Company The Chief of the Roxana Fire Company was in attendance to advise the Council of problems they are having in controlling the required 38 foot radius for cul-de-sacs (new developments).
