ORDINANCE NO. 1909

AN ORDINANCE TO AMEND CHAPTER 62 OF THE CODE OF SUSSEX COUNTY BY AMENDING ARTICLE IV '62-16 RELATING TO FEES CHARGED BY THE CLERK OF THE PEACE, as amended, to be effective September 1, 2007.

The Sussex County Council has determined that in order to better serve the health, safety and welfare of the citizens of Sussex County, it is necessary to revise the Code of Sussex County in relation to the fees charged for services provided by the Sussex County Clerk of the Peace and his staff to amounts that are currently appropriated based on the amount of work and expenses involved in providing those services.

NOW, THEREFORE THE COUNTY OF SUSSEX HEREBY ORDAINS:

§62-16.	Enumeration of fees.

A. The fee for a marriage license issued by the Clerk of the Peace for Sussex County <u>to a Delaware resident shall be \$30 each.</u>

- B. [The fee for providing a certified copy of a marriage license by the Clerk of the Peace for Sussex County shall be \$10 each.] <u>The fee for providing a marriage</u> <u>license issued by the Clerk of the Peace for Sussex County to a non-Delaware</u> <u>resident shall be \$50 each.</u>
- <u>C.</u> <u>The fee for providing a certified copy of a marriage license by the Clerk of the</u> <u>Peace for Sussex County shall be \$10 each.</u>
- **D.** The fee for conducting a Memorable Marriage Ceremony for a Delaware resident in the office of the Clerk of the Peace for Sussex County shall be \$20.
- **<u>E.</u>** The fee for conducting a Memorable Marriage Ceremony in the office of the Clerk of the Peace for Sussex County for a non-Delaware resident shall be \$50.
- **<u>F.</u>** The fee for conducting a Memorable Marriage Ceremony outside of the office of the Clerk of the Peace for Sussex County for a Delaware resident shall be \$25.
- **<u>G.</u>** The fee for conducting a Memorable Marriage Ceremony outside of the office of the Clerk of the Peace for Sussex County for a non-Delaware resident shall be \$50.
- **H.** The fee for performing a Renewal of Vows ceremony in the office of the Clerk of the Peace for Sussex County for a Delaware resident shall be \$20.
- **I.** The fee for performing a Renewal of Vows ceremony in the office of the Clerk of the Peace for Sussex County for a non-Delaware resident shall be \$50.
- J.The fee for performing a Renewal of Vows ceremony outside of the office of the
Clerk of the Peace for Sussex County for a Delaware resident shall be \$25.
- **K.** The fee for performing a Renewal of Vows ceremony outside of the office of the Clerk of the Peace for Sussex County for a non-Delaware resident shall be \$50.
