Robert Carey, Executive Director, Delmarva Teen Challenge, updated the Council on who Delmarva Teen Challenge is and what they do. Delmarva Teen Challenge (DTC) is an affiliate of Teen Challenge International and is a non-profit 501(c)(3) organization with its own Board of Directors. DTC is an induction center which provides a residential program for the first 4 months of a 1-year program; the second phase, an 8-month program, is held at

another U.S. location. DTC is currently the only long-term drug/alcohol/addiction residential program in Delaware. DTC is a faith-based residential program whose mission is to restore broken lives of men who have been affected by issues like anger, rebellion, depression, drug/alcohol abuse and other life controlling problems. Mr. Carey reported that DTC has an 86 percent success rate.

Dave Schepens, Program Manager of the Groundwater Discharge Section of DNREC, was in attendance at the invitation of the Council to discuss proposed regulations governing the design, installation, and operation of on-site wastewater treatment and disposal systems. Also present was James Cassidy, Manager of the Georgetown Office in charge of individual systems in Sussex County. Mr. Schepens stated that the proposed changes are needed to improve water quality as every stream in Delaware is impaired, there is a decrease in fish populations and an increase in algae blooms and dead zones, and many waterways are not safe for swimming.

Mr. Schepens provided a background on the proposed regulations. The process was started in November 2008. Since that time, the Department has conducted 11 public workshops throughout the State, held several meetings with stakeholders, and established seven working committees. A Public Hearing was held on May 3rd. Another public hearing will be held on November 15th; once that hearing has been held, the Department plans to have the record open for a minimum of 15 days.

Mr. Schepens discussed the portion of the proposed regulations that relate to individual septic systems: (1) FEMA guidelines must be adhered to in "V" zones; systems, including holding tanks, will be located and designed to minimize or eliminate flood damage, (2) all new and replacement on-site wastewater treatment and disposal systems permitted within the 1,000 feet of the Chesapeake Bay Tidal Waters must meet performance standards.

Mr. Schepens reviewed the costs for individual septic systems: \$2,500 to \$5,000 plus the cost of having a service provider look at the systems twice a year – the service costs are approximately \$175.00 to \$250.00. Owners may retrofit one of these units on a permitted existing system as a repair which will usually add years to the drain field (for replacement systems only). The regulations allow for a homeowner to become a service provider for their own system.

Mr. Schepens reviewed a map outlining parcels in Delaware completely within 1,000 feet of the Chesapeake Bay Tidal Areas.

Mr. Schepens stated that, per the proposed regulations, cesspools and seepage pits will be prohibited statewide and when found must be replaced within one year. Cesspools and seepage pits will be found through inspections on the system for real estate transfers, complaints from the public for overflowing systems, and requests for authorization to use existing systems for additions of bedrooms and new dwellings on existing properties for which a septic permit

was not issued previously.

**Mr. Schepens provided information on the Septic Rehabilitation Loan Program and the Septic Extended Funding Option.**

**At the conclusion of the presentation, Mr. Phillips stated that property owners to be affected by the 1,000 foot overlay should receive notification of the November 15th Public Hearing.**

**A Public Hearing was held on the Proposed Ordinance entitled “AN ORDINANCE TO AMEND CHAPTER 62 OF THE CODE OF SUSSEX COUNTY RELATING TO FEES CHARGED BY THE CLERK OF THE PEACE TO PERFORM MARRIAGE CEREMONIES AND CIVIL UNIONS”.**

**The Proposed Ordinance sets the fees the Clerk of the Peace charges for marriage and civil union ceremonies for Delaware residents, non-residents, and active United States military personnel.**

**George Parish, Clerk of the Peace, explained the Proposed Ordinance and he stated that it would extend the County’s appreciation and gratitude to the men and women of the military as it would provide for the same rates that are charged to Delaware residents:**

- **\$50.00 fee for a marriage or civil union license**
- **\$50.00 fee for conducting a marriage or civil union ceremony in the office of the Clerk of the Peace or on The Circle or any building fronting The Circle**
- **\$75.00 fee for conducting a marriage or civil union ceremony outside of the office of the Clerk of the Peace**
- **\$50.00 fee for performing a renewal of marriage or civil union vows in the office of the Clerk of the Peace or on The Circle or any building fronting The Circle**
- **\$75.00 fee for performing a renewal of marriage or civil union vows ceremony outside of the office of the Clerk of the Peace**

**Mr. Parish noted that New Castle County and Kent County have already implemented this reduction of fees.**

**Mr. Phillips noted that, at that time the Council introduced the Proposed Ordinance, some Council members expressed an interest in waiving the fees for men and women of the military. For this reason, prior to public comments, Mr. Phillips made the following Motion:**

Attached please find the call statistics for the Fire and Ambulance Callboard for October 2012. There were 15,924 total calls handled in the month of October. Of those 9-1-1 calls in October, 75 percent were made from wireless phones.

3. Project Receiving Substantial Completion

As you will see from the attached Engineering Department fact sheet, The Woods at Johnson's Corner a/k/a Fenwick Hamlet a/k/a Fox Haven – Phase I reached Substantial Completion effective November 2, 2012.

4. Thanksgiving Holiday

The Sussex County Council will not meet on Tuesday, November 20, 2012, during the week of Thanksgiving. County offices will be closed on November 22 and 23 for the Thanksgiving holiday and will reopen on Monday, November 26, at 8:30 a.m.

5. Superstorm Sandy Update

Nearly two weeks since Superstorm Sandy made landfall, it is apparent that Sussex County and the State of Delaware were spared the devastating effects of the storm. That being said, there are communities within the County that have damage and their post-storm efforts continue.

When an event such as Sandy is predicted to hit Sussex County, there are two aspects to the County's response: the one that involves keeping critical County infrastructure and services such as our wastewater and communications systems operating, and the other that involves the County's role in providing public safety to our citizens.

During the days leading up to the main force of the storm and after the storm passed, our County's employees performed dutifully and without pause. Many were required to work, but there were several others who volunteered their time as well. I want to extend my sincere appreciation and gratitude for their efforts.

There are too many individuals to name; however, the following departments deserve a tremendous amount of credit, including: Assessment, Communications, Engineering, Information

**Technology, Paramedics, and our flagship Emergency Operations Center staff led by Joe Thomas.**

**During Sandy, the County provided information through its press releases and network of social media including Twitter and Facebook. We also developed a new service to our citizens in the form of video reports which provided critical, real-time updates to those seeking information. The results were astounding. During the storm:**

- **The County's website had over 57,000 views;**
- **Facebook followers jumped nearly 200 percent;**
- **Reach through the Facebook page (followers to friends and friends of friends) grew to 44,203;**
- **The EOC Twitter handle had the most referrals and activity in its history; and**
- **The YouTube Video Reports had over 32,000 views.**

**These reports helped keep our citizens informed and well-prepared for the effects of the storm.**

**Finally, our partners at the State and Federal levels are still assessing the damage Sandy caused to determine what, if any, relief the County and State will receive. The assessments will determine if the State can seek a Federal Major Disaster Declaration. As of today, no determination has been made, but we anticipate one soon.**

**David Rutt, Assistant County Attorney, presented a Lease Amendment with Universal Forest Products (UFP) for land at Sussex County Industrial Park (the lease has been in effect since 1994). He noted that this building has remained vacant for several years without a tenant. Dating as far back as 1991, the lease for this building has gone through multiple assignments and there have been some errors in the lease terms and parcel lot dimensions as a result. The County was made aware of these issues recently.**

**Mr. Rutt explained that the original lease was entered into with North American Housing Corp. and subsequently assigned to Shoffner, which became Universal Forest Products (UFP). The original lease was for 5 1/2 acres; however, this turned out to be incorrect as the correct acreage is**

actually 7.22 acres. There was also a question as to whether they had agreed to an assignment of an additional 17± acres. A building was constructed on the 7.22 acres and UFP owns the building but leases the land; however, they never did anything with the building and it is empty. Mr. Rutt advised that UFP now has a potential tenant (Delmarva Aluminum) for the property (and the building). UFP acknowledges that they lease the 7.22 acres and that they do not have a lease on the 17± acres. UFP is willing to waive any rights to the 17± acres since there is no lease giving the County the option to re-lease it to someone else or use it for other purposes, i.e. stormwater drainage.

Mr. Rutt reviewed a Memorandum of Understanding (MOU) which has been signed by UFP and by which the assignment of the 7.22 acres to UFP can be amended (allowing an assignment or a sublease). By doing this, the County agrees that, if the tenant exercises the option to purchase the building, the tenant would not have to come back to the Council for approval.

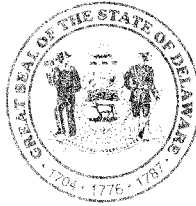

The purpose of this letter is to follow up on recent conversations that you and Deputy Attorney General Peter Jamison have had regarding the above-referenced matter. As Mr. Jamison advised you, the Delaware Board of Architects ("Board of Architects") and the Council of the Delaware Association of Professional Engineers ("DAPE Council") (both of whom are represented by the Attorney General) have for some time been concerned about language in section 52-18 of the Sussex County Code that allows for the issuance of a building permit where the drawings, specifications and accompanying data submitted with the application for the permit are not prepared by a Delaware registered architect or Delaware licensed engineer. As Mr. Jamison advised you, that language appears to be at odds with State statutory law that prohibits persons from practicing architecture or engineering in Delaware without first being licensed in Delaware. We are, therefore, pleased to hear that Sussex County is willing to take corrective action to address the matter. In our view, the matter may be resolved by an amendment to section 52-18 as follows:

1. Delete existing Section 52-18 C of the Sussex County Code and replace with the following:

**§ 52-18. Drawings and specifications.**

- C. All drawings, specifications and accompanying data shall bear the name and address of the designer. All drawings, specifications and accompanying data submitted for review by the building official and any documents submitted to the building official with a permit application shall meet the requirements of the Delaware Code. Said

drawings, specifications and accompanying data shall have affixed upon them the official seal of an architect and/or engineer, and no permit application will be approved unless, for plans sealed by an architect, the person so affixing his or her seal is, in connection with the preparation and submission of such drawings, specifications, and accompanying data, in compliance with the registration provisions of 24 Del. C. Ch. 3 or, for plans sealed by an engineer, the person so affixing his or her seal is, in connection with the preparation and submission of such drawings, specifications, and accompanying data, in compliance with the licensing provisions of 24 Del. C. Ch. 28.

2. Delete existing Section 52-18 E.

Upon Sussex County amending the Sussex County Code as indicated above, the Board of Architects and the DAPE Council believe that the concerns previously expressed with respect to Section 52-18 being in conflict with controlling state law will be resolved. Please respond within 10 days of the date of this letter to advise of the date that this matter will be placed on the Sussex County Council's public meeting agenda and the date that you anticipate the changes to the Sussex County Code will be effective. Our expectation is that the changes to the Sussex County Code will be effective within 30 days and if the changes are not in effect by that time we will have to consider other remedies.

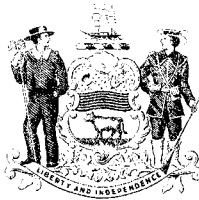

As President of the Delaware Board of Architects ("Board of Architects"), I am contacting you with respect to two issues that the Board of Architects has identified with Section 52-18 C of the Sussex County Code. The Board of Architects has also been in communication with representatives of the Council of the Delaware Association of Professional Engineers (the "DAPE Council") and knows that the DAPE Council also has the same concerns with Section 52-18 of the Sussex County Code.

Deputy Attorney General Andrew Kerber, representing the Board of Architects, previously contacted David B. Baker, County Administrator by letter dated March 21, 2007 on behalf of the Board of Architects with respect to one of the issues with Section 52-18 C. However, Mr. Baker did not acknowledge or respond to the letter. A copy of this letter is enclosed. The Board of Architects is aware that Deputy Attorney General Tom Ellis, representing the Law Enforcement and Ethics Committee of the DAPE Council, was in contact with attorney David N. Rutt, representing Sussex County, with respect to the other issue with Section 52-18 C, most recently by letter dated October 7, 2010. Mr. Rutt did not acknowledge or offer any response to the October 7, 2010 letter.

The two issues the Board of Architects has with Section 52-18 C of the Sussex County Code are as follows:

(1) Under Section 52-18 C, architects and engineers registered in any state are permitted to seal drawings and specifications submitted with an application for a building permit in Sussex County. The inclusion of the words "of any state in the United States" in Section 52-18 C results in this section being out of compliance with applicable state law governing the practice of architecture in Delaware, specifically 24 Del. C §303(a). Section 52-18 C would be in compliance with state law if the words "of any state in the United States" were changed to "of Delaware."



(2) In addition, under Section 52-18 C, an official seal of an architect or engineer is only required for certain Educational, Institutional and Assembly Occupancy buildings and for buildings of 5,000 square feet or more. The state statutes for the Board of Architects contain no such limitation on the size of buildings. Under Delaware state law, if a person performs architectural services with respect to a building in Delaware without being a Delaware registered architect, that person is engaged in the unlawful practice of architecture. Section 52-18 C would be in compliance with state law if the section read as follows:

**§ 52-18. Drawings and specifications.**


- C. All drawings, specifications and accompanying data shall bear the name and address of the designer. All design work for new construction, alteration, repair, expansion, addition or modification work involving the practice of architecture or engineering, as defined by the professional registration laws of the State of Delaware, shall be prepared by an architect or engineer legally registered or licensed under the laws of Delaware, consistent with the professional registration or licensing laws of the State of Delaware. Construction documents shall include the name, address and license or registration number of the architect or engineer and shall be signed, sealed and dated by the architect or engineer in accordance with professional registration or licensing laws of the State of Delaware.

The primary objective of the Board of Architects is to protect the general public from unsafe practices and, in furtherance of that objective, the Board of Architects is charged with preventing the unregistered practice of architecture in Delaware pursuant to 24 Del C §303(a). The Board of Architects view the cited provisions of Section 52-18 C of the Sussex County Code as authorizing the unlicensed practice of architecture in Delaware in violation of Delaware state law. Accordingly, the Board of Architects requests that the Sussex County Council take the steps necessary to revise Section 52-18 C to comply with Delaware state law.

In the event that the Board of Architects is not able to come to an acceptable resolution with Sussex County on the issues with Section 52-18 C within 30 days of the date of this letter, the next recourse would be to seek a declaration from the Delaware Courts that the cited provisions of Section 52-18 C are void and unenforceable under state law.

Accordingly, the DAPE Council requests that the Sussex County Council take the steps necessary to revise Section 52-18 C to comply with Delaware state law.



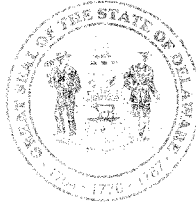

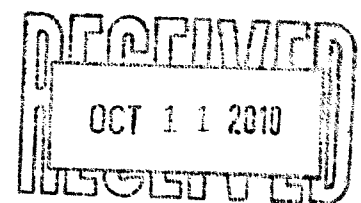

Thank you for your letter of September 1, 2010 and your invitation to submit this reply to more fully explain the concerns of the Law Enforcement and Ethics Subcommittee ("Subcommittee") of the Delaware Association of Professional Engineers.

Twenty-four Del. C. §2803(24) defines what constitutes the practice of engineering in Delaware while §2825 proscribes the unlicensed practice of engineering. As you will note, §2803(24) defines the practice of engineering not in terms of the size of a particular building or structure, but rather in terms of the actions of an individual. This makes sense.

The Sussex County Building Code would seem to suggest that the size of a building or structure, and specifically ones less than 5000 square feet in dimension, is determinative of whether or not an individual is practicing engineering, i.e., a Delaware professional engineer's stamp and signature is only required on work in Sussex County involving buildings and structures of 5000 square feet or more. The Subcommittee thinks this approach is fundamentally misguided and ignores the vital public safety role that Delaware Professional Engineers have played historically in the state. The Subcommittee questions on what basis the conclusion was reached that a 5000 square foot threshold would adequately protect the citizens of this state as opposed to some other random number. The Subcommittee respectfully maintains that 52-18 creates a real tension between the state law that mandates the possession of a Delaware Professional Engineering License to practice engineering and the Sussex County Building Code provision that implies that for structures of less than 5000 square feet such a license is unnecessary.

Conversely, there may be buildings or structures of more than 5000 square feet which does not involve "the practice of engineering." Nevertheless, the Subcommittee can envision a




situation where an individual who is not a licensed Delaware Professional Engineer, nevertheless “practices engineering” in Sussex County on a structure of less than 5000 square feet who claims he is exempt from the state law requiring licensure by virtue of the Sussex County Building Code provision. In my view, the state licensing law preempts the Sussex County provision as it is currently written. The engineering statute itself supplies the only exemptions from the state licensing requirement that currently exist. See 24 Del. C. §2825(j). The architects’ statute you have relied upon (24 Del.C. §303(e)) in your letter of 9/1 is not relevant as the architects certainly don’t speak for, much less regulate, the engineering profession.

In my view, a reasonable resolution of this matter would be for Sussex County Council to revise its Building Code provision by amending it so as to read:

“§52-18 E. Nothing in this section is to be construed as an exemption from 24 Del. C. §2825(a)(1) that mandates that anyone practicing engineering, as that term is defined at 24 Del. C. §2803(24), must be licensed in Delaware in order to develop drawings and/or specifications for buildings or structures of less than five thousand (5,000) square feet in area.”

I look forward to hearing from you again on this subject at your earliest convenience. Thanks for your consideration.

Dear Mr. Ellis:

You contacted me regarding complaints that had been lodged by certain engineers regarding the provisions under Section 52-18 of the Sussex County Code that permit a designer who is not an architect or engineer to develop drawings and specifications for buildings of less than 5,000 square feet. The argument was that someone could practice either professional engineering or architecture without receiving a license to do so from the State.

My research has indicated that there is no requirement in the Delaware Code that buildings of less than 5,000 square feet require the use of professional engineers or architects. I focused specifically in Title 24, Chapter 28 of the Delaware Code, which regulates engineers, and found nothing obligating the County to amend its Code to require that plans encompassed by the SCC bear the stamp of a professional engineer. I also reviewed Title 24, Chapter 3, which regulates architects. In particular, 24 Del.C., ' ' 303(b)(5) and 303(c) address the issue which you have raised. Exempted from the definition of the practice of architecture is the design of single and two-family dwellings with incidental outbuildings, farm buildings and alterations or renovations that do not affect the safety features of a structure, though these sections of 24 Del.C., Chapter 3 do not place size limitations on the size of the structure that can be built. It can be argued that the Sussex County Code is more restrictive than the Delaware Code in that respect.

24 Del.C., §303(c) does address when an owner of real property must also obtain the certificate of an engineer. However, under Section 303(c)(1)(d), the necessity of utilizing an engineer or architect is exempted under projects that fall within the parameters of Section 52-18 of the Sussex County Code.

I think there is an argument on both sides of this issue. If I understand the positions of the Law Enforcement and Ethics Committee of the Delaware Association of Engineers, they wish to have all structures in Sussex County, regardless of the nature of the building or the size of the building, certified by an engineer or architect. That is not what the Delaware Code requires. I would ask that you put into letter form the specific concerns of the Committee and I will address them with Sussex County Council.

**WHEREAS, Title 9, § 334 (a) of the Delaware Code, entitled, “Organization meeting; election of president” states, “(a) The governing bodies of the respective counties shall meet for organization on the first Tuesday in January following the biennial general election, or on the date specified by ordinance in the respective county,” thereby mandating the Sussex County Council to meet on the first Tuesday in January each year unless the County passes an ordinance stating otherwise; and**

**WHEREAS, Title 9, § 7002 (k) (1) of the Delaware Code which addresses Sussex County Council procedure states in part that “[t]he place and dates of such meetings shall be established by the county government as a part of the rules of procedure adopted for the conduct of its meetings,”; and**

**WHEREAS, Title 9 § 7002 (k) (2) of the Delaware Code states in part that “[t]he county government shall determine its own rules and order of business,”; and**

**WHEREAS, Sussex County Council desires to clarify when its meetings shall be held in the event its regularly scheduled Tuesday meeting falls on a legal holiday; and**

**WHEREAS, this ordinance shall amend Chapter 1 of the Sussex County Code by creating a new Article II, entitled, “Sussex County Council Procedure” and a new § 11-20, entitled, “Meetings on Legal Holidays” to clarify when a Sussex County Council meeting shall take place if the regularly scheduled meeting falls on a legal holiday;**

**NOW, THEREFORE, THE COUNTY OF SUSSEX HEREBY ORDAINS:**

**Section 1. Amend Sussex County Code, Chapter 1, by creating a new Article II, entitled, “Sussex County Council Procedures” and a new § 1-20, entitled, “Meetings on Legal Holidays, containing the underlined language as follows:**

**Article II. Sussex County Council Procedures**

**§ 1 – 20 Meetings on Legal Holidays.**

**In the event any Council meetings mandated by the Delaware Code, Sussex County Code or Sussex County Council’s Rules of Procedure fall on a legal holiday, the meeting shall take place on the next regularly scheduled Tuesday meeting date, or on such other date to be scheduled by the Council, upon providing proper notice to the public in accordance with Title 29, Chapter 100, of the Delaware Code.**

**Section 2. Effective Date. This Ordinance shall become effective immediately upon its passage.**

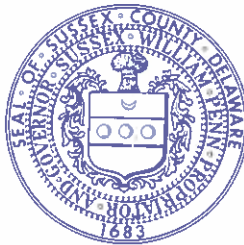

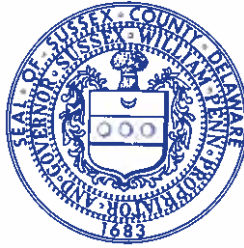

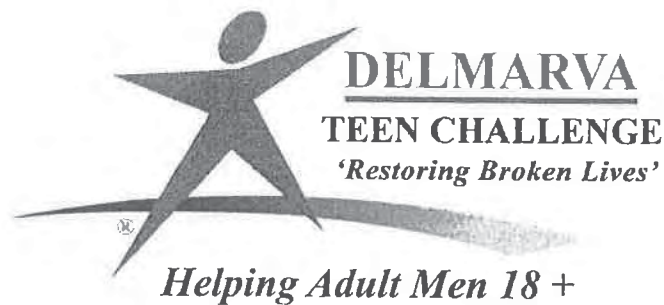

RE: Program Information

Dear Council Members:

In 1958, the first Teen Challenge (TC) Center was established in New York City to work with inner-city youth wanting a life that did not involve gangs and drugs. TC endeavors to help the whole person become mentally sound, emotionally balanced, socially adjusted, physically well and spiritually alive. Today there are more than 300 TC centers throughout the United States helping men, women, boys and girls trapped by addictions and over 1,100 TC Centers now operating on over six continents. Over the last two years alone, over 20,000 students were inducted into TC USA programs and over 5,029 students completed a one-year residential recovery program.

Delmarva Teen Challenge (DTC) is an affiliate of Teen Challenge International, USA, but autonomous from the national headquarters. DTC is a non-profit 501(c)(3) organization with its own Board of Directors. In 2008, DTC took over the site of the former Mission of Hope in Seaford, Delaware. DTC is an induction center which provides a residential program for the first 4 months of a 1-year program; the second phase, an 8-month program, is held at another U.S. location. DTC is currently the only long-term drug/alcohol/addiction residential program in Delaware. Since commencing the Teen Challenge programs in Seaford, DE in 2008, DTC has served over 600 men; approximately 40% have been students and the others have taken advantage of the weekly food assistance program. It is too early to measure our success, however we do know that in a little more than four years, we have graduated 126-men. More graduations are anticipated this calendar year. In addition, DTC employs seven graduates of the program who work/oversee the dormitory. Over 600-men have walked through the DTC doors and have experienced a positive impact in order to re-enter society.

**Mission Statement:** Our purpose is to restore broken lives of men who have been affected by issues like anger, rebellion, depression, drug/alcohol abuse and other life controlling problems. Delmarva Teen Challenge reaches out to men 18 years of age and up from all walks of life. DTC will provide an effective solution to life-controlling drug and alcohol problems in order for men to become productive members of society. DTC endeavors to help men become mentally sound, emotionally balanced, socially adjusted, physically well and spiritually alive.

**Success Rates:** There have been a number of studies conducted and that show that Teen Challenge has a great abstinence success rate, as high as 86% in some studies when including only graduates of the program. A

recent independent 2007 study<sup>1</sup> also indicates that the Minnesota Teen Challenge has a superior accomplishment rate with their program. This follow-up survey and study found that the average graduate had graduated an average of 2.7 years prior to the survey (graduation years ranged from 1 and 5 years; 2001-2005). The complete one-page summary and findings are attached. Following is a list of a few findings:


- Graduates were asked about their drug/alcohol use in the 6 months prior to the follow-up and 73% of adult graduates reported no substance usage in the last 6 months.
- Over 80% rated the overall quality of Teen Challenge as "outstanding" or "very good."
- 87% said "completely true" when asked if they think their circumstances today would be a lot worse if they had not gone through the Teen Challenge program.

**Community Served:** Currently we serve men 18 years of age and older who have addiction or life-controlling problems; service to women is planned for the future. The service area for DTC is the Delmarva Peninsula which extends between the Chesapeake and Delaware Bays. The peninsula is about 180 miles long and up to 70 miles wide. It encompasses parts of the states of Delaware, Maryland and Virginia. The population of the Delmarva Peninsula was about 681,030 in the 2000 census.

**Services Provided/Programs Offered:** The DTC has had full community support for DTC's miraculous neighborhood improvement programs including tearing down drug users/dealers hangouts and disbanding users and dealers from gathering in the neighborhood.

Delmarva Teen Challenge offers a 4-12 month residential program; the students upon assessment will then be transferred to another U.S. TC Training Center as they complete the full 1 year program. In addition to the DTC services provided in this building, non-profit community groups will also have use of this building.

Dear Councilmember Cole:

The Ocean View Historical Society (OVHS), in conjunction with other local townships, is conducting a capital campaign designed to preserve the rich history of the coastal towns of lower Sussex County. This project will have two aspects: first, the restoration of an historical home to its original condition, circa the period between the 1860's and 1880's, along with the restoration of a period Post Office building and chicken coop; and second, the construction of a new Coastal Towns Museum, to be built on the property adjacent to the historical home. The museum will be a place for visitors and residents to view artifacts and displays that reflect the history of Ocean View and the surrounding towns of Millville, Clarksville, Bethany Beach, and Selbyville, among others. The renovated home will be open to the public as well, and will reflect homes as they existed during the late 19th Century.

The OVHS building project will benefit the community in two ways: first, as an educational opportunity for local schoolchildren to visit and learn about what it was like to live in this community in the 1800's; and second, as a community development program, promoting the history of our coastal towns for residents and visitors alike.

To date, the OVHS has raised more than \$140,000 to renovate the outside of the Tunnel-West House, located on the John West Park property in Ocean View. The first Ocean View Post Office, which was donated to the OVHS, has also been moved onto the property adjacent to the Tunnel-West house, along with a period chicken coop that reflects the area's acknowledged history as the birthplace of the boiler chicken industry. Just recently, The Tunnell-West House was approved by the United States Department of the Interior to be placed on the Registry of Historic Places in the United States, and a plaque will soon be placed on the exterior of the house reflecting this designation.

It is the goal of the OVHS to complete this first phase of the project by next spring, so that we can open up the Tunnel-West House and the post office to local school systems for youth to visit for field trips. The OVHS needs just \$40,000 to complete the renovation on the inside of the house so that it is ready for the spring of 2013.

The first phase of the project has brought together representatives from the surrounding towns of Bethany Beach, Fenwick, South Bethany, Millville and Selbyville, who have now begun to hold meetings to gather artifacts that reflect the history of each of their respective towns. This has been a good precursor of what is in store for the area as the OVHS moves forward with Phase 2 of the project, building a new Coastal Towns Museum.

In the past, the Sussex County Council has generously supported the OVHS in our efforts to preserve the history of the Coastal Towns of lower Delaware. As we approach the final stages of the first phase of this capital campaign, the OVHS would like to once again request a grant in the amount of **\$5,000** from the Council to help us complete renovations on the inside of the Tunnel-West House. Grant funds would specifically be used to complete work on the living room and foyer of the house, allowing the OVHS to stay on target for a spring 2013 opening to the public.



I am writing to you representing Sussex Central Pop Warner. We are a local football and cheer organization and have been serving the youth of the Millsboro, Georgetown, and Long Neck communities for the last 40 years. We are a member of Henlopen Pop Warner, a league which serves the youth of Kent and Sussex counties as well as the Berlin and Salisbury areas.

We have 8 teams in our organization and serve over 200 children each year. This year we have a cheerleading squad with a possible opportunity to advance and compete in the Pop Warner National Cheer and Dance Championships at ESPN Wide World of Sports Complex in Disney World. This team of 31 girls, ages 11-15, has logged over 100 hours of practice, game and competition cheering so far this season to reach this point. They won our Henlopen competition on October 14<sup>th</sup> with the highest score of 53 total teams. They went to the Eastern Region Qualifiers on the 27<sup>th</sup> and placed 1<sup>st</sup> in the division and 6<sup>th</sup> overall out of 96 teams. If they finish 1<sup>st</sup> or 2<sup>nd</sup> in their division at the Regional Championship on November 18<sup>th</sup> they will qualify for the National Championship which runs from December 1-7. They would be the first team ever from our organization to accomplish this and just the 2<sup>nd</sup> from Henlopen.

However this once in a lifetime opportunity comes at a significant price which is why we need help. There is a mandatory 3 day stay required at the resort to compete with a 4 person per room maximum. The price per person is \$418.00 just for the room and passes. Our 31 girls require 11 chaperones so the total for rooms is \$17,556.00 and is due 5 days after we compete. When you add in plane tickets and meals we are staring at a \$30,000.00 total bill for the trip.

As stated we are a non-profit with many children to serve. Our funds do not allow us to pay for a trip this size or this expensive without the help of our communities. We would tremendously appreciate any funds you can assist with or any help you can give by spreading the word about this super talented, hard working group of girls. 

The attached comments relating to the public hearings are findings of the Planning and Zoning Commission based on a summary of comments read into the record, and comments stated by interested parties during the public hearings.

CU #1947 – application of **CHEER DELAWARE** to consider the Conditional Use of land in an AR-1 Agricultural Residential District for a public service building/use, to be located on a certain parcel of land lying and being in Broadkill Hundred, Sussex County, containing 4.35 acres, more or less, lying north of Broadkill Road (Route 16) 800 feet east of County Road (Road 22A) (Tax Map I.D. 2-35-14.00-122.02 and 122.04).

The Commission found that on October 15, 2012 the Applicants provided a Presentation Booklet for consideration that contains a presentation outline, with references to land use and zoning, land utilization, environmental, traffic, and civil engineering; a portion of the State Strategies map showing the site; a portion of the Future Land Use Map from the Comprehensive Plan showing the site; an aerial map labeled with other business and commercial uses in the area; a site plan; a portion of the Town of Milton Existing Zoning Map showing the site; a portion of a Flood Insurance Rate Map showing the site; and a DelDOT Support Facilities Report referencing that a traffic impact study is not recommended and that the current Level of Service “C” will not change as a result of this application.

The Commission found that on October 11, 2012 the Sussex Conservation District provided comments referencing that there are 2 soil types on this property; that the Applicant will be required to follow recommended erosion and sediment control practices during construction and to maintain vegetation; that no storm flood hazard areas and no tax ditches are affected; that it may not be necessary for any off-site drainage improvements; and that it may be possible that on-site drainage improvements will be required.

The Commission found that on October 19, 2012 the Sussex County Engineering Department Utility Planning Division provided comments referencing that the site is located in the North Coastal Planning Area; that use of an on-site septic system is proposed; that the project is not capable of being annexed into a County operated Sanitary Sewer District; that conformity to the North Coastal Planning Study will be required; that the proposed project is not in an area where the County has a schedule to provide sewer service; and that a concept plan is not required.

The Commission found that Ken Bock, Deputy Director of Cheer, was present on behalf of Cheer Delaware with Ring Lardner, Professional Engineer with Davis, Bowen and Friedel, Inc., and that they stated in their presentations and in response to questions raised by the Commission that they are submitting suggested proposed Findings of Fact and suggested proposed Conditions of Approval; that they are proposing a public use facility containing 6,000 square feet; that the two existing parcels will be combined into one parcel; that the site is located in a Level 3 according to the State Strategies; that the site is located in a Low-Density Area according to the County Comprehensive Land Use Plan; that maps in the Presentation Booklet depict other business and commercial uses in the area along Route 16; that Cheer Delaware has not yet purchased the site; that they are proposing to relocate the existing Cheer operation to this site from the current leased site at the intersection of Reynolds Pond Road and Broadkill Road; that the proposed 195 parking spaces may be reduced in number, if not needed; that the site is not located in a Flood Plain; that there are no wetlands identified on the site; that they have reviewed the site plan with DelDOT; that on-site well and on-site septic system are proposed; that a septic site evaluation has been completed and approved; that they are planning to use green technologies in designing the stormwater management facilities in cooperation with the Sussex Conservation District; that a lighted signage will not exceed 32 square feet per side; that they propose to serve the needs of the senior adults in the area; that the facility will have normal operating hours Monday through Friday from 8:00 a.m. to 4:00 p.m.; that they anticipate 3 to 4 full time employees; that there will be some evening activities, i.e. meals, bingo, conferences, occurring 1 or 2 times a month on weeknights; that they would like to provide space for weddings, banquets and conferences on weekends no more than once per month; that daily activities would include nutrient programs, games, crafts and similar activities for the senior population in the Milton area; that transportation will be made available when needed; that the facility will include a fitness center; that the current site is leased and does not have enough area for expansion; that a full commercial type kitchen will be provided to serve foods on site and to prepare foods for delivery to home bound seniors in the area; that the existing piped storm drain system was place near the rear of the site to correct a flooding issue several years ago in the area; that DelDOT did not require any turn lanes or by-pass lanes in the entrance design; that handicap spaces have been provided on the site plan; and that a dumpster location will be provided on the preliminary and final site plans if the use is approved.

The Commission found that there were no parties present in support of or in opposition to this application.

At the conclusion of the public hearings, the Commission discussed this application.

Mr. Burton stated that he would move that the Commission recommend approval of C/U #1947 for Cheer Delaware for a public service building based upon the record made during the public hearing and for the following reasons:

- 1) The site will be used as a Cheer center, which is a non-profit organization providing services to mature Sussex County residents.
- 2) The site is appropriate for this type of use, since it is located along Route 16, and is just outside the boundary of the Town of Milton.
- 3) The use is consistent with nearby uses, which include various types of small scale commercial businesses. It will not have any adverse effects upon neighboring properties or area roadways.
- 4) The use is a public service that promotes the health, safety, and welfare of Sussex County residents.
- 5) No parties appeared in opposition to the project.
- 6) DelDOT has no objection to the project.
- 7) This recommendation is subject to the following conditions:
  - A. The regular hours of operation shall be Monday through Friday from 8:00 a.m. through 4:00 p.m., with extended hours for special activities.
  - B. Meals-On-Wheels, a meal delivery service, is a part of Cheer's regular operations and services. This type of service shall be permitted on the site.
  - C. Special events (such as weddings and receptions, banquets, conferences, etc.) are part of Cheer's regular operations, and shall be permitted on the site and outside of regular operating hours.
  - D. Any lighting shall be downward screened so that it does not shine on neighboring properties or roadways.
  - E. One lighted sign, not to exceed 32 square feet in size per side, shall be permitted.
  - F. There may be full kitchen facilities on the site.
  - G. The location of a dumpster shall be shown on the Final Site Plan. It shall be screened from view of neighboring properties and roadways.
  - H. The Final Site Plan shall be subject to the review and approval of the Planning and Zoning Commission.

Motion by Mr. Burton, seconded by Mr. Johnson, and carried unanimously that this application be forwarded to the Sussex County Council with the recommendation that the application be approved for the reasons and with the conditions stated. Motion carried 5 – 0.

CZ #1722 – application of **ROBERT AND PATRICIA ROBINSON** to amend the Comprehensive Zoning Map from a LI-2 Light Industrial District to an AR-1 Agricultural Residential District to be located on a certain parcel of land lying and being in Broad Creek Hundred, Sussex County, containing 1.91 acres, more or less, lying west of Route 13A (Seaford Road), 1,300 feet north of Road 488 (Johnson Road) (Tax Map I.D. 1-32-6.00-186.01).

Mr. Lank advised the Commission that a Support Facilities Report was not requested from DelDOT since the application is a down zoning from Light Industrial to Agricultural Residential.

Mr. Lank added that this site was originally zoned AR-1 Agricultural Residential; and that the Applicants applied for rezoning to LI-2 Light Industrial (C/Z #854) and were approved so that the Applicants could erect a small store and warehousing for the sale and storage of dry and canned dog foods.

The Commission found that on October 11, 2012 the Sussex Conservation District provided comments referencing that there are 4 soil types on this property; that the Applicant will be required to follow recommended erosion and sediment control practices during construction and to maintain vegetation; that no storm flood hazard areas and no tax ditches are affected; and that it may not be necessary for any on-site or off-site drainage improvements.

The Commission found that on October 19, 2012 the Sussex County Engineering Department Utility Planning Division provided comments referencing that the site is located in the Blades Planning Area #2; that use of an on-site septic system is proposed; that the project is not capable of being annexed into a County operated Sanitary Sewer District; that the proposed project is located in the Blades Planning Area, but is not in an area where the County has a schedule to provide sewer service; and that a concept plan is not required.

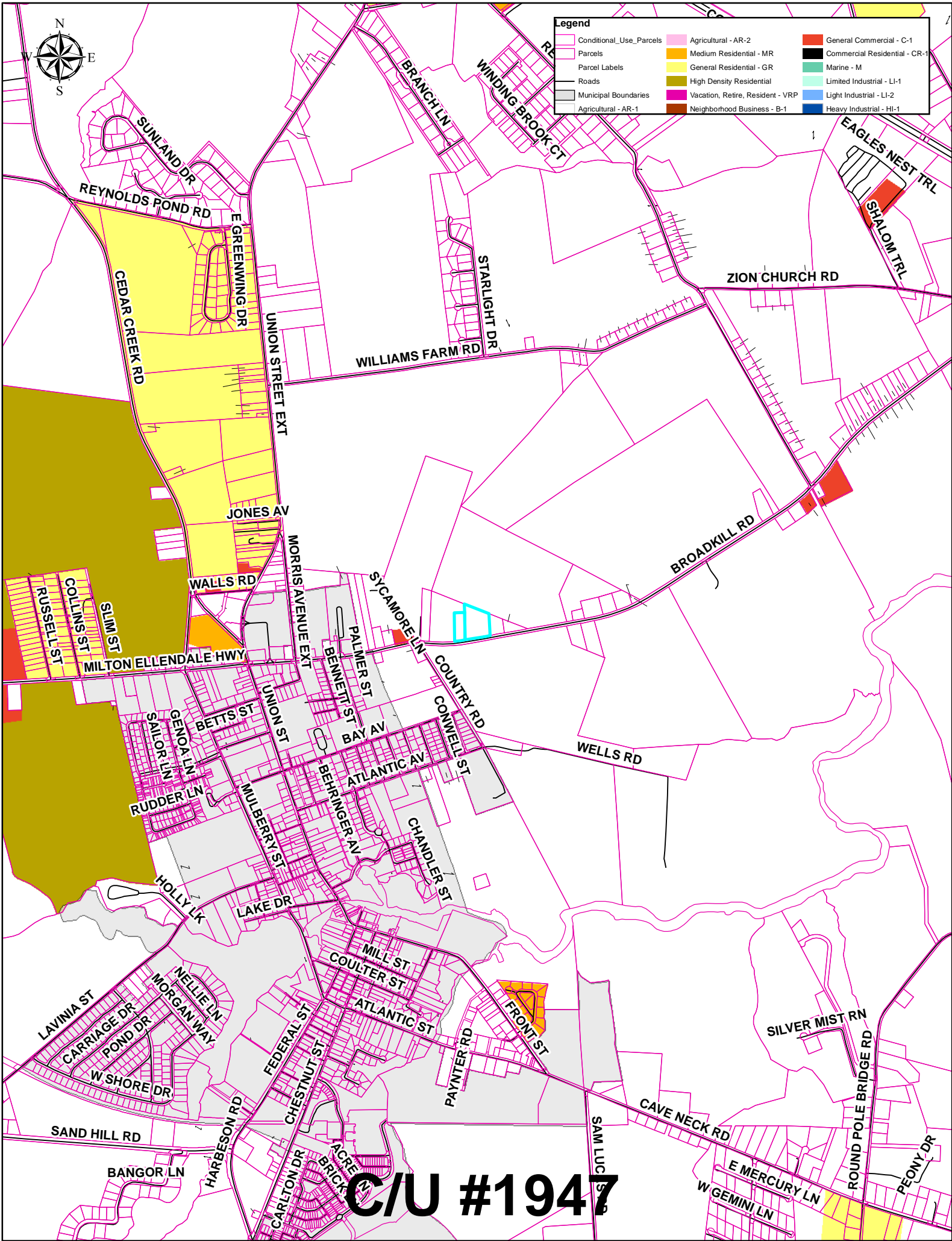
The Commission found that Robert Robinson was present and stated in his presentation that he no longer is operating a business on the site; that he has applied so that his taxes can be reduced; that there will be no adverse effects on traffic; and that there will be no adverse effect on property values.

The Commission found that there were no parties present in support of or in opposition to this application.

Mr. Johnson stated that he would move that the Commission recommend approval of C/Z #1722 for Robert and Patricia Robinson for a change in zone from LI-2 Light Industrial to AR-1 Agricultural Residential based on the record made at the public hearing and for the following reasons:

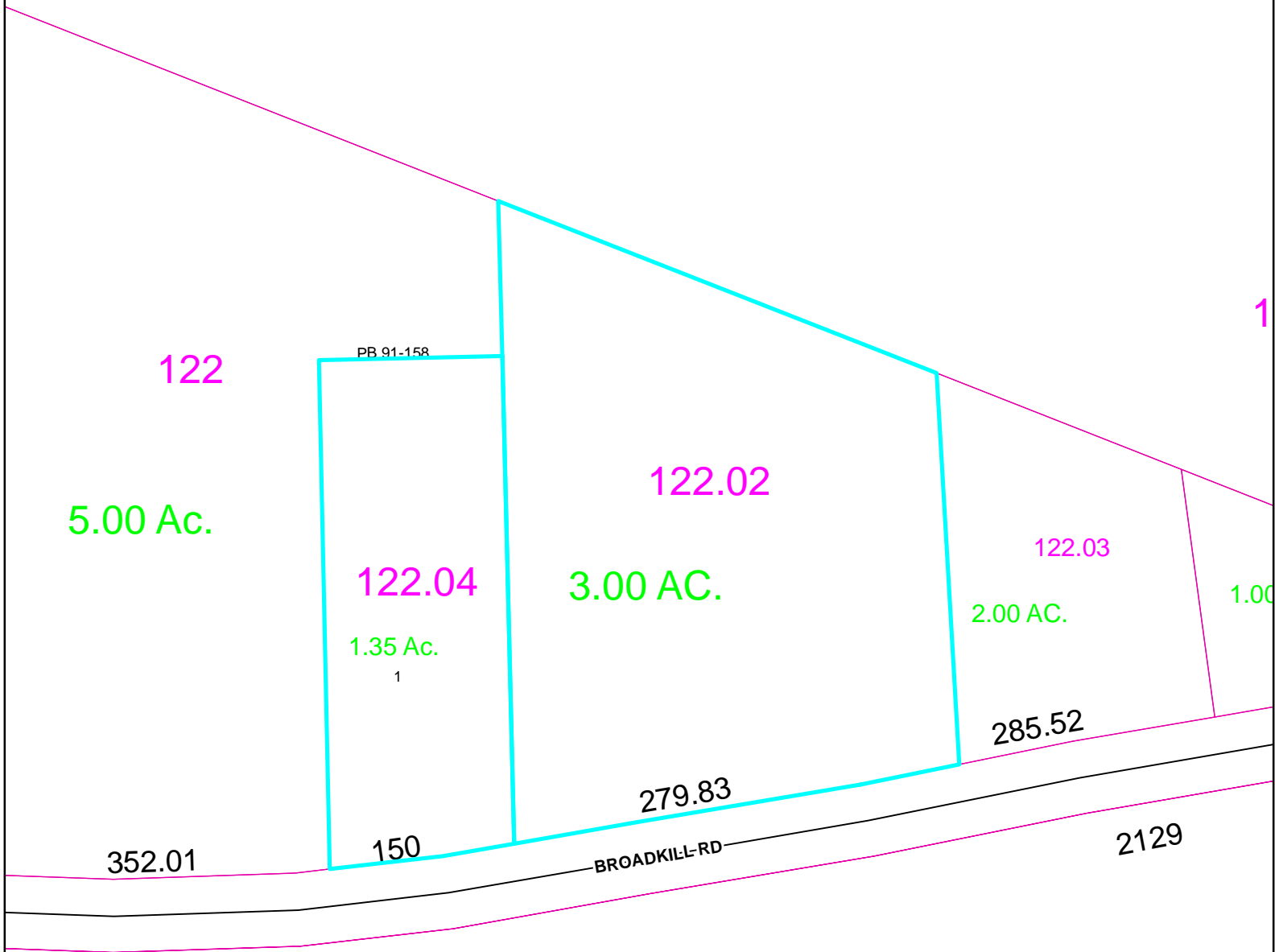
- 1) The application is for a downzoning that returns the property to its original AR-1 zoning.
- 2) The return to AR-1 zoning is consistent with surrounding uses and zonings.
- 3) The Applicant no longer intends to use the property for industrial purposes, so it is appropriate to eliminate the potential industrial uses that could occur there.
- 4) AR-1 zoning is appropriate, since the Applicant resides there, and the only use that occurs there is low-density residential use.
- 5) The downzoning will have no negative impact on neighboring properties or roadways.

Motion by Mr. Johnson, seconded by Mr. Burton, and carried unanimously to forward this application to the Sussex County Council with the recommendation that the application be approved for the reasons stated. Motion carried 5 – 0.

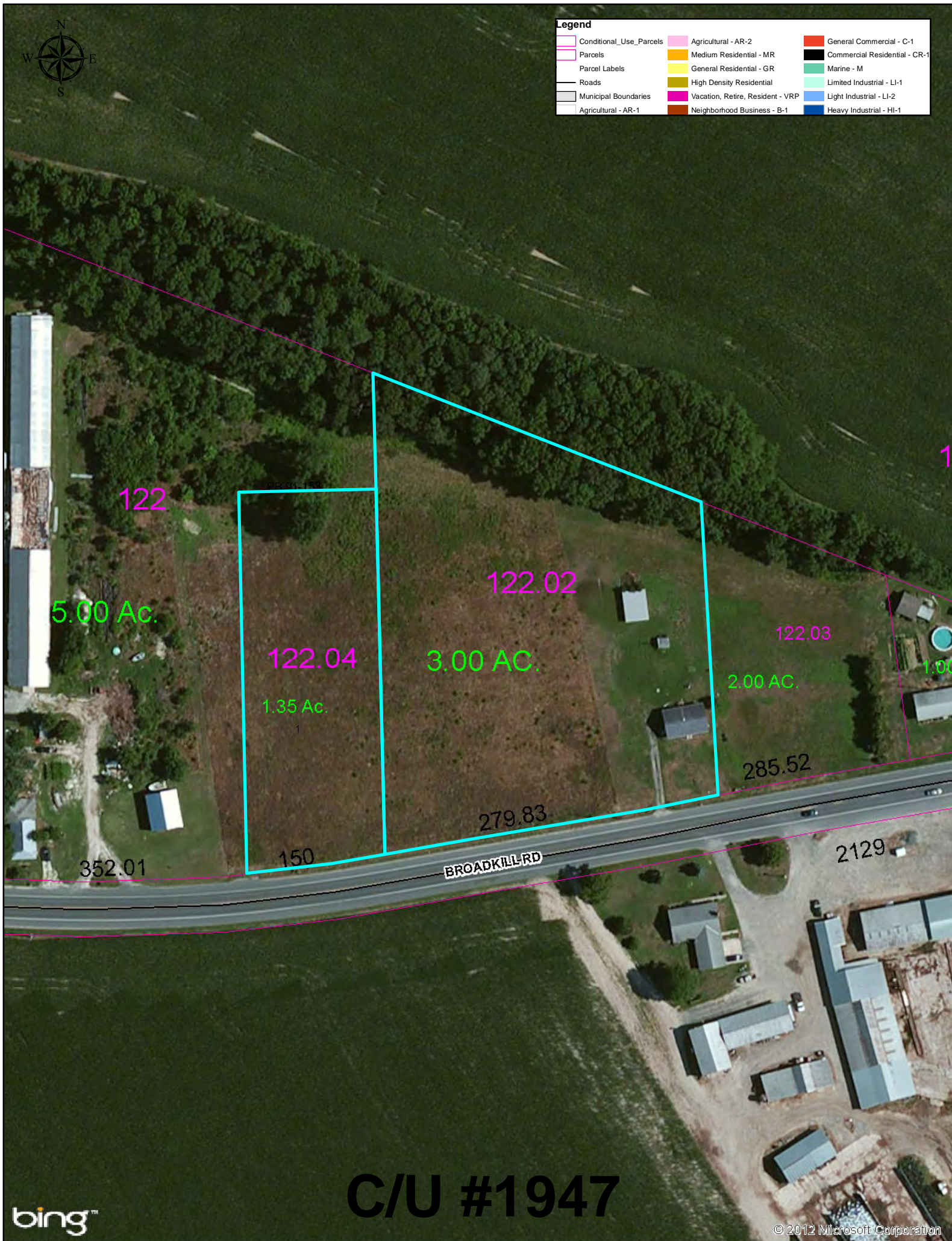

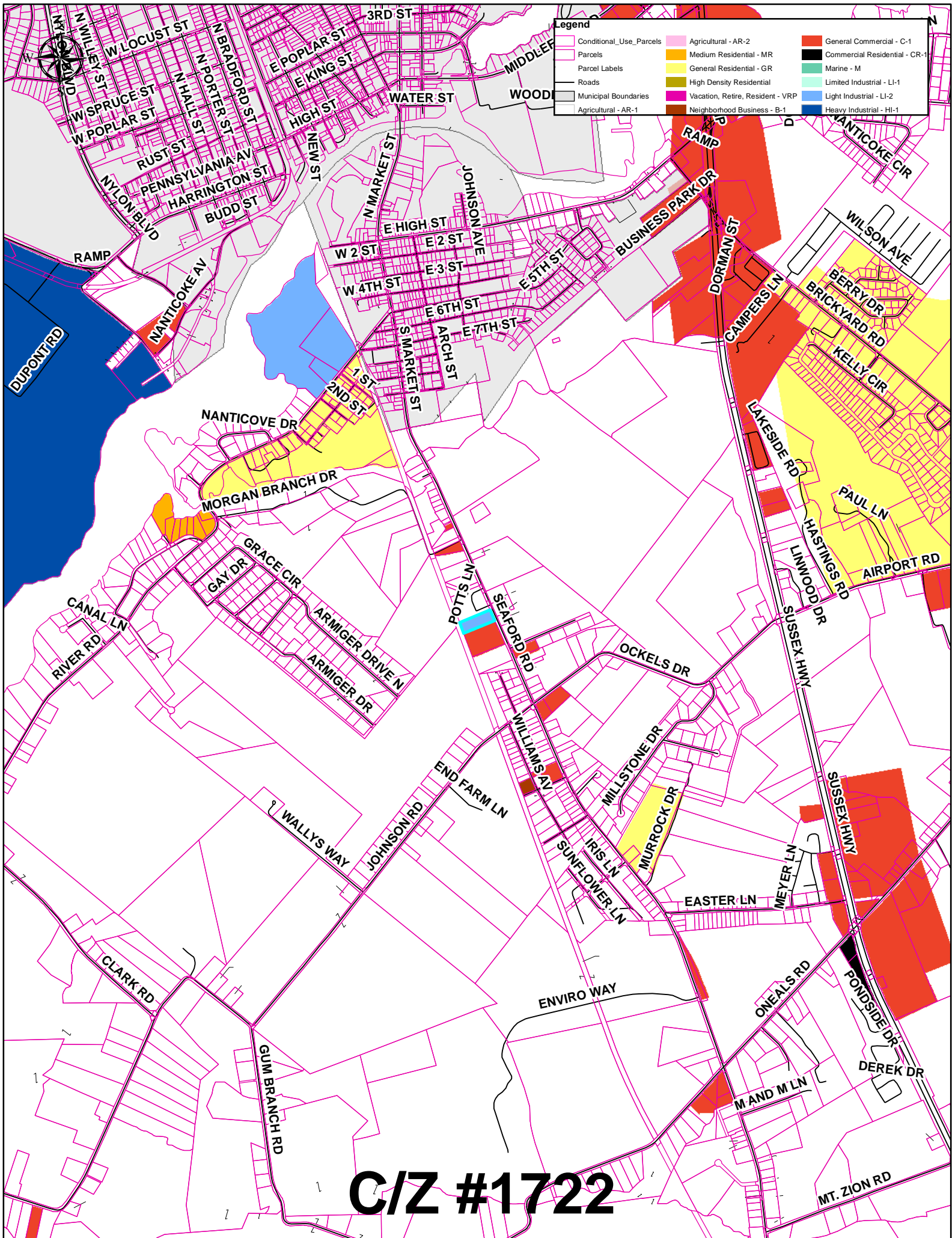
