

RESOLUTION NO. R 005 76

AUTHORIZING WILLIAM C. HENRY TO APPLY FOR GRANTS, FRANCHISES AND OTHER LICENSES AND PERMITS AS REQUIRED FOR THE SANITARY SEWER DISTRICTS

WHEREAS, the eligible voters of the Henlopen Acres, the Fenwick Island Water and Sanitary Sewer District, the Towns of Frankford and Dagsboro and the Town of Blades did approve the establishment of sanitary sewer and/ or water districts by County Council of Sussex County; and

WHEREAS, County Council of Sussex County did in accordance with Chapter 65, Title 9 of the Delaware Code establish sanitary sewer and/or water idstricts within these areas; and

WHEREAS, County Council of Sussex County did establish the John M. LeCato Sanitary Sewer District; and

WHEREAS, the City of Rehoboth, the City of Lewes, and the Town of Milton did contract with County Council of Sussex County to become a part of the John M. LeCato Sanitary Sewer District; and

WHEREAS, County Council of Sussex County is planning for the construction of sewer facilities for the Long Neck area, West Rehoboth, and Greenwood; and

WHEREAS, County Council of Sussex County herein called the "Applicant", after thorough consideration of the various aspects of the problem and study of available date, has hereby determined that construction of certain works, required for the collection, treatment and discharge of sewage and the collection, acquisition, treatment, purification and distribution of water is desirable and in the public interest; and

WHEREAS, under the Federal Water Pollution Control Act, as amended, the United States Environmental Protection Agency has authorized the making of grants to aid in financing the cost of construction of necessary collection facilities to prevent the discharge of untreated or inadequately treated sewage or other

waste into any waters and for the purpose of reports, plans, and specifications in connection therewith,

NOW, THEREFORE,

BE IT RESOLVED that County Council of Sussex County hereby authorizes William C. Henry, Sussex County Engineer, to apply for and accept grants, loans, franchises, work permits, and all other licenses and permits that may be required by the Environmental Protection Agency, the Corps of Engineers, as well as other Federal Agencies and State of Delaware Agencies, for the construction of the following projects:
