A RESOLUTION TO EXTEND THE BOUNDARY OF THE SOUTH BETHANY SANITARY SEWER DISTRICT (SBSSD) TO ENCOMPASS A CERTAIN PIECE, PARCEL, OR TRACT OF LAND ON MUDDY NECK, LYING CONTIGUOUS TO THE SBSSD, SITUATE WEST OF THE TOWN OF SOUTH BETHANY AND BEING IN BALTIMORE HUNDRED, SUSSEX COUNTY DELAWARE.

WHEREAS, Sussex County has established the SBSSD; and

WHEREAS, in the best interests of the present district, and to enhance the general health and welfare of that portion of Sussex County west of the Town of South Bethany, the inclusion of this property will be beneficial; and

WHEREAS, in accordance with 9 <u>Del.C.</u>, Section 6502 (a), the Sussex County Council may, upon request of the County Engineer, revise the boundary of an established sewer district when 50 or more houses have been connected by posting a public notice in four public places in the district describing the new or revised boundary; and

WHEREAS, the Sussex County Council has caused to be posted a public notice in at least four public places in the district, as verified by the affidavit of Anthony DiGiuseppe, a copy of which affidavit and public notice is attached hereto and made a part hereof; and

WHEREAS, in accordance with 9 <u>Del.C.</u>, Section 6502 (b), the Sussex County Council shall, within thirty days after posting the public notices pass a formal resolution establishing the new boundary of the district;

NOW, THEREFORE,

BE IT RESOLVED the Sussex County Council hereby revises the boundary of the SBSSD to encompass the Clearwater subdivision, which lies between County Roads 361 and 363, as follows:

BEGINNING at a concrete marker on the southerly right-of-way (ROW) line of County Route 361, said marker being a corner for these lands and lands now or formerly (N/F) of Tavaldis Berzins, et ux., and being located approximately 1,510 feet west of the intersection with the centerline of County Route 363; thence South

14 degrees 28 minutes 01 second West by and with the lands N/F of Tavaldis Berzins, et ux. a distance of 942.27 feet to a concrete block; thence North 89 degrees 49 minutes 32 seconds East by and with the lands N/F of Tavaldis Berzins, et. ux. a distance of 409.53 feet to a stone; thence South 02 degrees 41 minutes 30 seconds West by and with the lands N/F of Tavaldis Berzins, et ux. a distance of 337.61 feet to a stone; thence South 31 degrees, 31 minutes, 28 seconds East by and with the lands N/F of Tavaldis Berzins, et ux. a distance of 380 feet to a point where it meets the northwestern property corner of lands N/F of James P. III & Janice H. Robinson; thence South 31 degrees 31 minutes 28 seconds East by and with the lands N/F of James Robinson, et ux. a distance of 302.73 feet through a concrete marker to a point in the center of "Little Bay Tax Ditch," said point also being the northernmost property corner of lands N/F of James Cullen; thence proceeding in a southwesterly and southerly direction, respectively, by and with lands N/F of James Cullen to a point on the northerly ROW of County Route 363; thence South 75 degrees 48 minutes 46 seconds West by and with County Route 363 a distance of 1,120 feet to an iron pipe on the northerly ROW of County Route 363; thence North 17 degrees 54 minutes 59 seconds West by and with Ocean Farms Subdivision a distance of 1,335.18 feet to an iron pipe; thence North 89 degrees 04 minutes 59 seconds West by and with the Ocean Farms Subdivision a distance of 825.85 feet to a stone; thence North 23 degrees 08 minutes 26 seconds East by and with the Foxfire Meadows Subdivision a distance of 1,067.97 feet to a point; thence North 21 degrees 49 minutes 05 seconds East by and with the lands N/F of Leo M. Donohoe a distance of 369.73 feet to an iron pipe on the southerly ROW of County Route 361; thence South 70 degrees 42 minutes 02 seconds East by and with County Route 361 a distance of 1,283.05 feet to a point of BEGINNING.

BE IT FURTHER RESOLVED that the Sussex County Council directs the County Engineer and the Attorney for the County Council to procure the necessary lands and rights-of-way by purchase,

agreement, or condemnation in accordance with the existing statutes;

BE IT FURTHER RESOLVED that the County Engineer is hereby directed to prepare maps, plans, specifications, and estimates, elect contracts for and supervise the construction and maintenance of, or enlarging and remodeling of, any and all structures required to provide for the safe disposal of sewage in the sanitary sewer district, as amended.

PROPOSED EXPANSION TO THE SOUTH BETHANY SANITARY SEWER DISTRICT

NOTICE IS HEREBY GIVEN that the Sussex County Council voted on December 21, 1993 to consider extending the South Bethany Sanitary Sewer District (SBSSD) to include a certain piece, parcel, or tract of land owned by Clearwater Land, Ltd. on Muddy Neck lying contiguous to the SBSSD, situate west of the Town of South Bethany and being in Baltimore Hundred, Sussex County, Delaware.

This action is in conformity with 9 Del.C., Section 6502.

A description of the property which is contiguous to and to be added to the SBSSD is described as follows:

Beginning at a concrete marker on the southerly right-of-way (ROW) line of County Route 361, said marker being a corner for these lands and lands now or formerly (N/F) of Tavaldis Berzins, et ux., and being located approximately 1,510 feet west of the intersection with the centerline of County Route 363; thence South 14 degrees 28 minutes 01 second West by and with the lands N/F of Tavaldis Berzins, et ux. a distance of 942.27 feet to a concrete block; thence North 89 degrees 49 minutes 32 seconds East by and with the lands N/F of Tavaldis Berzins, et ux. a distance of 302.61 minutes 30 seconds West by and with the lands N/F of Tavaldis Berzins, et ux. a distance of 337.61 feet to a stone; thence South 31 degrees, 31 minutes, 28 seconds East by and with the lands N/F of Tavaldis Berzins, et ux. a distance of 380 feet to a point where it meets the northwestern property corner of lands N/F of James P. III & Janice H. Robinson; thence South 31 degrees 31 minutes 28 seconds East by and with the lands N/F of James Cullen; thence proceeding in a southwesterly and southerly direction, respectively, by and with lands N/F of James Cullen to a point on the northerly ROW of County Route 363; thence South 17 degrees 48 minutes 46 seconds West by and with Cocan Farms Subdivision a distance of 1,235.18 feet to an iron pipe on the northerly ROW of County Route 363; thence North 17 degrees 59 seconds West by and with the Foxfire Meadows Subdivision a distance of 1,667.97 feet to a point; thence North 89 degrees 04 minutes 59 seconds East by and with the Foxfire Meadows Subdivision a distance of 1,667.97 feet to a point; thence South 70 degrees 42 minutes 05 seconds East by and with the South 21 degrees 44 minutes 59 seconds East by and with the Southerly ROW of County Route 363; thence North 17 degrees 54 minutes 26 seconds East by and with the foxfire Meadows Subdivision a distance of 1,667.97 feet to a point; thence North 21 degrees 49 minutes 05 seconds East by and with County Route 361; thence South 70 degrees 42 minutes

The proposed expansion of the SBSSD is within these boundaries. The boundary description has been prepared using Sussex County Tax Map No. 1-34-17, and information provided by Land Tech, Inc. in a letter dated December 15, 1993.

A map outlining and describing the extension of the SBSSD is attached. The area involved is crosshatched.

The public hearing will be held on this issue at 11:00 a.m. on Tuesday, January 25, 1994 in the Sussex County Council Chambers, Room 115, The Courthouse, Georgetown, Delaware. All interested persons, officials, residents, voters, taxpayers, property owners, or corporations in any way affected by this boundary extension are welcome to attend. There will be an opportunity for questions and answers. The final decision on the boundary extension will be made by the Sussex County Council following the hearing at one of their regularly scheduled meetings.
