RESOLUTION TO ACCEPT AND APPROVE THE COASTAL SUSSEX WATER QUALITY MANAGEMENT PLAN (DATED JANUARY 19, 1978)

WHEREAS, the Sussex County Council did show its intent through adoption of Resolution Number R 005 74 and did join together in the planning process through participation in the Coastal Sussex Water Quality Program Planning Policy Board to develop a water quality management plan (hereinafter called the "Plan") which will result in a coordinated waste treatment management system for the Coastal Sussex Water Quality Program Planning Area, (hereinafter called the "Area"), as shown on the attached map and as required in C.F.R. 126.10; and

WHEREAS, the Sussex County Council has agreed to undertake the responsibility of grantee and manager of the Coastal Sussex Water Quality Program; and

WHEREAS, such planning process and waste treatment management system is a necessary and significant measure to control present point and non-point sources of water pollution in order to prevent, abate, and solve existing and potential substantial water quality control problems; and

WHEREAS, the State of Delaware Department of Natural Resources and Environmental Control and the United States Environmental Protection Agency, Region III, have shown an interest in working with and through the affected general purpose units of local government within the Coastal Area to implement the Plan; and

WHEREAS, the Coastal Sussex Water Quality Program Planning Policy Board has approved the Plan and recommended approval by the Sussex County Council;

NOW, THEREFORE,

BE IT RESOLVED that the Sussex County Council approves and accepts the Coastal Sussex Water Quality Management Plan (dated January 19, 1978) with the name of the COASTAL SUSSEX WATER QUALITY BOARD being changed to the COASTAL SUSSEX WATER QUALITY ADVISORY BOARD wherever same appears, and the existing PLANNING DIVISION and the proposed WATER QUALITY PLANNING DIVISION of the Sussex County Engineering Department are consolidated into one division named the WATER QUALITY PLANNING DIVISION.
