

RESOLUTION NO. R 008 90

A RESOLUTION ESTABLISHING THE DATE, TIME AND PLACE OF A REFERENDUM TO BE HELD TO CONSIDER THE QUESTION OF ESTABLISHING THE PROPOSED FIELDWOOD ADDITION STREET LIGHTING DISTRICT.

WHEREAS, the Sussex County Council adopted Sussex County Ordinance No. 15 on June 18, 1974 providing for the establishment, maintenance and modification of street lighting districts; and

WHEREAS, on September 19, 1989 the Sussex County Council approved the circulation of a petition to establish a street lighting district for the Fieldwood Addition to Tru-Vale Acres; and

WHEREAS, a petition was received from 16 legal voters of the proposed Fieldwood Addition Street Lighting District requesting the Sussex County Council to submit the question of organizing a street lighting district to a vote of electors residing in the area, a map of the proposed district boundaries is attached as Exhibit "A"; and

WHEREAS, the estimated charges for the proposed street lighting district are \$23.66 per year per residential or business structure located within the boundaries of the "Fieldwood Addition Street Lighting District".

NOW, THEREFORE,

BE IT RESOLVED that the Sussex County Council does establish Wednesday, March 28, 1990 between the hours of 10:00 a.m. and 7:00 p.m. in Council Chambers, Sussex County Courthouse, The Circle, Georgetown, Delaware as the date, time and place for the referendum to consider the question, "Do you support the formation of the Fieldwood Addition Street Lighting District?"; and

BE IT FURTHER RESOLVED that the judge of the election shall be Robert W. Wood, P.E., Sussex County Engineer; and

BE IT FURTHER RESOLVED that any person who is the owner of an improved structure for residential or business use located within the "Fieldwood Addition Street Lighting District" may vote in the election; and each structure meeting the requirements and owned jointly, severally, or by tenants-in-common shall entitle the owner(s) to one (1) vote in the election; and

BE IT FURTHER RESOLVED that eligible voters unable to appear in person at the time and place of the election may obtain absentee ballots from the Sussex County Engineering Department, The Courthouse Annex, Race and Pine Streets, Georgetown, Delaware or by calling (302) 855-7717, extension 283. Absentee ballots must be obtained, executed and notarized, and mailed or delivered to the Sussex County Engineering Department in sufficient time to be received by 10:00 a.m. on the date of the election.

BE IT FURTHER RESOLVED that the Sussex County Council directs the County Engineer to notify voters of the date, time and place of the election, including the estimated costs and charges by posting a notice in at least four (4) public places within the proposed street lighting district at least ten days before the election, and by either direct mail to the voters of record twenty days before the day of the election or by advertisement in a newspaper in general circulation in the area in which the proposed lighting district is located once in each of two consecutive weeks prior to the week in which the election is to be held.
