ENDORSING PROJECTS TO BE SUBMITTED TO THE DELAWARE STATE HOUSING AUTHORITY FOR FUNDING FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND AUTHORIZING ROBERT L. STICKELS, COUNTY ADMINISTRATOR, TO SUBMIT APPLICATIONS

WHEREAS, The Sussex County Council resolves to apply for Community Development funds from the Delaware State Housing Authority in accordance with appropriate regulations governing Community Development Block Grants State of Delaware Program for Block Grants as contained in (Section 570.488-499 24 CFR U.S. Department of Housing and Urban Development); and

WHEREAS, Sussex County has met the application requirements of (Attachment E Delaware Community Development Block Grant Program Policies and Procedures) citizen participation requirements; and

WHEREAS, Sussex County is eligible to submit applications for such grants through the Delaware State Housing Authority as stated in the policies and procedures manual dated FY 2005 of the Delaware Community Development Block Grant Program in the earmarked amount of \$1,100,000 each grant for counties and \$1,100,000 each grant for municipalities, except for infrastructure.
