

RESOLUTION NO. R 011 98

A RESOLUTION ESTABLISHING KEENWICK WEST STREETLIGHTING DISTRICT

WHEREAS, the attached referendum results certify that the Keenwick West Streetlighting District was approved by a majority vote in a referendum held on January 24, 1998; and

WHEREAS, Sussex County Code, Section 95, requires the County Council to issue a determination establishing the District in the form of a Resolution;

NOW, THEREFORE,

BE IT RESOLVED that the Sussex County Council hereby determines that the eligible voters of the Keenwick West Streetlighting District have approved the creation of said District; that the properties included in the District are shown on Sussex County Tax Map Nos. 5-33-12.19 Parcels 10 through 33; 5-33-19.07 Parcels 1 through 98; and 5-33-19.08 Parcels 1 through 10; that said District is hereby declared to be validly constituted under the provisions of Sussex County Code, Section 95; and that the Director of Finance is authorized and directed to bill the owners of all assessable structures within said District in accordance with Sussex County Code, Section 95.


