

RESOLUTION NO. R 015 85

WHEREAS, in accordance with Title 9, Delaware Code, Section 6505, the Sussex County Council adopted Resolution No. R 078 84 on October 23, 1984 establishing the boundaries of the West Rehoboth Sanitary Sewer District; and

WHEREAS, the Sussex County Council pursuant to Title 9, Delaware Code, Section 6505 directed the the County Engineer to have prepared an estimate of cost of proposed construction and an approximate estimate of the assessment per front foot and the amount to be included in the assessment necessary to take care of interest amortization and cost of construction and financing; and

WHEREAS, Sussex County Council, through the County Engineer, entered into an agreement with the consulting firm of George, Miles and Buhr to prepare the necessary cost estimates; and

WHEREAS, the draft planning study has been prepared and will be finalized by March 29, 1985; and

WHEREAS, in accordance with Title 9, Delaware Code, Section 6506, the Sussex County Council shall cause an election be held within six (6) months following the date of the hearing, at which time the question shall be submitted to the voters of the sanitary sewer district as fixed by the Sussex County Council as to whether the district shall be established or not; and

WHEREAS, in accordance with Title 9, Delaware Code, Section 6504, notice of the election shall be advertised by posting a notice in four (4) of the most public places within the district boundaries, at least ten (10) days prior thereto and by publishing a notice in a newspaper published within the County and having general circulation therein once in each of the two (2) weeks immediately preceding the week in which the election is to be held,

NOW, THEREFORE,

BE IT RESOLVED by the Sussex County Council:

That advertisement of the public hearing and the referendum dates including estimated services and assessment charges shall appear in State and County newspapers on March 27, 1985 and April 3, 1985;

That the final West Rehoboth Planning Study shall be made available for public review on March 29, 1985;

That a public hearing on the West Rehoboth Sanitary Sewer District Planning Study shall be held on April 9, 1985 at 7:00 P.M. in Rehoboth Beach Convention Hall;

That the first referendum on the Question "Do you support the creation of a West Rehoboth Sanitary Sewer District?" be held on April 13, 1985 in the Rehoboth Beach Commissioner's Chambers between 11:00 A.M. and 7:00 P.M.;

That a second referendum, if the first is approved, on the Question "Which method of discharge of treated wastewater do you support?" be held on April 20, 1985 between 11:00 A.M. and 7:00 P.M. in Rehoboth Beach Convention Hall.
