

RESOLUTION NO. R 024 02

A RESOLUTION ESTABLISHING THE DATE, TIME, AND PLACE FOR A PUBLIC HEARING TO BE HELD TO CONSIDER THE REQUEST FOR INSTALLATION OF ADDITIONAL STREETLIGHTING IN THE OAK MEADOWS STREETLIGHTING DISTRICT

WHEREAS, Chapter 95 of the Sussex County Code provides for the establishment, maintenance, and modification of a streetlighting district; and

WHEREAS, Sussex County currently operates the Oak Meadows Streetlighting District; and

WHEREAS, on September 14, 2000, a letter was received from Oak Meadows Owner's Association requesting the installation of additional streetlighting; and

WHEREAS, the Sussex County Engineering Department and Conectiv, Inc. presented a final layout and cost estimate for additional streetlighting to the Oak Meadows Owner's Association meeting on June 22, 2002; and

WHEREAS, on July 11, 2002, a letter was received from the Oak Meadows Owner's Association, requesting Sussex County Engineering Department to amend the layout and cost estimate as voted on by their Association, and then proceed with the request to install additional streetlighting in accordance with Chapter 95 of the Sussex County Code;

NOW, THEREFORE, BE IT RESOLVED that the annual billing rate for the installation of additional streetlighting in the existing district is estimated to be \$63.93 for the first year and \$32.63 after the first year, for each property having a residential or commercial improvement located within the boundaries of the Oak Meadows Streetlighting District; and

BE IT FURTHER RESOLVED that the Sussex County Council does establish Tuesday, September 10, 2002, at 10:45 a.m., at the Sussex County Council Chambers in the Sussex County Administrative Office Building, 2 The Circle, Georgetown, Delaware as the date, time, and place for the public hearing to consider the request for the installation of additional streetlighting in the Oak Meadows Streetlighting District; and

BE IT FURTHER RESOLVED that a final decision on this request will be made by the Sussex County Council immediately following the public hearing on September 10, 2002; and

BE IT FURTHER RESOLVED that the Sussex County Engineering Department is directed to provide appropriate notice to the property owners within the Oak Meadows Streetlighting District, of the date, time, and place of the public hearing, and the estimated costs and charges for the installation of the additional streetlighting, as required by Chapter 95 of the Sussex County Code.
