

RESOLUTION NO. R 027 00

A RESOLUTION PROVIDING FOR MODIFICATIONS IN THE HARBESON STREETLIGHTING DISTRICT

WHEREAS, Sussex County Code, Section 95-7, permits the modification of streetlighting districts; and

WHEREAS, Sussex County currently operates and maintains the Harbeson Streetlighting District; and

WHEREAS, the Sussex County Council received a letter dated March 30, 2000 from Ms. Sharon S. Joseph, Secretary, Harbeson Improvement Association, requesting the replacement of the existing mercury vapor streetlights with high-pressure sodium streetlights; and

WHEREAS, the Sussex County Council has caused to be posted a public notice in at least four public places in the district, as verified by the affidavit of Chris Calio, a copy of which affidavit and public notice is attached hereto and made a part hereof;

NOW, THEREFORE,

BE IT RESOLVED, after consideration of statements made at the public hearing, the Sussex County Council directs the County Engineer to have the high-pressure sodium streetlights installed.

**NOTICE OF PUBLIC HEARING
PROPOSED STREETLIGHTING DISTRICT MODIFICATIONS
TO THE HARBESON STREETLIGHTING DISTRICT**

Notice is hereby given that the Sussex County Council voted on July 18, 2000 to consider modifications to the Harbeson Streetlighting District. The modifications include upgrading the current 100-Watt Mercury Vapor streetlights with 100-Watt High-Pressure Sodium streetlights. If the modifications are approved, the annual cost is estimated to increase approximately \$5.64 per home. This increase will result in an annual bill of approximately \$24.76 per home and will not appear on a bill until 2001.

This action is in conformity with the Sussex County Code, Section 95-4C(3).

The public hearing will be held on this issue at 11:00 a.m. on Tuesday, August 22, 2000 in the Sussex County Council Chambers, Sussex County Administrative Offices, 2 The Circle, Georgetown, Delaware. All interested persons, officials, residents, voters, taxpayers, property owners, or corporations in any way affected by this modification are welcome to attend. There will be an opportunity for questions and answers. The final decision on the proposed modifications will be made by the Sussex County Council following the hearing at one of their regularly scheduled meetings.
