A RESOLUTION TO EXTEND THE BOUNDARY OF THE DAGSBORO-FRANKFORD SANITARY SEWER DISTRICT (DFSSD) TO INCLUDE DELAWARE AVENUE EXTENDED, LYING EAST OF STATE OF DELAWARE ROUTE 113 AND SOUTH OF THE TOWN OF FRANKFORD, AND BEING IN DAGSBORO HUNDRED, SUSSEX COUNTY, DELAWARE

WHEREAS, Sussex County has established the Dagsboro-Frankford Sanitary Sewer District; and

WHEREAS, in the best interests of the present district, and to enhance the general health and welfare of that portion of Sussex County south of the Town of Frankford, which includes Delaware Avenue Extended, which is contiguous to the DFSSD, the inclusion of this property will be beneficial; and

WHEREAS, in accordance with 9 <u>Del.C.</u>, Section 6502 (a), the Sussex County Council may, upon request of the County Engineer, revise the boundary of an established sewer district when 50 or more houses have been connected by posting a public notice in four public places in the district describing the new or revised boundary; and

WHEREAS, the Sussex County Council has caused to be posted a public notice in at least four public places in the district, as verified by the affidavit of Chris Calio, a copy of which affidavits and public notice is attached hereto and made a part hereof; and

WHEREAS, in accordance with 9 <u>Del.C.</u>, Section 6502 (b), the Sussex County Council shall, within thirty days after posting the public notices pass a formal resolution establishing the new boundary of the district;

NOW, THEREFORE,

BE IT RESOLVED the Sussex County Council hereby revises the boundary of the Dagsboro-Frankford Sanitary Sewer District to encompass Delaware Avenue Extended, as follows:

Beginning at a point, said point being on the DFSSD boundary, said point also being on the property line of lands Now or Formerly (N/F) of Timothy W. & Stacey L. Purnell; thence proceeding by and with said Purnell lands in a southerly direction a distance of 302

feet more or less to a point, said point being a property corner of lands N/F of Timothy W. & Stacey L. Purnell; thence proceeding by and with said Purnell lands in an easterly direction a distance of 603 feet more or less to a point, said point being a property corner of lands N/F Harvey L. & Joann E. Jenkins; thence continuing by and with said Jenkins lands in a southwesterly direction a distance of 92 feet more or less to a point, said point being a property corner of lands N/F Wesley H. Hayes Sr.; thence proceeding by and with said Hayes lands in a southwesterly direction a distance of 876 feet more or less to a point, said point being the northwesterly property corner of lands N/F of Alice Godwin-Smith; thence proceeding by and with said Godwin-Smith lands in a southwesterly direction a distance of 100 feet more or less to a point, said point being the northwesterly property corner of lands N/F of Hilton Spence, thence proceeding by and with said Spence lands in a southerly direction a distance of 238 feet more or less to a point, said point being a property corner of lands N/F Fentrel L. & Barbara Church; thence proceeding by and with said Church lands in an easterly direction a distance of 251 feet more or less to a point, said point being on the westerly Right-of-way ROW of State Road 54A; thence proceeding in a straight line in an easterly direction a distance of 50 feet more or less to a point, said point being on the easterly ROW of State of Delaware Route 54A; thence proceeding by and with said ROW in a northerly direction a distance of 1287 feet more or less to a point, said point being on the easterly ROW of Penn Central Railroad, thence proceeding by and with said Penn Central ROW in a southerly direction a distance of 211 feet more or less to a point, said point being on the westerly ROW of Penn Central Railroad; thence proceeding in a straight line in an easterly direction a distance of 70 feet more or less to a point, said point being on the easterly ROW of Penn Central Railroad, said point also being the southernmost property corner of lands N/F of Dora Bell; thence proceeding by and with said Bell lands in an easterly and northerly direction respectively a distance of 472 feet to a point, said point being on the Dagsboro-Frankford Sanitary Sewer District Boundary; thence proceeding by and with said Boundary in a westerly direction a distance of 1312 feet more or less to the point of BEGINNING.

PROPOSED EXPANSION TO THE DAGSBORO-FRANKFORD SANITARY SEWER DISTRICT

NOTICE IS HEREBY GIVEN that the Sussex County Council voted on November 6, 2001 to consider extending the Dagsboro-Frankford Sanitary Sewer District (DFSSD) to include an area along Delaware Avenue Extended, situate, lying east of State of Delaware Route 113 and south of the Town of Frankford, and being in Dagsboro Hundred, Sussex County, Delaware

This action is in conformity with 9 Del.C. §6502.

A description of the area, which is contiguous to and to be added to the DFSSD is described as follows:

The proposed expansion of the DFSSD is within these boundaries. The boundary description has been prepared using Sussex County Tax Map No. 4-33 11.00.

A map outlining and describing the expansion of the DFSSD is attached. The area involved is crosshatched.

The public hearing will be held on this issue at 11:00 a.m. on December 4, 2001 in the Sussex County Council Chambers, County Administrative Offices, 2 The Circle, Georgetown, Delaware. All interested persons, officials, residents, voters, taxpayers, property owners, or corporations in any way affected by this boundary expansion are welcome to attend. There will be an opportunity for questions and answers. The final decision on the boundary expansion will be made by the Sussex County Council following the hearing, at one of their regularly scheduled meetings.
