RESOLUTION NO. R 031 80

A RESOLUTION TO DENY A CONDITIONAL USE OF LAND IN AN AGRICULTURAL RESIDENTIAL DISTRICT FOR A FLEA MARKET TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN BROADKILL HUNDRED, SUSSEX COUNTY, CONTAINING ONE ACRE, MORE OR LESS

WHEREAS, on the 10th day of June, A.D. 1980, an application for a Conditional Use of land in an AR-1 Agricultural Residential District for a Flea Market, denominated C/U #585, was filed on behalf of Martin Schmidt; and

WHEREAS, on the 10th day of July, A.D. 1980, a public hearing, after notice, was held before the Planning and Zoning Commission of Sussex County and said Commission recommended that C/U #585 be denied; and

WHEREAS, on the 29th day of July, A.D. 1980, a public hearing, after notice, was held before the County Council of Sussex County on C/U #585 and, having heard and considered the public comments made at such a hearing and the County Council having found as follows:

- (a) That the Conditional Use applied for may not be for the general convenience and welfare of the inhabitants of Sussex County;
- (b) That the location is not appropriate for the Conditional Use applied for and is not in conflict with the Comprehensive Plan;
- (c) That the public health, safety, morals, and general welfare of the inhabitants of Sussex County may be adversely affected;
- (d) That adequate off-street parking facilities may not be provided;
- (e) That the necessary safeguards may not be provided for the protection of surrounding property, persons and neighborhood values; and
- (f) That the additional standards of Ordinance 1, Article 10, Section 1, et seq. may not be complied with,

NOW, THEREFORE,

BE IT RESOLVED that the application of Martin Schmidt for a Conditional Use of land in an AR-1 Agricultural Residential District

for a Flea Market to be located in Broadkill Hundred, Sussex County, be and the same is hereby denied; and

BE IT FURTHER RESOLVED that the description of the land which is the subject of this application is more particularly described as follows:

ALL that certain tract, piece, or parcel of land lying and being situated in Broadkill Hundred, Sussex County, Delaware, and lying on the easterly side of Route 1 and bounded as follows:

BEGINNING at a point on the easterly side of Route 1, 395 feet north of Route 258 at a corner for this subject land and lands of Anthony Maiale; thence north 42° 00' west 200 feet along the easterly side of Route 1 to a point; thence north 48° 00' east 218 feet to a point; thence south 42° 00' east 200 feet to a point; thence south 48° 00' west 218 feet to the point and place of beginning, containing within the above described metes and bounds one acre, more or less.
