

RESOLUTION NO. R 034 77

WHEREAS, over fifty (50) eligible voters did sign a petition for Sussex County Council to submit the question of organizing a Sanitary Sewer District to a referendum for the North Shores area, a copy of the petition form being attached hereto as Exhibit 1; and

WHEREAS, the proposed boundaries of the District described in the petition are the North Shores area to include all lands in Lewes-Rehoboth Hundred, bounded on the north by lands of the State of Delaware; on the east by the Atlantic Ocean; on the south by the Town of Henlopen Acres; and on the west by the Lewes and Rehoboth Canal, excepting for properties known as "Villas West", "21 Ocean Drive", "North Shores Bath and Tennis Club", and "Ocean Front Villas", a map of the District being attached hereto as Exhibit 2; and

WHEREAS, under the provisions of Delaware Code 9, Section 6504, Sussex County Council did advertise a public hearing in the Morning News, Evening Journal, and Delaware State News on August 18, 1977 and August 25, 1977; and Donald L. Schwartz, Chief of Planning for the Sussex County Engineer's Office, did post notices in six (6) of the most public places within the proposed District on August 18, 1977, a list of these locations being attached hereto as Exhibit 3; and

WHEREAS, under the provisions of Delaware Code 9, Section 6504 Sussex County Council did hold a public hearing on the question of the proposed boundaries of the North Shores Sanitary Sewer District on September 1, 1977 at 7:00 P. M. at the City of Rehoboth Beach Municipal Building; and

WHEREAS, the Sussex County Engineer did review the testimony presented at the Public Hearing by all interested persons, officials, residents, voters, taxpayers, property owners, or other persons or corporations in any way affected by the petition, and recommends to the Sussex County Council that the establishment of the North Shores Sanitary Sewer District is in the public interest and that the boundaries are to be those set forth in the petition,

NOW, THEREFORE,

BE IT RESOLVED that the County Council of Sussex County, Delaware hereby establishes the boundaries of the proposed North Shores Area Sanitary Sewer District as those set forth in the aforementioned District under the provisions of Delaware Code 9, Section 6505; and

BE IT FURTHER RESOLVED that Sussex County Council hereby determines that a Sanitary Sewer District in the North Shores Area is in the public interest and that the boundaries of the District are those set forth in the petition attached hereto as Exhibit 1 and described above.
