A RESOLUTION TO EXTEND THE BOUNDARY OF THE DAGSBORO-FRANKFORD SANITARY SEWER DISTRICT (DFSSD) TO ENCOMPASS A PORTION OF PRINCE GEORGE'S ACRES SUBDIVISION, LYING CONTIGUOUS TO THE DFSSD, SITUATE EAST OF THE TOWN OF DAGSBORO AND BEING IN DAGSBORO HUNDRED, SUSSEX COUNTY, DELAWARE

WHEREAS, Sussex County has established the Dagsboro-Frankford Sanitary Sewer District; and

WHEREAS, in the best interests of the present district, and to enhance the general health and welfare of that portion of Sussex County east of the Town of Dagsboro, which includes a portion of Prince George's Acres subdivision, which is contiguous to the DFSSD, the inclusion of this property will be beneficial; and

WHEREAS, in accordance with 9 <u>Del.C.</u>, Section 6502 (a), the Sussex County Council may, upon request of the County Engineer, revise the boundary of an established sewer district when 50 or more houses have been connected by posting a public notice in four public places in the district describing the new or revised boundary; and

WHEREAS, the Sussex County Council has caused to be posted a public notice in at least four public places in the district, as verified by the affidavits of Chris Calio, a copy of which affidavits and public notice is attached hereto and made a part hereof; and

WHEREAS, in accordance with 9 <u>Del.C.</u>, Section 6502 (b), the Sussex County Council shall, within thirty days after posting the public notices pass a formal resolution establishing the new boundary of the district;

NOW, THEREFORE,

BE IT RESOLVED the Sussex County Council hereby revises the boundary of the Dagsboro-Frankford Sanitary Sewer District to encompass a portion of the Prince George's Acres subdivision, as follows:

BEGINNING at a point, where the southerly right-of-way (ROW) of County Road 382 intersects the boundary of the DFSSD; thence proceeding from said point of beginning and by and with said ROW in an easterly direction 704 feet more or less to the northeasternmost property corner of Lot 102, Section A of lands now or formerly (N/F) of Eric W. and Jan E. Bomhardt; thence proceeding with said lands in a southerly direction 120 feet to the southeastern property corner of lands N/F of Eric W. and Jan E. Bomhardt; thence proceeding in an imaginary straight line in a southerly direction 120 feet more or less across Blackfoot Town Street to the southeastern property corner of lands N/F of Ronald L. and Tempe B. Steen, thence proceeding with said lands in a westerly direction 125 feet more or less to the northeastern property corner of lands N/F of Dolores C. Robinson and Maria A. Robinson; thence proceeding with said lands in a southerly, westerly, and northerly direction, respectively, to the southwestern property corner of Lot 1, Block D, land N/F of Dolores C. Robinson and Maria A. Robinson; thence proceeding in a westerly direction along an imaginary straight line across King George III Street to the southeastern property corner of lands N/F of Steven C. Hitchens and Maria A. Robinson; thence proceeding with said lands in a westerly direction to the southwestern property corner of lands N/F of Steven C. Hitchens and Maria A. Robinson; thence proceeding in a westerly direction along an imaginary straight line across Queen Ann Street to a point being the northeastern property corner of lands N/F of Frederick N. Mandley and Mary L. Jenkins; thence proceeding with said lands in a southerly and westerly direction, respectively, to the eastern property line of lands N/F of Casper G. and Helen D. Voithofer; thence proceeding with said lands in a southerly and westerly direction, respectively, to a point where it meets the DFSSD boundary; thence by and with said boundary in a northerly direction to the point of BEGINNING.

BE IT FURTHER RESOLVED that the Sussex County Council directs the County Engineer and the Attorney for the County Council to

procure the necessary lands and right-of-way by purchase, agreement, or condemnation in accordance with the existing statutes;

BE IT FURTHER RESOLVED that the County Engineer is hereby directed to prepare maps, plans, specifications, and estimates, elect contracts for and supervise the construction and maintenance of, or enlarging and remodeling of, any and all structures required to provide for the safe disposal of sewage in the sanitary sewer district, as amended.
