A RESOLUTION TO GRANT A CONDITIONAL USE OF LAND IN AN AR-1 AGRICULTURAL RESIDENTIAL DISTRICT FOR A POULTRY HOUSE ON LESS THAN 5.0 ACRES TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN BALTIMORE HUNDRED, SUSSEX COUNTY, CONTAINING 2.798 ACRES MORE OR LESS

WHEREAS, on the 7th day of February, A. D. 1984 an application for a Conditional Use of land in an AR-1 Agricultural Residential District for a poultry house on less than 5.0 acres, denominated C/U #787, was filed on behalf of Jack Hickman; and

WHEREAS, on the 22nd day of March , A. D. 1984 a public hearing, after notice, was held before the Planning and Zoning Commission of Sussex County and said Commission recommended that C/U #787 be approved; and

WHEREAS, on the 10th day of April , A. D. 1984 a public hearing, after notice, was held before the County Council of Sussex County on C/U #787 and having heard and considered the public comments made at such hearing and the County Council having found as follows:

(a) That the Conditional Use applied for is for the general convenience and welfare of the inhabitants of Sussex County;

(b) That the location is appropriate for the ConditionalUse applied for and not in conflict with the Comprehensive Plan;

(c) That the public health, safety, morals and general welfare of the inhabitants of Sussex County will not be adversely affected;

(d) That adequate off-street parking facilities willbe provided;

(e) That the necessary safeguards will be provided for the protection of surrounding property, persons and neighborhood values; and

(f) That the additional standards of Ordinance 97, Article 10, Section 1 et seq. will be complied with,

NOW, THEREFORE,

BE IT RESOLVED that the application of Jack Hickman for a Conditional Use of land in an AR-1 Agricultural Residential District for a poultry house on less than 5.0 acres to be located in Baltimore Hundred, Sussex County, be and the same is hereby granted; and

BE IT FURTHER RESOLVED that the description of the land which is the subject of this application is more particularly described as follows:

ALL that certain tract, piece or parcel of land lying and being in Baltimore Hundred, Sussex County, Delaware, and lying on the northeast side of Route 382 and being more particularly described as lands of Jack D. Hickman and Barbara J. Hickman in Deed Book 717 at page 366 in the office of Recorder of Deeds in and for Sussex County. Said parcel containing 2.798 acres more or less; and

BE IT FURTHER RESOLVED that this Conditional Use is granted subject to compliance with Ordinance No. 97, the Comprehensive Zoning Ordinance of Sussex County, as amended.
