

RESOLUTION NO. R 043 77

WHEREAS, Sussex County has constructed sewer lines on Fifth Street, between Delaware Route 1 and the Atlantic Ocean, in the Bethany Beach Sewer District; and

WHEREAS, the sewer lines on Fifth Street, Delaware Route 1 and the Atlantic Ocean in the Bethany Beach Sewer District, have twelve laterals extending to the north side of said Fifth Street which could allow the nine parcels on the north side of Fifth Street to connect up to the Bethany Beach Sewer District without any additional costs being incurred by the Bethany Beach Sewer District; and

WHEREAS, the nine parcels fronting on the north side of Fifth Street between Delaware Route 1 and the Atlantic Ocean are now located outside of the boundaries of the Bethany Beach Sewer District; and

WHEREAS, any additional connections to the existing Bethany Beach Sewer lines will serve to reduce the costs of Sewage Collection and Treatment to the residents in the Bethany Beach Sewer District; and

WHEREAS, in accordance with Delaware Code 9, Section 6502 (a), the Sussex County Council may, upon request of the County Engineer, revise the boundaries of an established district by posting a public notice in four public places within the district; and

WHEREAS, the Sussex County Council has posted a public notice in four places within the Bethany Beach Sewer District on October 5, 1977; and

WHEREAS, in accordance with Delaware Code 9, Section 6502 (b), the Sussex County Council shall, within thirty (30) days after posting of the public notices, pass a formal resolution establishing the new boundaries of the district,

NOW, THEREFORE,

BE IT RESOLVED that the Sussex County Council has revised the boundaries of the Bethany Beach Sewer District to include nine

parcels fronting on the north side of Fifth Street, between Delaware Route 1 and the Atlantic Ocean, for which lateral connections have already been provided. The revised boundaries of the Bethany Beach Sewer District which include these nine parcels designated as parcel numbers 27, 28, 29, 30, 31, 32, 162, 152 and 151 are shown on the attached drawing; and

BE IT FURTHER RESOLVED that the Sussex County Council directs the County Engineer and the Attorney for County Council to procure the necessary land and rights-of-way by purchase, agreement, or condemnation in accordance with existing statutes and authorizes the County Engineer to prepare maps, plans, specifications, and estimates, let contracts for and supervise the construction and maintenance of, or enlarging and remodeling of, any or all structures required to provide for the safe disposal of the sewage in the Sanitary District.
