

RESOLUTION NO. R 068 83

A RESOLUTION TO GRANT A CONDITIONAL USE OF LAND IN A UR URBAN RESIDENTIAL DISTRICT FOR AN ADDITION TO EXISTING FIRE HALL TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN CEDAR CREEK HUNDRED, SUSSEX COUNTY, CONTAINING 28,800 SQUARE FEET MORE OR LESS

WHEREAS, on the 1st day of September, A. D. 1983 an application for a Conditional Use of land in a UR Urban Residential District for an addition to an existing fire hall, denominated C/U #761, was filed on behalf of Ellendale Fire Co.; and

WHEREAS, on the 13th day of October, A. D. 1983 a public hearing, after notice, was held before the Planning and Zoning Commission of Sussex County and said Commission recommended that C/U #761 be approved; and

WHEREAS, on the 1st day of November, A. D. 1983 a public hearing, after notice, was held before the County Council of Sussex County on C/U #761 and having heard and considered the public comments made at such hearing and the County Council having found as follows:

(a) That the Conditional Use applied for is for the general convenience and welfare of the inhabitants of Sussex County;

(b) That the location is appropriate for the Conditional Use applied for and not in conflict with the Comprehensive Plan;

(c) That the public health, safety, morals and general welfare of the inhabitants of Sussex County will not be adversely affected;

(d) That adequate off-street parking facilities will be provided;

(e) That the necessary safeguards will be provided for the protection of surrounding property, persons and neighborhood values; and

(f) That the additional standards of Ordinance 97, Article 10, Section 1 et seq. will be complied with,

NOW, THEREFORE,

BE IT RESOLVED that the application of Ellendale Fire Co. for a Conditional Use of land in a UR Urban Residential District for an addition to an existing fire hall to be located in Cedar Creek Hundred, Sussex County, be and the same is hereby granted; and

BE IT FURTHER RESOLVED that the description of the land which is the subject of this application is more particularly described as follows:

ALL that certain tract, piece or parcel of land lying and being in Cedar Creek Hundred, Sussex County, Delaware, and lying on the north side of Route 16 (Main Street) and west side of Prettyman Avenue and being more specifically lots 31, 32 and 66 of the subdivision of the Town of Ellendale as recorded in Deed Book 156, page 600. Said lots containing 28,800 square feet more or less; and

BE IT FURTHER RESOLVED that this Conditional Use is granted subject to compliance with Ordinance No. 97, the Comprehensive Zoning Ordinance of Sussex County, as amended.
