ENDORISING PROJECTS TO BE SUBMITTED TO THE STATE OF DELAWARE, DEPARTMENT OF COMMUNITY AFFAIRS, DIVISION OF HOUSING FOR FUNDING FROM THE U. S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND AUTHORIZING JOSEPH T. CONAWAY, COUNTY ADMINISTRATOR, TO SUBMIT APPLICATIONS

WHEREAS, the Sussex County Council resolves to apply for Community Development funds from the State of Delaware Division of Housing in accordance with appropriate regulations governing Community Development Block Grants, State of Delaware Program for Block Grants as contained in (Sections 570.488-499 24 CFR U. S. Department of Housing and Urban Development); and

WHEREAS, Sussex County has met the application requirements of (Section 5 Delaware Community Development Block Grant Program Policies and Procedures) Citizen Participation requirements; and

WHEREAS, Sussex County Council possesses the legal authority to apply for such grants; and

WHEREAS, Sussex County is eligible to submit applications for such grants through the State of Delaware Department of Housing as stated in the policies and procedures manual dated August 24, 1984 of the Delaware Community Development Block Grant Program in the earmarked amount of \$250,000 each grant,

BE IT RESOLVED by the Sussex County Council that after holding public reviews and a public hearing on projects to be included in these applications to the State of Delaware Division of Housing for Community Development funds, they endorse the following projects:

APPLICATION No. 2 (unincorporated) \$250,000

Project 85-U1 \$120,000 - Housing Rehabilitation - Milton CCD

Project 85-U2 \$100,000 - Housing Rehabilitation - Seaford CCD

Project 85-U3 \$ 30,000 - Community Building Improvements
- Slaughter Neck
