RESOLUTION NO. R 074 81

A RESOLUTION TO GRANT A CONDITIONAL USE OF LAND IN AN AR-1 AGRICUL-TURAL RESIDENTIAL DISTRICT FOR A SEAFOOD RETAIL STORE TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN INDIAN RIVER HUNDRED, SUSSEX COUNTY, CONTAINING 11,250 SQUARE FEET, MORE OR LESS

WHEREAS, on the 7th day of October, A. D. 1981, an application for a Conditional Use of land in an AR-1 Agricultural Residential District for a Seafood Retail Store, denominated C/U #656, was filed on behalf of Isaac and Geneva Greene; and

WHEREAS, on the 12th day of November, A. D. 1981, a public hearing, after notice, was held before the Planning and Zoning Commission of Sussex County and said Commission recommended that C/U #656 be approved; and

WHEREAS, on the 1st day of December, A. D. 1981, a public hearing, after notice, was held before the County Councilof Sussex County on C/U #656 and, having heard and considered the public comments made at such hearing and the County Council having found as follows:

- (a) That the Conditional Use applied for is for the general convenience and welfare of the inhabitants of Sussex County;
- (b) That the location is appropriate for the Conditional Use applied for and not in conflict with the Comprehensive Plan;
- (c) That the public health, safety, morals and general welfare of the inhabitants of Sussex County will not be adversely affected;
- (d) That adequate off-street parking facilities will be provided;
- (e) That the necessary safeguards will be provided for the protection of surrounding property, persons and neighborhood values; and
- (f) That the additional standards of Ordinance 1, Article 10, Section 1, et seq., will be complied with,

NOW, THEREFORE,

BE IT RESOLVED that the application of Isaac and Geneva Greene for a Conditional Use of land in an AR-1 Agricultural Residential District for a Seafood Retail Store to be located in the Indian River Hundred, Sussex County, be and the same is hereby granted;

BE IT FURTHER RESOLVED that the description of the land which is the subject of this application is more particularly described as follows:

ALL that certain tract, piece or parcel of land lying and being situate in the Indian River Hundred, Sussex County, Delaware, and lying on the west side of Route 24 and being more particularly described as lot 12 of a plat of lots of Elisha A. Steele as recorded in Plat Book 1, page 159 and having a frontage on Route 24 of 75 feet and containing 11,250 square feet;

BE IT FURTHER RESOLVED that this Conditional Use is granted subject to compliance with Ordinance No. 1, the Comprehensive Zoning Ordinance of Sussex County, as amended.
