RESOLUTION NO. R 077 86

WHEREAS, Sussex County has established the Bethany Beach Sanitary Sewer District; and

WHEREAS, the Sanitary Sewer District as established includes only the corporate limits of the Town of Bethany Beach and those private properties north of Bethany Beach along State of Delaware Route 1 south of the Indian River Inlet; and

WHEREAS, in the best interests of the present district, and to enhance the general health and welfare of that portion of Sussex County to be referred to as Section III of Ocean Way Estates Subdivision; and

WHEREAS, in accordance with Title 9, <u>Delaware Code</u>, Section 6502 (a), the Sussex County Council may, upon request of the County Engineer, revise the boundaries of an established sewer district when 50 or more houses have been connected by posting a public notice in four public places in the district describing the new or revised boundaries; and

WHEREAS, the Sussex County Council has caused to be posted a public notice in at least four public places in the district as verified by the affidavit of William A. Siegmund, a copy of which affidavit and public notice is attached hereto and made a part hereof; and

WHEREAS, in accordance with Title 9, <u>Delaware Code</u>, Section 6502 (b) the Sussex County Council shall, within thirty (30) days after posting the public notices pass a formal resolution establishing the new boundaries of the district,

NOW, THEREFORE,

BE IT RESOLVED the Sussex County Council hereby revises the boundary of the Bethany Beach Sanitary Sewer District to encompass the private lands referred to as Section III of Ocean Way Estates Subdivision as follows:

ALL that certain piece, parcel or lot of land lying and being situate in Baltimore Hundred, Sussex County, State of Delaware being more fully described as follows, to wit:

BE IT FURTHER RESOLVED that the Sussex County Council directs the County Engineer and the Attorney for the County Council to procure the necessary lands and right-of-way by purchase, agreement or condemnation in accordance with the existing statutes; and

BE IT FURTHER RESOLVED that the County Engineer is hereby directed to prepare maps, plans, specifications and estimates, elect contracts for and supervise the construction and maintenance of, or enlarging and remodeling of, any structures required to provide for the safe disposal of sewage in the sanitary sewer district, as amended.


